

## N67/N85 Inner Relief Road Ennistymon (Blake's Corner) CPO

### Engineering Brief of Evidence

9<sup>th</sup> June 2021





## 1.0 Introduction

My name is Eoin Ó Catháin. I am a Chartered Engineer and a Registered Consulting Engineer and a Technical Director of Roughan & O'Donovan Consulting Engineers [ROD]. I hold Level 8 and Level 9 qualifications in Civil, Structural and Environmental Engineering from UCD and Trinity College. I have been the Project Manager for the Blake's Corner project since 2014. I am supported here today by my colleagues Séamus MacGearailt, BE, Chartered Engineer and Fellow of the Institution of Engineers and the Association of Consulting Engineers, and Deirdre Neff, BE, MSc, Chartered Engineer.

## 2.0 The Need for the Scheme

Anyone familiar with Blake's Corner in Ennistymon will appreciate the problems that exist there. It connects two national secondary roads - the N85 from Ennis to Ennistymon and the N67 from Galway to Kilrush. As national secondary routes, these are the designated routes for heavy commercial vehicles and coaches. Neither vehicle type can traverse the junction without difficulty. Since this is the principal access route to Lahinch and north and west Clare, including Ireland's second largest tourist attraction at the Cliffs of Moher, it causes considerable difficulty for traffic. Over 1100 vehicles an hour traverse the junction during busy periods.

There are no safe continuous pedestrian facilities at the junction, which poses a hazard to these road users, including in particular the many schoolchildren walking between their houses



on the east side of the river and the schools on the west side of the river. As such, there is a clear and strong community need for improvements to be carried out at this location.

My company, ROD, in joint-venture with AECOM, was engaged by Clare County Council in 2014 to assess options for overcoming the congestion and safety issues at Blake's Corner and to secure statutory approvals for a preferred scheme.

### 3.0 Alternatives Considered

Following an extensive Options Assessment and consultation process, a preferred scheme was identified involving the construction of a new bridge upstream of the existing bridge, and the realignment of the N67 across the new bridge. In particular, this option was favoured over an earlier scheme proposal which would have required the removal and reconstruction of the Blake's and Linnane's listed structures immediately east of the existing Michael Conway Bridge. This earlier proposal would have involved the construction of a roundabout between the N67 and the N85 at the eastern end of the Michael Conway Bridge, facilitated by reconstructing the buildings at a setback. It would also have required the addition of a boardwalk to the Michael Conway Bridge to provide pedestrian connectivity across the river. The scheme would have involved potential heritage and ecological impacts and An Bord Pleanála previously determined that a full Environmental Impact Assessment would be necessary for that proposal.

Other local alternative scheme options were investigated, including one-way systems, installation of traffic signals and variations on the planned Inner Relief Road. It became clear through the traffic modelling and appraisal process that none would address the community needs at this location except for the preferred option (i.e. the proposed project). In particular,

the traffic signal solutions don't work at this location, since they only allow one vehicle at a time into the junction (as a result of the two other approaches having to be shown a red signal while one approach arm is shown green). This reduces the capacity below the existing situation, which is further exacerbated by the required junction clearance time between signal stages.

It is noted that, as well as the proposed project, the Clare County Development Plan includes a proposal for a Relief Road (Outer Road) around the southern side of Ennistymon. It has been suggested that the provision of this Outer Relief Road would obviate the need for works in the vicinity of Blake's Corner, and that it would be a more appropriate solution. Our studies have demonstrated that this is not the case, because:

- i. It would not address the issues at Blake's Corner in terms of geometry or pedestrian movements. It is noted that coaches need to stop in Ennistymon and these would not therefore use the Outer Relief Road;
- ii. Similarly, larger vehicles must access Ennistymon to make deliveries and this requirement will remain with or without the Outer Relief Road;
- iii. The Outer Relief Road would most likely be located to the south of the town centre, as indicated on the Development Plan, meaning N67 traffic between the north and the west will be likely to continue to use the considerably shorter route through the town centre; and
- iv. The Outer Relief Road will facilitate the expansion of Ennistymon to the south and the development of zoned lands. There is currently no demand for the development of these lands.

This option was considered as part of the Options Assessment process for the Blake's Corner project but was not favoured for the reasons above. It is envisaged that it may be delivered in future to facilitate the continued expansion and consolidation of the Ennistymon Urban Development Area, and will complement the works proposed in the current project.

#### **4.0 The Proposed Scheme**

The approved scheme under discussion today involves the realignment of the N67 off the Michael Conway Bridge and over a new bridge through the current Clare County Council car park next to Unglert's Bakery approximately 80m upstream of the existing bridge. The new bridge will have a clear span over the river to avoid any risk to the river. The geometric constraint at Blake's Corner will be removed, allowing the smooth flow of traffic and multiple concurrent vehicle manoeuvres at a new junction 80m upstream. In addition, the N85 New [Ennis] Road approaching the junction will be widened to allow two trucks to pass outside Linnane's Funeral Home. Existing disjointed and discontinuous pedestrian facilities will be joined up and improved to provide continuous pedestrian connectivity between the east and west sides of the river and to the new bridge.

The provision of the new N67 bridge to the south of the existing Michael Conway Bridge will allow the closure of the existing bridge to regular vehicular traffic. This in turn will allow the creation of a pedestrian priority realm and an extension of the town centre across the bridge. A new plaza will be created at the west side of the bridge in the space between the existing bridge and the new N67 Lahinch Road alignment. The removal of vehicular traffic from the old bridge will improve provision for pedestrians and cyclists, and provision has been included to connect the Lahinch to Ennistymon cycleway to the centre of Ennistymon over the old bridge.

In overcoming the congestion at Blake's Corner, and providing safe pedestrian (and cycle) connectivity between the east and west sides of the town, the project will have addressed the clear community needs that exist at present. It will deliver an immediate and lasting improvement in capacity and road safety, and will improve the attractiveness of Ennistymon as a destination in itself.

The scheme has a benefits to costs ratio of 5.98 and has scored positively under all headings of the Capital Appraisal Framework, as indicated in Table 1 below.

## 5.0 The Part VIII Process

Following completion of the Options Assessment process, Clare County Council wrote to An Bord Pleanála in March 2016 seeking An Bord Pleanála's determination on whether an Environmental Impact Statement or a Natura Impact Statement was required for the currently proposed scheme. An Bord Pleanála issued its determinations on the 5<sup>th</sup> October 2016 that neither an Environmental Impact Statement nor a Natura Impact Statement was required.

Following An Bord Pleanála's direction, a Part VIII process was initiated by Clare County Council, and the proposed development was considered by the members of Clare County Council in accordance with Section 179 of the Planning and Development Act 2000 (as amended) and was approved by them at the meeting of the members of the Council held on the 9<sup>th</sup> of April 2018. The accompanying Planning Brief of Evidence by Mr. Gareth Ruane sets



out how the proposed development is consistent with national, regional and local planning policy.

## **6.0 The Compulsory Purchase Order**

Following the Part VIII approval, ROD-AECOM progressed the design development and Compulsory Purchase Order [CPO] stages of the Blake's Corner project which has resulted in the submission of the CPO documentation to An Bord Pleanála in June 2020, and which is the subject of this hearing. The design development took account of the various conditions appended to the Part VIII approval and I confirm that these conditions can be addressed within the lands that are subject to this CPO.

The junction of the new bridge with the N85 will be constructed through the existing Clare County Council car park next to Unglert's Bakery, and the existing car park will be relocated to the south. This will require the demolition of one property on the N85 Ennis Road, which has already been acquired by Clare County Council. The scheme also proposes widening the N85 approach to the junction to facilitate two coaches passing, which requires the acquisition of a strip of land from two further properties – Linnane's Funeral Home and an adjoining house.

The realignment of the N67 on the west side of the river requires the acquisition and demolition of a number of structures. These are:



- 1) The Department of Employment Affairs Branch Office, which includes a private dwelling above; and
- 2) The florist shop and private dwelling on the corner of Bogbere Street and the N67 Lahinch Road.

In addition, a strip of land is required from the Church of Our Lady and Saint Michael.

Finally, all of the public road is being acquired throughout the extents of the scheme and rights of way that will become redundant on completion of the scheme are being extinguished. Therefore, the entirety of the land necessary to implement the approved scheme and address the community need that exists is included within this Compulsory Purchase Order.

## **7.0 Responses to Individual Submissions**

13 submissions have been made to An Bord Pleanála in relation to the Compulsory Purchase Order being applied for, and I will endeavour to concisely address each of these in turn below.

- 1) The submission in relation to Plots 105b, 106b and 190b from Ms. Anna Christofides and Ms. Helen Barry:
  - a. Raised concerns about the potential impacts on parking outside their premises. It is not intended to amend the parking arrangements at this location. The roadway is and will remain under the control of Clare County Council.
  - b. Raised concerns about impact on parking at the church. The works require only a minor encroachment on the undelineated church car park area and will not result in a reduction in available car parking at the church.
  - c. Raised concerns about safety crossing the Lahinch Road – especially for school children. Clare County Council separately proposes to install a pedestrian crossing across the Lahinch Road but this does not form part of the current project. I do not expect that the scheme herein will in any way reduce road safety at this location and I expect that the provision, through the scheme, of significant connectivity improvements for pedestrians between the east and west parts of the town will lead to substantial safety improvements for these vulnerable road users.
  - d. Raised concerns in relation to the Old Mill Laneway. The current access arrangements to the laneway in question do not form part of the scope of the project and will be unaffected by the project.
- 2) The submission in relation to 14 New Road Ennistymon from Ms. Catherine Doyle Hassett in relation to Plot 163.b raised concerns in relation to parking provision outside the premises, and in particular the need for accessible parking. The roadway is and will remain under the control of Clare County Council. The details of the permanent on-street parking measures will be confirmed at detailed design stage and subject to the

Stage 2 Road Safety Audit. Clare County Council will engage with local residents along the N85 in terms of managing on-street parking.

- 3) The submission in relation to the Department of Employment Affairs Branch Office from Ms. Monica Carroll, Ms. Frances Ryan and Mr. Kevin McNamara:
  - a. Raised concerns about the impact of the proposal on the business and its employees and advocated alternative solutions to the issues at Blake's Corner. These matters have already been considered as part of the Part VIII process, and approval has been secured in accordance with Part XI of the Planning and Development Act, 2000 as amended and Part VIII of the Planning and Development Regulations as amended for the scheme underlying the CPO herein. The proposed scheme has been found to be considerably superior to any alternative, including those requiring the demolition of the Blake's and Linnane's premises.
- 4) The submission from Ms. Elizabeth McNamara in relation to Plots 114a3, 114a4, 114a5, 120.a1, 120.a2 and 120.a3 – the Department of Employment Affairs Branch Office:
  - a. Raised concerns about the impact of the proposal on the business and its employees and advocated alternative solutions to the issues at Blake's Corner. These matters have already been considered as part of the Part VIII process, and approval has been secured in accordance with Part XI of the Planning and Development Act, 2000 as amended and Part VIII of the Planning and Development Regulations as amended for the scheme underlying the CPO herein.
  - b. Expressed concerns about the availability of alternative suitable accommodation within Ennistymon. A review by a local Estate Agent was commissioned in March 2021 and updated in May 2021, and it was noted that there is a selection of suitable premises for lease or purchase within Ennistymon Town Centre. A claim for compensation may well be made in this regard which is a separate process to the present.
- 5) The submission from Ms. Erin McClure of 21 New Road, Ennistymon in relation to Plot 170b:
  - a. Raised concerns about access during the construction stage. Construction will be managed to minimise the impacts on local residents and businesses insofar as practicable. The substantially offline nature of the proposed scheme is such that most of the works can be constructed with minimal impact on existing national road traffic. The scheme, when completed, will deliver significantly improved traffic conditions for Ennistymon, which will benefit the residents of the town in addition to through traffic.
  - b. Raised queries about the intended use of 20 New Road, which the submission states has been acquired by Clare County Council. This is outside the scope of the project.

- c. Raised concerns that the proposed scheme would simply move the problem from Blake's Corner to the proposed new junction. It is noted that the proposed new junction is considerably larger than Blake's Corner, and larger vehicles will not therefore continue to experience the delays that occur at Blake's Corner. Visibility will also be significantly improved compared with the existing situation at Blake's Corner. Only one vehicle turning movement at a time can be made at Blake's Corner, whereas multiple concurrent movements will be feasible at the new junction. Traffic modelling has indicated that the proposed scheme will have considerably greater capacity than the existing junction. This is in addition to the considerable benefits for pedestrians and vulnerable road users that will accrue from the proposed works.
  - d. Raised concerns about the operational impacts on their premises, including noise and lighting. The environmental impacts of the scheme, both positive and negative, were considered as part of the Part VIII process, and approval has been secured in accordance with Part XI of the Planning and Development Act, 2000 as amended and Part VIII of the Planning and Development Regulations as amended for the scheme underlying the CPO herein.
- 6) The submission from Mr. Frank McDonald:
- a. Broadly welcomed the proposal and suggested additional details in relation to the treatment of the Michael Conway Bridge. The detailed design of the scheme will ensure adequate provisions for pedestrians and cyclists in line with the provisions of the Design Manual for Urban Roads and Streets. In this instance, a shared facility may be considered appropriate to ensure the primacy of pedestrians, given the relatively low anticipated number of cyclists. It is noted that the scheme will provide a very significant urban realm enhancement for Ennistymon Town Centre, and will facilitate the extension of the town centre to the west side of the River Inagh. On foot of this, Clare County Council is separately progressing a complementary urban realm enhancement scheme for the town centre itself.
- 7) The submission in relation to Plots 115a and 115b from Ivor Fitzpatrick Solicitors on behalf of Mr. John Clancy and Mrs. Sheena Clancy:
- a. Raised concerns about the impact of the scheme proposal on their Clients. The environmental impacts of the scheme, both positive and negative, were considered as part of the Part VIII process, and approval has been secured in accordance with Part XI of the Planning and Development Act, 2000 as amended and Part VIII of the Planning and Development Regulations as amended for the scheme underlying the CPO herein.
  - b. Issues concerning form of CPO. The lands and premises proposed to be acquired have been accurately described and the landowners are in no doubt as to what is being acquired. The acquisition of this property is required for the carrying out of the scheme in question, in respect of which the landowners had an opportunity to make submissions and observations, and the acquisition in question is

proportionate and is required in the common good and is in accordance with law and with the Constitution. It is not correct for the landowners' solicitors to suggest that a notice to treat can be served once the CPO is confirmed, and instead, if, the Board having considered the submissions and observations, the CPO herein is confirmed, same is required to be followed by the publication of notice in relation to same, and the CPO becomes operative three weeks after such publication.

- c. Furthermore, if the CPO is confirmed, the Council would intend to move with all due expedition in relation to same, and the landowners can apply for the appointment of an arbitrator should there not be agreement between the parties as to compensation within such time as the landowners deem fit. Furthermore, there has been no position in living memory whereby compensation had to be agreed prior to the Council being in a position to enter the lands. The Council herein has not delayed or prevaricated in the determination of compensation as alleged or at all. The Council furthermore is keen to advance this scheme with all due expedition and is subject to quite tight timelines thereafter the service of a notice to treat if the CPO is confirmed as contained in Section 217 of the Planning and Development Act.
- d. It is furthermore incorrect for the representatives of these parties to suggest that the Council is the sole Authority in respect of the scheme in which the CPO herein is subject to approval by An Bord Pleanála who can reject the CPO or approve same with or without modification. Again, the CPO herein does not deprive these objectors of their constitutional rights and any CPO herein is subject to payment of just compensation in accordance with the statutory scheme applicable to same, and which is subject to independent determination by an arbitrator in default of agreement.
- e. The claims that can be made in due course (and which are subject to an independent process) can include the determination of issues relating to the purchase of a home as well as a business and no breaches of any rights occur by reason of the CPO herein.
- f. The suggestion that the Council and/or the Board have been complicit as alleged herein is extremely regrettable and entirely without foundation and groundless.
- g. In relation to the EIA Directive, no application has been made to disapply the Directive as alleged or at all, and these parties had a full right of participation in the Part XI/Part VIII process previously lawfully carried out and to which no challenge has been brought whether within time or otherwise. Similarly, there is no basis for the implied assertion that the provisions of the Habitats Directive have not been complied with in relation to the scheme underlying the CPO herein, and no challenge asserting any deficiencies in this regard has been brought or upheld and the time for doing so has long since expired.
- h. The CPO herein is appropriate and proportionate, and is necessary for the realisation of the project, as approved by Clare County Council at its meeting of 9<sup>th</sup> April 2018, in accordance with Part XI of the Planning and Development Act,



2000 as amended and Part VIII of the Planning and Development Regulations. It will not be possible to execute the works required to implement the project should the CPO not be confirmed in its entirety.

- i. The Council has at all times herein fully engaged with members of the public and has sought to deal with all queries raised and to provide ongoing engagement with the members of the public and the affected landowners, who it has treated with the utmost respect at all times.
- 8) The submission in relation to Plots 185a1 and 185a2 from Stokes Property on behalf of Messrs John and Michael Linnane:
- a. Raises concern about public safety on the footpath / rollover area. These matters have already been considered as part of the Part VIII process, and approval has been secured in accordance with Part XI of the Planning and Development Act, 2000 as amended and Part VIII of the Planning and Development Regulations as amended for the scheme underlying the CPO herein. In this particular instance, the design has been further developed to separate pedestrians from road traffic and to allow two articulated vehicles to pass each other as required by condition 2(v) of the Part VIII approval. Therefore, the issue raised no longer arises, and there is no risk to pedestrians associated with larger vehicles mounting the footpath area. The current General Arrangement Drawing, which addresses the conditions imposed by the Part VIII approval, is included as Appendix 1 hereto.

- b. Notes that parking for the business's hearse will be tight and that any larger hearse that may be acquired in future may project onto the road. Following earlier submissions from the landowner, Clare County Council discussed a number of alternative options with the landowner in this regard. The landowner did not express a preference to advance any of these alternatives, and therefore the scheme, as proposed, is in accordance with the Part VIII approval and makes provision for the parking of the hearse as it currently does, with a slight rotation and permission to partially park over the adjoining lands, which are owned by Clare

County Council. I am happy that there will be no appreciable diminution of the ability to park and manoeuvre a hearse at this location as a result of the project being constructed. I further believe, the measures proposed – including particularly the extension of the public footpath network - should lead to significant safety improvements during the operation of the funeral home.

- c. Suggests alternatives to the preferred scheme. These matters have already been considered as part of the design development and Part VIII process, and the scheme, as adopted, followed on from the consideration of all relevant matters including potential alternatives, and is considered the most suitable development to address the issues while balancing same against impacts. I have already discussed these alternatives and the reasons why the proposed project is a more appropriate solution to the issues at Blake's Corner above, and this process has been concluded by the Part VIII approval of the project at Clare County Council's meeting of 9<sup>th</sup> April 2018.
- 9) The submission in relation to Plot 167b in relation to 18 New Road, Ennistymon from Mr. Jonathan O'Gorman:
- a. Objects to the removal of parking outside his premises. These matters have already been considered as part of the Part VIII process, and approval has been secured in accordance with Part XI of the Planning and Development Act, 2000 as amended and Part VIII of the Planning and Development Regulations as amended for the scheme underlying the CPO herein. The details of the permanent on-street parking measures will be confirmed at detailed design stage and subject to the Stage 2 Road Safety Audit. The roadway is and will remain under the control of Clare County Council and Clare County Council will liaise with directly affected residents in relation to parking.
  - b. Suggests alternatives to the preferred scheme. These matters have already been considered as part of the Part VIII process. The proposed scheme has been shown to address the traffic capacity issues at Blake's Corner, while traffic modelling of the suggested alternative to install traffic signals concluded that it would not. This has been borne out by live trials on site, the most recent having been undertaken in August 2017, which caused extensive queuing on the approaches when the signalisation was tested on a weekday afternoon.
- 10) The submission in relation to Plot 172b from Ms. Miriam O Doherty:
- a. Raises concerns about the impact of the preferred scheme on her premises. The environmental impacts of the scheme, both positive and negative, were considered as part of the Part VIII process, and approval has been secured in accordance with Part XI of the Planning and Development Act, 2000 as amended and Part VIII of the Planning and Development Regulations as amended for the scheme underlying the CPO herein.

- 11) The submission in relation to Plots 107b, 108b, 109b, 110b, and 111b from Mr. Paddy Clarke, Mr. Michael Lyons, Mr Kevin Dore, Mr. Paddy and Ms. Antoinette Reynolds, and Ms. Bríd Howe:
  - a. Raised concerns about the potential impacts on parking outside their premises. It is not intended to amend the parking arrangements at this location. The roadway is and will remain under the control of Clare County Council.
  - b. Raised concerns in relation to the Old Mill Laneway. The current access arrangements to the laneway in question do not form part of the scope of the project and will be unaffected by the project.
- 12) The submission in relation to Plot 191b from Mr. Patrick Donovan:
  - a. Objects to the preferred scheme and to the acquisition of the lands for the implementation of the preferred scheme. The environmental impacts of the scheme, both positive and negative, were considered as part of the Part VIII process, and approval has been secured in accordance with Part XI of the Planning and Development Act, 2000 as amended and Part VIII of the Planning and Development Regulations as amended for the scheme underlying the CPO herein.
- 13) The submission from Mr. Ross O'Doherty:
  - a. Notes that the submission from Ms. Miriam O Doherty mentioned in 10) above is a joint submission from both Ms. Miriam O Doherty and Mr. Ross O'Doherty. My response thereto is noted above.

## **8.0 Amended First Schedule**

Appendix 2 hereto includes an Amended First Schedule. Additions are noted in red and underlined and deletions are struck through. The amendments are based on additional information received in the intervening period since the present application was submitted to An Bord Pleanála. Specifically, the changes are as follows:

- 1) In relation to Plot reference 119.b, a second address has been noted for Stephen McIlvenna and Tamar Shorten;
- 2) In relation to Plot reference 139.b, Tony Daly of Main Street, Ennistymon and Geraldine Daly of Main Street, Ennistymon have been added as Owners or Reputed Owners in addition to Timothy Towell, also of Main Street, Ennistymon;
- 3) In relation to Plot reference 144.b, the reference to Michael J. O'Loughlin has been amended to Reps of Michael J. O'Loughlin;
- 4) In relation to Plot reference 167.b, the reference to Joseph Morris has been amended to Reps of Joseph Morris, and Maura McBride Morris of No. 18 New Road, Ennistymon has been added as an Owner or Reputed Owner in addition to Maura Morris of No. 18

New Road, Ennistymon and Jonathan O'Gorman, also of No. 18 New Road, Ennistymon;

- 5) In relation to Plot reference 181.b, Michael Connolly of Sallybank, Kilmore, Co. Clare has been added as an Owner or Reputed Owner in addition to Representatives of Austin Kerin, No. 11 Riverview Terrace, Ennistymon and "The Owner", No. 11 Riverview Terrace, Ennistymon; and
- 6) In relation to Plot reference 192.b, a second address has been noted for Harriet Moran-Dodge.

I confirm that notices and the relevant part of the amended First Schedule have been issued to those parties whose schedule entry has been added or amended since the present application was submitted to An Bord Pleanála. These notices were issued last week following execution of the revised Chief Executive's Order by Clare County Council.

## **9.0 Conclusion**

It is of course unavoidable and regrettable that the delivery of public works can impinge on nearby landowners and occupants. However, a preferred scheme has been identified to resolve the longstanding issues at Blake's Corner, and this scheme has been through a rigorous assessment process pursuant to Part XI of the Planning and Development Act, 2000 as amended and Part VIII of the Planning and Development Regulations, 2001 as amended, involving significant public participation and which resulted in approval for the Scheme underlying the CPO herein which has not been challenged and is in full force and effect. Having reviewed the Scheme and the submissions herein, I confirm that the lands identified for acquisition in the Compulsory Purchase Order are sufficient and necessary for the implementation of the scheme approved by Clare County Council at its meeting of the 9<sup>th</sup> April 2018. It is my opinion that the CPO herein is proportionate and meets the common good and community need, and I confirm that those lands identified in the CPO documentation are sufficient and necessary for the approved scheme's construction.

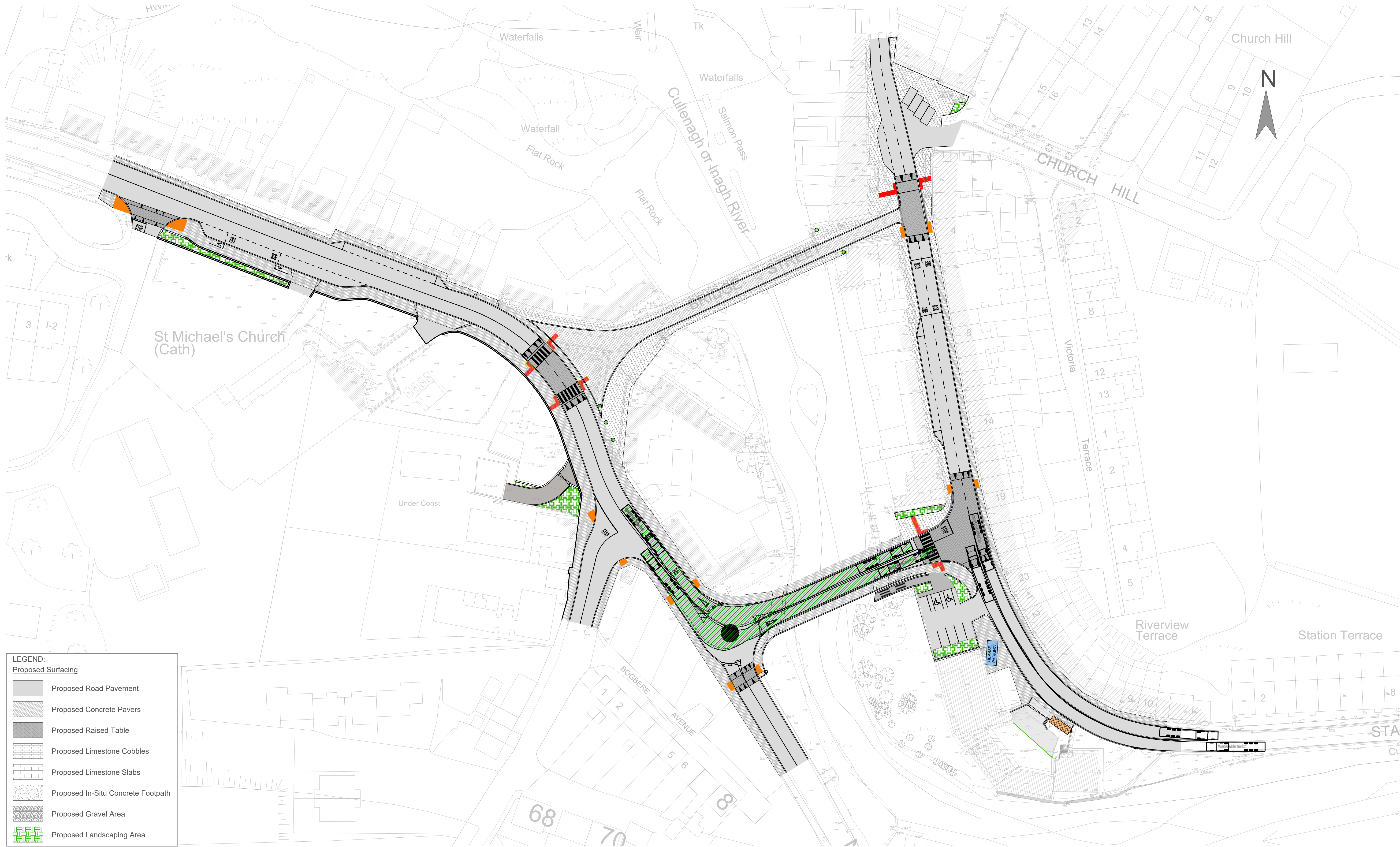
