

# DRAFT SHANNON TOWN CENTRE MASTERPLAN

Clare County Council has prepared a final Draft Shannon Town Centre Masterplan taking account of the feedback received during the initial public consultation. The purpose of the Shannon Town Centre Masterplan is to define the focus, nature, and locations for economic, cultural, community and commercial development in Shannon Town Centre, including the public realm.

Clare County Council wishes to hear your views on the Draft Shannon Town Centre Masterplan and hereby invites community groups, individuals and stakeholders to make submissions and observations in respect of the Draft Masterplan. Children, or groups or associations representing the interests of children, are particularly encouraged to make submissions or observations.

The Draft Shannon Town Centre Masterplan is accompanied by a Strategic Environmental Assessment (SEA) Screening Report which details the likely significant environmental effects of implementing the Draft Masterplan. The Draft Masterplan is also accompanied by a Screening for Appropriate Assessment which considers potential significant effects on the integrity of European Sites.

These reports and the consultation on the Draft Plan are prepared in accordance with the European Communities (Environmental Assessment of Certain Plans and Programmes) Regulations 2004 (SI No. 435 of 2004), (as amended) and European Communities (Birds and Natural Habitats Regulations 2011 (S. I. No. 477 of 2011) (as amended).
