ROAD TRAFFIC (SPECIAL SPEED LIMITS)

(County of Clare) Bye-Laws, 2017

Clare County Council in exercise of the powers conferred on it by Section 46 of the Road Traffic Act, 1961 (No. 24 of 1961) as amended by Sections 4-9 of the Road Traffic Act, 2004 (No. 44 of 2004), Part 19 of the Local Government Act 2001 as amended, hereby make the following Bye-Laws in respect of the area comprising the administrative area of County of Clare:-

Citation.

1. These Bye-Laws may be cited as the Road Traffic (Special Speed Limits) (County of Clare) Bye-Laws 2017.

Commencement.

2. 1st June 2019

Interpretation

3. In these Bye-Laws:

"The Act" means the Road Traffic Act, 2004 (No. 44 of 2004);

"The Principal Act" means the Road Traffic Act, 1961.

"Built-up area speed limit" and "special speed limit" have the meanings respectively assigned to them in part 2 of the "Act".

"Distance" means the distance as measured along the centre line of a road.

"National Road" means a road declared to be a National Road in the Local Government (Roads and Motorways) Act, 1974 (Declaration of National Roads) Order, 1977 (S.I. No. 164 of 1977) and any reference to the number of such road shall be a reference to the number of such road as shown in column 1 of the First Schedule or column 1 of the Second Schedule to the aforementioned order.

"Road" means a public road.

Built-up area speed limit

4. Each of the roads described in the First Schedule herein is hereby declared to be a public road in a built-up area for the purposes of section 5 of the "Act".

Speed Limits

- 5. Sixty kilometres per hour shall be the speed limit for mechanically propelled vehicles on each of the roads specified in the Second Schedule to these Bye-Laws.
- 6. Eighty kilometres per hour shall be the speed limit for mechanically propelled vehicles on each of the roads specified in the Third Schedule to these Bye-Laws.
- 7. One hundred kilometres per hour shall be the speed limit for mechanically propelled vehicles on each of the roads specified in the Fourth Schedule to these Bye-Laws.
- **8.** One hundred and twenty kilometres per hour shall be the speed limit for mechanically propelled vehicles on each of the roads specified in the Fifth Schedule to these Bye-Laws.
- **9.** Sixty kilometres per hour shall be the special speed limit for mechanically propelled vehicles on the road section specified in the Sixth Schedule to these Bye-Laws.
- **10.** Thirty kilometres per hour shall be the speed limit for mechanically propelled vehicles on the road section specified in the Seventh Schedule to these Bye-Laws.
- **11.** The rural speed limit sign shall be the speed limit for mechanically propelled vehicles on the road section specified in the Eight Schedule to these Bye-Laws.

Exempted vehicles

- The following vehicles shall be exempted from the provisions of these Bye-Laws: (a) ambulances,
 - (b) fire brigade vehicles, and
 - (c) vehicles used by members of the Garda Siochana in the performance of their duties as such members.

Revocations

12. The Road Traffic (Special Speed Limits) County of Clare Bye Laws, 2012 are hereby revoked in their entirety.

FIRST SCHEDULE

Roads declared to be public roads in a built up area for the purposes of section 5 of "Act".

(1.) The following road at Ballyea:

The L-8266 through Ballyea Village from a point 10m south of junction with the L-4170 Ennis Road south west for a distance of 280m.

(2.) The following roads at Ballynacally:

All Roads in the area enclosed by a series of straight lines commencing at a point on the Ennis Road (R-473) a distance of 676 metres north of its junction with the Roscliff Road and thence successively to the following points:

- (a) a point on the Roscliff Road (L-6325) a distance of 165 metres south-east of its junction with the Ennis- Killadysert Road;
- (b) a point on the Killadysert Road (R-473) a distance of 40 metres south-west of its junction with the Cloonakilla Road;
- (c) a point on the Cloonakilla Road (L-6334) a distance of 30 metres south-east of its junction with the Killadysert Road;
- (d) a point on the Kilcreest Road (L-2072) a distance of 40 metres west of its junction with the Killadysert Road;

and from the last mentioned point to the commencement point on the Ennis Road.

(3.) The following roads at Ballyvaughan:

(i) Ballyvaughan Village

All Roads in the area enclosed by a series of straight lines commencing at a point on the Fanore Road (R-477) a distance of 705 metres north-west of its junction with the Lisdoonvarna-Galway Road and thence successively to the following points:

- (a) a point on the Pier Road (L-5040) a distance of 280 metres north of its junction with the Fanore Road;
- (b) a point on the Galway Road (N-67) a distance of 136 metres north-east of its junction with the Sheds Road (L5038)
- (c) a point on the Lisdoonvarna Road (N-67) a distance of 300 metres south of its junction with the Fanore Road;
- (d) a point on the School Road (L-5042) a distance of 310 metres south of its junction with the Fanore Road;

and from the last mentioned point to the commencement point on the Fanore Road.

(ii) Loughrask Road

The Loughrask Road (L-5036) for a distance of 345 metres south-east of its junction with the Galway Road.

(4.) The following roads at Barefield:

- (a) L-81226-0 for a distance of 30 metres east from its junction with the R458
- (b) L-8122-0 for a distance of 193 metres east from its junction with the R458
- (c) The M18 Junction 14 Barefield northbound-off / on slip road, for a distance of 31 metres South of the yield line of Barefield North Roundabout
- (d) R-458 from a point at its intersection with the Barefield North Roundabout to a point at its intersection with the R-458 (16 m North East of the junction of the L-4158 and the R-458)
- (e) R-458 for a distance of 33 metres west of the yield line of Barefield North Roundabout to a point 87 m South East of its intersection with the M18 including all circulatory carriageways of said roundabout
- (f) R-458 for a distance of 73 metres East of the yield line of the Barefield South Roundabout
- (g) Ennis Road (R-458) a distance of 203 metres south-west of the yield line of the Barefield South Roundabout to a point 680 North East of its intersection with the Trinaderry Road (L-4158) including all circulatory carriageways of said roundabout
- (h) Trinaderry Road (L-4158) a distance of 668 metres west of its junction with the Ennis Road

(5.) The following roads at Bodyke:

All Roads in the area enclosed by a series of straight lines commencing at a point on the Scarriff Road (R-352) a distance of 228 metres east of its junction with the Broadford Road and thence successively to the following points:

- (a) a point on the Broadford Road (R-465) a distance of <u>233</u> metres south of its junction with the Scarriff Road;
- (b) a point on the Ennis Road (R-352) a distance of 179 metres south-west of its junction with the Clonmoher Road;
- (c) a point on the Clonmoher Road (L-4066) a distance of 420 metres north-west of its junction with the Ennis Road;

and from the last mentioned point to the commencement point on the Scarriff Road

(6.) The following roads at Bridgetown Village:

All Roads in the area enclosed by a series of straight lines commencing at a point on the Broadford Road (R-466) a distance of 110 metres west of its junction with the Ardnataggle Road and thence successively to the following points:

- (a) a point on the Fahy Road (L-7126) a distance of 105 metres north-west of its junction with the Kilcredaun Road;
- (b) a point on the Ballyknavin Road (L-7104) a distance of 53 metres north of its junction with the Kilcredaun Road;
- (c) a point on the Kilcredaun Road (L-3080) a distance of 132 metres north-east of its junction with the Ballyknavin Road;
- (d) a point at the termination of the Riverdale estate road L-7127.
- (e) a point on the O'Briensbridge Road (R-466) a distance of 330 metres south-east of its (western) junction with the Kilcredaun Road;
- (f) a point on the Ardnataggle Road (L-7078) for a distance of 56 metres south-west of its junction with the Broadford / O'Briensbridge Road;

and from the last mentioned point to the commencement point on the Broadford Road.

(7.) The following roads at Broadford:

All Roads in the area enclosed by a series of straight lines commencing at a point on the Scarriff Road (R-465) a distance of 65 metres north-west of its junction with the Violet Hill Road and thence successively to the following points:

- (a) a point on the Violet Hill Road (L-3030) a distance of 46 metres north-west of its junction with the Scarriff Road;
- (b) a point on the Kilbane Road (L-7004) a distance of 125 metres east of its junction with the Scarriff Road;
- (c) a point on the Bridgetown Road (R-466) a distance of 350 metres east of its junction with the Limerick Road;
- (d) a point on the Limerick Road (R-465) a distance of 95 metres south of its junction with the Bridgetown Road;
- (e) a point on the Kilseily Road (L-3008) a distance of 130 metres west of its junction with the Limerick Road;
- (f) a point on the O'Callaghan's Mills Road (R-466) a distance of 101 metres east of its junction with the Scarriff Road;

and from the last mentioned point to the commencement point on the Scarriff Road.

(8) The following roads at Bunratty:

- (a) a point on the L-3132 a distance of 34 metres west of its Junction of L-3132 / L-3040 at Bunratty Bridge, Bunratty West;
- (b) a point on the L-3132 a distance of 138 metres East of its Junction of L-3132 / L-3040 at Bunratty Bridge, Bunratty West;
- (c) a point on the L-3040 a distance of 508 metres North of its Junction with the L-3132 / L-3040 at Bunratty Bridge, Bunratty West;

(9) The following roads at Carrigaholt:

All Roads in the area enclosed by a series of straight lines commencing at a point on the Kilkee Road (R-488) a distance of 50 metres north-west of its junction with the Doonaha Road and thence successively to the following points:

- (a) a point on the Doonaha Road (L-6024) a distance of 30 metres north-east of its junction with the Kilkee Road;
- (b) a point on the Carrigaholt Castle Road (R-488) a distance of 10 metres east of its junction with the O'Curry College Road;
- (c) a point on the O'Curry College Road (L-2002) a distance of 196 metres south of its junction with Carrigaholt Castle Road;
- (d) a point on West Street (L-2004) a distance of 549 metres west of its junction with the Kilkee / Carrigaholt Castle Road;

and from the last mentioned point to the commencement point on the Kilkee Road.

(10) The following roads at Carron

All Roads in the area enclosed by a series of straight lines commencing at a point on the Kinvarra Road L 1014 a distance of 110 metres north of its junction with the Gort Road L-1012 and thence successively to the following points:

- (a) a point on the Gort Road L1012 a distance of 90 metres east of junction with the Kinvarra Road L1014
- (b) A point on the Kilfenora Road L1014 a distance of 300 metres south of its junction with the Ballyvaughan Road.
- (c) a point on the Ballyvaughan Road L1042 a distance of 120 metres southwest of its junction with Kinvarra Road L1014

and from the last mentioned point to the commencement point on the Kinvara Road (L1014)

(11) The following roads at Clarecastle:

All Roads in the area enclosed by a series of straight lines commencing at a point on the old Limerick Road (R458) a distance of 18 metres south-west of its junction with the Quin Road (L-4114) and thence successively to the following points:

- (a) a point on the Lissan Road (L-4174) a distance of 1,030 metres south of its junction with the Claremount Road;
- (b) a point on the Claremount Road (L-4172) a distance of 1,234 metres south-west of its junction with the Lissan Road;
- (c) a point on the Killadysert Road (R-473) a distance of 1,053 metres south-west of its junction with the old Ennis Road;
- (d) a point on the Ballybeg Road (L-4176) at its junction with the Kilrush Road;
- (e) a point on the old Ennis Road (R458) at its intersection with the Ennis Town Boundary;

and from the last mentioned point to the commencement point on the Limerick Road.

(12) The following road at the Cliffs of Moher:

The Lisdoonvarna Road (R-478) from a point 265 metres north of the Cliffs of Moher car park entrance in a southerly direction for a distance of 640m.

(13) The following road at Clooney:

The Ennis – Tulla Road (R-352) through Clooney from a point 85 metres North West of its junction with the L 4074-41 for a distance of 475 metres in a North Westerly direction.

(14) The following roads at Cloonlara:

- (a) The Cloonlara Village Road (L-3050) between points which are 341 metres northwest and 238 metres south-east respectively of its junction with the Newtown Road.
- (b) The Newtown Road (L-3058) for a distance of 823 metres south-west of its junction with the Cloonlara Village Road.

(15) The following roads at Connolly:

(a) The Ennis-Milltown Malbay Road (R-474) between points which are 830 metres east

and 370 metres south-west respectively of its junction with the Inagh Road.

(b) The Inagh Road (L-8284) for a distance of 50 metres north-west of its junction with the Ennis-Milltown Malbay Road.

(16) The following roads at Cooraclare:

All Roads in the area enclosed by a series of straight lines commencing at a point on the Kilrush Road (R-483) a distance of 240 metres west of its junction with the Bristla Road and thence successively to the following points:

- (a) a point on the Danganella Road (L-2042) a distance of 340 metres north-west of its junction with the Milltown Malbay Road;
- (b) a point on the Milltown Malbay Road (R-483) a distance of 355 metres north of its junction with the Danganella Road;
- (c) a point on the Ennis Road (L-2044) a distance of 30 metres east of its junction with the Milltown Malbay Road;
- (d) a point on the Tiernaglohane Road (L-6118) a distance of 25 metres east of its junction with the Bristla Road;
- (e) a point on the Bristla Road (L-2050) a distance of 93 metres south of its junction with the Kilrush-Milltown Malbay Road;

and from the last mentioned point to the commencement point on the Kilrush Road.

(17) The following roads at Corrofin:

All Roads in the area enclosed by a series of straight lines commencing at a point on the Ennis Road (R-476) a distance of 120 metres south of its junction with the Ennistymon Road and thence successively to the following points:

- (a) a point on the Ennistymon Road (R-460) a distance of 805 metres south-west of its junction with the Ennis Road;
- (b) a point on the Lough Inchiquin Road (L-1110) a distance of 390 metres west of its junction with the Lisdoonvarna Road;
- (c) a point on the Lisdoonvarna Road (R-476) 426 metres north of its junction with the Lough Inchiquin Road;
- (d) a point on the Gort Road (R-460) a distance of 499 metres north-east of its junction with the Lisdoonvarna Road;
- (e) a point on the Kilvoydan Road (L-5242) a distance of 35 metres north-east of its junction with the Gort Road;

and from the last mentioned point to the commencement point on the Ennis Road.

(18) The following roads at Cratloe:

(i) Cratloe Village -

All Roads in the area enclosed by a series of straight lines commencing at a point on the Sixmilebridge Road (R-462) a distance of 331 metres north-west of its junction with the Gallows Hill Road and thence successively to the following points:

- (a) a point on the Gallows Hill Road (L-3038) a distance of 831 metres north-east of its junction with the Sixmilebridge Road;
- (b) a point on the Wood Road (L-3102-11) a distance of 1,009 metres east of its junction with the Sixmilebridge Road;
- (c) a point on the Limerick Road (R-462) a distance of 176 metres south-east of its junction with the Laghile Road;
- (d) a point on the Laghile (Setrights' Cross) Road (L-3116) a distance of 209 metres south of its junction with the Limerick Road;
- (e) a point on the Brickhill / Ballymorris Road a distance of 10 metres south of its junction with Station Road;.
- (f) a point on the Station Road (L-3102) for a distance of 795 metres south-west of its junction with the Sixmilebridge Road;

and from the last mentioned point to the commencement point on the Sixmilebridge Road.

(19) The following roads at Cree:

All Roads in the area enclosed by a series of straight lines commencing at a point on the Kilrush Road (R-483) a distance of <u>364</u> metres south of its junction with the Ennis / Doonbeg Road and thence successively to the following points:

- (a) a point on the Doonbeg Road (R-484) a distance of 133 metres west of its junction with the Kilrush Road;
- (b) a point on the Milltown Road (R-483) a distance of 234 metres north of its junction with the Ennis / Doonbeg Road;
- (c) a point on the Ennis Road (L-2048) a distance of 222 metres east of its junction with the Kilrush Road;

and from the last mentioned point to the commencement point on the Kilrush Road.

(20) The following road at Cross:

All roads in the area enclosed by a series of straight lines commencing at a point on the Kilbaha / Kilkee Road (R-487) a distance of 230 west of it's junction with the L-6010 and thence successively to the following points:

- (a) A point on the R487 a distance of 604 metres east of its junction with the L -6010.
- (b) A point on the L-6010 a distance of 350 metres south of it's junction with the R-487.

(21) The following roads at Crusheen:

All Roads in the area enclosed by a series of straight lines commencing at a point on the old Galway Road (R458) a distance of 480 metres north of its junction with the Tulla Road and thence successively to the following points:

- (a) a point on the Ballinruan Road (L-4000) a distance of 275 metres north-east of its junction with the Tulla Road;
- (b) a point on the Tulla Road (L-4074) a distance of 445 metres south-east of its junction with the old Galway Road;
- (c) a point on the old Ennis road (R-458) a distance of 50 metres south of the centre of the Ennis road roundabout
- (d) a point on the yield line at the intersection of the N-18 and the Ennis Road Roundabout
- (e) a point on the Station Road (L-8156) a distance of 50 metres North of the centre of the Ennis road roundabout

and from the last mentioned point to the commencement point on the old Galway Road.

(22) The following roads at Doolin:

All Roads in the area enclosed by a series of straight lines commencing at a point on the Doolin Pier Road (R-459) a distance of 353 metres west of its junction with the Cliffs of Moher Road and thence successively to the following points:

- (a) a point on the Lisdoonvarna Road (R-459) a distance of 1591 metres north-east of its junction with the Cliffs of Moher Road to a point 15 metres north east of its junction with Toomullin
- (b) a point on the L50701 a distance of 380 metres north west of its junction with the R459.

- (c) A point on the L50702 a distance of 120 metres south east of its junction with the R459.
- (d) A point on the R479 Ennistymon Road a distance of 120 metres south east of its junction with the R459.
- (e) a point on the Cliffs of Moher Road (L-1038) a distance of 54 metres south-west of its junction with the Doolin Pier/Lisdoonvarna Road;

and from the last mentioned point to the commencement point on the Doolin Pier Road.

(23) The following roads at Doonbeg:

All Roads in the area enclosed by a series of straight lines commencing at a point on the Kilkee Road (N-67) a distance of <u>50</u> metres west of its junction with the L-2028 White Strand Road and thence successively to the following points:

- (a) a point on the White Strand Road (L-2028) a distance of <u>384</u> metres north of its junction with the Kilkee Road;
- (b) a point on the Rinnagonnaght Road (L-6098) a distance of 137 metres north of its junction with the Kilkee / Milltown Malbay Road;
- (c) a point on the Milltown Malbay Road (N-67) a distance of 574 metres west of its junction with the Newtown Road;
- (d) A point on the (L-60981) a distance of 123 m South of its junction with the Kilkee/Milltown Malbay Road
- (e) a point on the Kilrush Road (L-2030) a distance of 215 metres south of its junction with the Kilkee Road;

and from the last mentioned point to the commencement point on the Kilkee Road.

(24) The following road at Drumquin:

The Ennis / Killdysert Road (R-473) between a point which is 124 metres south-west of its junction with the Craggkerrivan Road (L-8260) and a point which is 62 metres northeast of its junction with the Cragbrien Road (L-8266).

(25) The following road at Drumandoora.

All roads in the area enclosed by a series of straight lines commencing at a point on the Feakle Road R 461 a distance of 430 metres west of its junction with the L 80133 and thence successively to the following points.

- (a) A point on the Feakle Road R461 a distance of 250 metres east of its junction with the L-80132.
- (b) A point on the L80132 a distance of 100 metres north of its junction with the R461 Feakle Road.

(c) A point on the L80133 a distance of 67 metres south of its junction with the R461 Feakle Road.

(26) The following roads adjacent to the town of Ennis:

- (a) The Ruan Road (L-4186) & L4162 for a distance of 1597 metres north of its intersection with the Ennis Town Boundary.
- (b) The L-4146 for a distance of 40 metres East of its junction with the L-4162
- (c) The L-4146 for a distance of 70 metres West of its junction with the L-4162
- (d) The Shanvogh / Kilquane Road (L-4142) from its intersection with the Ennis Town Boundary to a point 61 metres south-west of its junction with the Cragleagh / Inch Road;
- (e) The Cragleagh / Inch Road (L-8314) between points which are 64 metres northwest and 238 metres south-east respectively of its junction with the Shanvogh / Kilquane Road;
- (f) The Drumcaran Beg Road (L-4604) for a distance of 331 metres south-west of its intersection with the Ennis Town Boundary;
- (g) The Ennistymon Road (N-85) between its junction with the L1604 Drumcaran Beg Road and its intersection on the north-west side with the Ennis town Boundary
- (h) The Quin Road (R-469) for a distance of 511 metres east of its intersection with the Ennis Town Boundary.
- (i) The Circular Road (R-474) starting at a point at the Ennis town boundary for a distance of 470 metres and ending at a point 125 metres west of the Beechpark roundabout.
- (j) The Tulla Road (R-352)starting at a point at the Ennis Town boundary (Knockanean Townland) and finishing at a point 230 metres east of the entrance to the electricity station
- (k) The Ballaghboy Road L-4118 Starting at a point at its junction with the R-469 and ending at a point with its junction with the L-4611Gaurus.
- (l) The M-18 Northern slip road Junction 13 starting at a point 23m from the yield line of the Tulla road roundabout and finishing at a point at its intersection with the Tulla road roundabout (R-352)
- (m)The M-18 Southern slip road Junction 13 starting at a point 24m from the yield line of the Knockaneen roundabout Tulla road R-352 and finishing at a point at its intersection with the Knockaneen roundabout Tulla road R-352.
- (n) The N68 (Ennis to Kilrush Road) from the yield line at the junction with the Kilrush Road Roundabout at Cahircalla More, to a point 354m south-west of the said location.
- (o) The N85 (Western Relief Road / Ennis Bypass) starting at a point 79 metres west of its intersection with the Clareabbey roundabout, including all circulatory carriageways within the said roundabout
- (p) The N85 (Western Relief Road / Ennis Bypass) starting at a point 93 metres East of the Clareabbey roundabout, on the West bound approach only and finishing at a point at its intersection with the Clareabbey roundabout.

(q) The L-4180 (Lees Road) from its junction with the N85 and ending at a point at its intersection with the Ennis town boundary for a distance of 1320m.

(27) The following roads at Ennistymon:

All Roads in the area enclosed by a series of straight lines commencing at a point on the Ennis Road (N-85) a distance of 317 Metres south-east of its junction with the Circular Road (L-1122-0) and thence successively to the following points:

- (a) a point on the Kilcornan Road (L-5286) a distance of 360 metres east of its junction with the Circular Road;
- (b) a point on the Lisdoonvarna Road (N-67) a distance of 95 metres north of its junction with the L-1050 Sroohil Road;
- (c) a point on the Sroohil Road (L-1050) a distance of 207 metres north-west of its junction with the Lisdoonvarna Road;
- (d) a point on the L-5132 (Falls Hotel) a distance 152 metres west of its junction with the Lisdoonvarna road (N-67)
- (e) a point on the Lehinch Road (N-67) a distance 550 metres west of its junction with the Bogberry Road;
- (f) a point on the Deerpark West Road (L-5192) a distance of 385 metres west of its junction with the Bogberry Road;
- (g) a point on the Bogberry Road (L-1082) a distance of 535 metres south of its junction with the Woodmount Road;.
- (h) a point on the Woodmount Road (L-1084) a distance of 420 metres south-east of its junction with the Bogberry Road;

and from the last mentioned point to the commencement point on the Ennis Road.

(28) The following roads at Feakle:

- (a)The Baurroe / Feakle Road (L-4058) between points which are 719 metres southwest and 648 metres north-east respectively of its junction with the Market House / Smith's Cross Road.
- (b) The Market House / Smith's Cross Road (L-4064) for a distance of 105 metres southeast of its junction with the Baurroe / Feakle Road.
- (c) The School Cross / Flynn's Cross Road (L-4062) for a distance of 180 metres southeast of its junction with the Baurroe / Feakle Road.
- (d) The Curragh Road (L-8116) for a distance of 348 south-west of its junction with the School Cross / Flynn's Cross Road.

(29) The following road at Flagmount:

The Caher / Bleach Bridge Road (L-8022) between points which are 183 metres south and 793 metres north respectively of its junction with the Merriman Court Estate.

(30) The following roads at Ballycasey and the Hurler's Cross:

- (a) The Ballycaseymore / Clonmoney Road (L-3198) between its junction with the Shannon Development Housing Estate Road and its further junction with the southern leg of the new N-18 inclusive of its feeder cul-de-sac road that formed part of the former N-18;
- (b) The Hurlers Cross Link Road for a distance of 20 metres south-west of its junction with the Hurlers Cross Road;

- b) The M18 Junction 11 Dromoland southbound-off slip road from the yield line at its junction with the Dromoland East Roundabout at Latoon North / South, to a point 26m north of the said location.

a) L-7058 starting at a point 47 metres North-East of the entrance to Bishop Murphy Park to its termination point.

3) The Kilbaha / Loop Head Area

- a) R-487 starting at a point 283 Metres South West of the junction of the R-487 and the L-2142 to an end point at it junction with the L-2000.
- b) R-487 starting at its junction with the L-2000 to a termination point at Loop Head Light House for a distance of 1677 metres.
- c) L-2000 starting at its junction with the L-2142 and ending at its junction with the R-487 for a distance of 3260 metres.
- d) L-2142 starting at its junction with the L2000 and ending at a point 160 metres north of its junction with the R487.
- e) L-20004 starting at 3x rds at the R-487 Kilbaha South and ending at its termination point for a distance of 640 metres.

4) Barrtra

a) L-5166 starting at its junction with the N-67 to its termination point for a distance of 900 metres.

EXPLANATORY NOTE

These Bye-Laws replace the Road Traffic (Special Speed Limits) (County of Clare) Bye-Laws 2012 and alter the speed limits applicable to certain roads in this area.

These ByeLaws prescribe speed limits of 50 and 60 kilometres per hour in respect of the public roads mentioned respectively in the First and Second Schedules herein.

These ByeLaws also prescribe speed limits of 80 and 100 kilometres per hour in respect of the public roads mentioned respectively in the Third and Fourth Schedules herein.

These Byelaws also prescribe a Rural designation speed limit in respect of the public road mentioned Sixth Schedule herein.

These Byelaws also prescribe Special Speed Limits in the immediate vicinity of Schools for Specified Periods and Specified Days in respect of the public roads mentioned in the Fifth schedule.

These Byelaws also prescribe road traffic special speed limits housing estates as listed in the 2015 bye-laws (Pilot Project). In respect of the public roads mentioned in the Fifth Schedule herein.

Roads in respect of which a Special Speed Limit for as prescribed in accordance with Circular RSD 01-2015 of the document "*Guidelines for the Setting and Managing of Speed Limits in Ireland (2015)*" section 7.2.2.6 Minor Local Roads; in respect of the public road mentioned Seventh Schedule herein.

Ambulances, fire brigade vehicles and Garda Siochana vehicles whilst used in the course of duty are exempted from all speed limits imposed by these Bye-Laws.
