**Phase 2 (Full Closure) - 11.00am - 18.00pm**  
 Barriers in place and no vehicular access into temporary pedestrian only zones.

**Phase 3 (Overnight)**  
 Barriers removed and full vehicular movement throughout temporary pedestrian only zones.

NB - There will be NO RIGHT TURN movements from Abbey Street carpark towards Abbey Street at any time.

NO Vehicles greater than 7.5m will be permitted through this junction as per existing warning signage
