Register of Electors Modernisation Project

The Electoral Reform Act 2022 was passed into legislation by the Dáil in July. The legislation provides for a range of significant electoral reforms in line with commitments in the Programme for Government – Our Shared Future.

Minister Humphreys officially opens Lahinch Leisure Centre

The Lahinch Leisure Centre Project Technical Team, led by Noeleen Fitzgerald, Director of Finance and Support Services, oversaw the €6m revamp of Lahinch Leisure Centre which was officially unveiled on Monday, 18th July 2022, by Heather Humphreys TD, Minister for Rural and Community Development.

The facility upgrade was funded by the Department of Community and Rural Development through the RRDF, the Sustainable Energy Authority of Ireland (SEAI), the TOMAR Trust, LEADER, Clare County Council and local fundraising.

The newly redesigned family-friendly, state-of-the-art facility features a 25-metre heated swimming pool, learner pool, sauna, steam room and jacuzzi. A two-storey fitness gym overlooks the Promenade and Liscannor Bay, with membership drawn from all over North and West Clare already exceeding 1,400 people.

The facility is a Nearly Zero-Energy Building (NZEB) delivering approximately €100,000 savings in annual energy costs. JADA Construction Ltd and Kelly RAC were the main contractors for the development while the design team comprised McKenna Consulting Engineers, Tom McNamara & Partners and Tipperary Energy Agency.

Funding received under the Department's RRDF fund has also helped deliver new on-site public toilets as well as a new rescue centre developed by Clare Water Safety.

This project is a great example of how collaboration, in this case between Clare County Council, Lahinch Leisure Centre, Clare Water Safety and the community, can deliver real investment in our areas and ensure that we have sustainable regional development throughout the county.

FINANCE

The interim half year report which covers the six month period from January to June 2022 is before the Council. The report outlines the financial results of Clare County Council for the first 6 months of the year. The overall result in the Revenue Account was in line with budget. While this is an extremely positive result, it should be noted that as we move into the second half

of the year additional challenges will be faced by the Council as outlined in the half year report. On the capital ledger the closing balance for the 6 months increased with income exceeding expenditure by €0.6m.



September brings the end of the summer season with school/college/work routines re-established. The summer months traditionally would see reduced demand for some services

however 2022 did not yield any slowdown with sustained demand for services during July and August.

HOUSING

The demand for social housing support is ever increasing in spite of the fact that the Council has allocated more than 200 properties in 2022 to date. In addition, there is a notable increase in those applying for social housing support in the County. In July the Council received correspondence from the Department that we have to undertake the social housing needs assessment on the 1st November with the return due by the 29th November. This will provide information on the net social housing demand in Clare.

Private Rented Inspections

Work to achieve the target for private rented inspections (1,025) has continued at pace over the summer months, with 102 physical inspections carried out in August. These inspections were carried out on HAP, RTB, RAS and Leased properties, as well as in response to complaints that were received. The team continue to follow up where properties do not meet the minimum rented standard.

HAP limits:

On the 7th July 2022 the Council was advised of additional discretion for HAP in recognition of the impact of inflation on the current rental market. The Council are now authorized to exercise discretionary flexibility in respect of the HAP rent limits as follows:

- An increase in the HAP discretion rate from the current 20% to a maximum of 35% for all local authority areas. This will apply to both new and existing tenancies.
- Additional flexibility allowing local authorities to apply a couple rate to a single person household, where required, in recognition of the shared onebed need. This will apply to new tenancies only.

Vacant properties

Vacant properties continue to be examined with a view to bringing the units back into use as either social housing or for sale on the private market. Properties are now being examined for the CPO procedure where all other attempts to address the dereliction is unsuccessful. One vacant property, the subject of a CPO, is progressing as confirmation was recently received from An

Bord Pleanala that no objections were received by them within the prescribed period. Confirmation of the CPO and Notice to Treat will now be undertaken with a view to bringing this unit into stock.

The public are encouraged to register vacant properties on the website www.vacanthomes.ie Properties registered on this website are investigated and assessed for suitability for redevelopment/purchase. Following the announcement of the new Croi Conáithe Scheme there has been a notable increase in the number of properties logged on this website during the summer months.

Croi Conaithe (Towns Fund)

In early July confirmation was received that a grant of €30,000 is being made available for the refurbishment of vacant properties for occupation as the principal private residence of the owner. A maximum top-up grant amount of €20,000 will be available where the property is confirmed to be derelict. The scheme is exclusively available to individuals or households where the dwelling will be used at their principal private residence. There is strong interest in the Scheme with a number of enquiries received daily. 4 applications have been submitted to date and are currently being assessed.

New County Library Construction Project

Construction commenced on the new library building on Thursday 28th April 2022. Progress to date is on programme, with an overall completion date of Q4 2023.

The project involves the construction of a 2,321m2 building on the glór site, comprising two floors of public library space. The local studies centre will be accommodated in this building, along with a separate art gallery. Additionally, the County Library HQ will be located on the third floor. The state-of-theart new build will provide a key resource for research, study, recreation and art in a centralised location adjacent to the well-established glór theatre.

Clare County Library

Clare County Library received €26,743.94 from 2022 Dormant Accounts Fund for library supports for marginalised, socially excluded and disadvantaged communities. The majority of the funding will be spent on library programming called 'A world of welcome', an arts programme for Ukrainian and their Irish classmates, which will take place in five libraries in the autumn. The remainder will be spent on a range of resources including learning support software, physical resources and c-pens.

Clare Library service also received €10,000 donation from the Eala Ce Fund via the Community Foundation of Ireland. The money will be spent on literacy resources and another arts programme for Ukrainian students.

42 deliveries were made to housebound library members this month.

There were many children's events in libraries this summer mainly reading-focused activities.

Over 2,000 children joined Summer Stars, the non-competitive initiative which enables every child who signs up to receive a series of reading-related incentives week on week. An award

certificate at the end of the challenge is presented to each participant. Support events took place in all branches including Environmental Awareness presentations, visits from National Parks and Wildlife Rangers, teddy bears' picnics in library gardens and STEAM events including chess and rock painting workshops. Library branches placed special emphasis on events to include the many Ukrainian children now living in Clare and programme advertising was in both English and Ukrainian.

In a collaborative event with Clare Children and Young People's Services Committee, (CYPSC), Mayor of Ennis, Claire Colleran Molloy welcomed Ukrainian children to De Valera Library, Ennis on the 6th of July, where they enjoyed a special story time, and each child received a gift of a Little Library Book Bag. Little Library Bags were provided free from all public libraries and is a First 5 initiative and part of the Government strategy to improve the lives of babies, young children and their families.

Creative Ireland

Work is currently ongoing on Clare's Culture and Creativity Strategy 2023-2027. A survey of stakeholders has taken place and focus groups will begin in September.

Healthy Ireland

Clare Library delivered 3 Healthy Ireland at Your Library events during the summer. Sixteen people attended a Parent & Baby Yoga workshop in Kilrush Library, which was facilitated by Yoga teacher, Colette Nagle. The workshop was greatly appreciated and enjoyed by all. Sonia Millar, mindfulness teacher, facilitated 2 children's workshops in Ennistymon and Kilrush Libraries, which were attended by a total of 14 children. The practice of Creative Mindfulness teaches children self-care tools that can help them to clear their minds and understand difficult thoughts and feelings. By making mindfulness a part of their lives at a young age, children are equipped to navigate challenges with greater wisdom, clarity and compassion.

Issues 1-20 (1984-89) have been completed and the project is ongoing. An index to the historical Parish Marriage records of southwest Clare has also been added to the page.

Clare Archives:

An exhibition on the Barrett Collection took place during Heritage Week in Kilrush Library. The Collection is currently being preserved thanks to funding from The Heritage Council. The collection was saved in 2018 by the Kilrush and District Historical Society. It will gradually be digitised over the coming months once it is safely stored and conserved.

Clare Arts Office

The Arts in Clare slot on Clare FM continued during the summer, 26 applications were successful under the Live Local Performance Scheme – Phase IV with 8 events taking place in Doolin, Ennis, Ennistymon, Feakle and Moy. A total of 219 individuals were employed for 607 days in Clare through Phase III of the scheme. Two "Artist in Schools" residencies were completed in Inagh and Kilbaha and 2 disability projects with Brothers of Charity and the Clare Crusaders were also completed.

Preparatory work for the final phase of the Associated Artists programme with Fionnathan was undertaken and Jenny Guy commenced planning on a major arts and education programme beginning in September. Six exhibitions took place in Kilkee, Ennis and Scariff.

The PRISM street art scheme continued in Ennis with 12 artworks completed and two repaired.

Over 40 events are currently being programmed for Culture Night in September. Assistance was given to 4 production companies doing location shots in New Quay, Killaloe, Ennis, Kilkee and Carrigaholt for tourism promotion films, adverts, sports coverage and for the BBC series "Who Do You Think You Are"? Two "Musicians on Call" performances took place in Kilrush and Ennistymon and 21 events took place in Culturlann Sweeney as well as three weeklong art camps for children.

Social media stats - 48 posts were placed on the Clare Arts Website. There were 5928 engagements on the Culturlann Sweeney Facebook page.

Clare Museum

The Museum received its Maintenance of Accreditation certificate at Kilkenny Castle. There were 15 social media posts, mostly of items associated with particular dates during July and August.

Thirty objects from the Museum's cataloguing backlog were accessioned during the summer months. The curator has been engaged in gathering photographs of artefacts for the new website and preparing content. During Heritage Week the museum and the web designers consulted the public and stakeholders on what the new website should look like and the kind of information they would like to see on it.

Two items sent for conservation during the year were returned to the Museum. Three items from the National Museum collection that were sent to Dublin for conservation purposes were placed back on display in August.

TRANSPORTATION

Roadworks Programme and Operations

Clare County Council has received its road grant allocations for 2022. The overall allocation for Roads in the 2022 Roadworks Programme is €48.4 million which comprises of Transport Infrastructure Ireland, Department of Transport and National Transport Authority grant allocations along with IPBMI and own resource allocations.

The Roadworks Programme for 2022 has been prepared as part of the SMDW for 2022 and has been adopted by all four Municipal District meetings in March.

Rollout of the 2022 programme of work is well under way in all of the Municipal Districts.

Strategic Transportation

Limerick Shannon Metropolitan Area Transport Strategy

The Draft Limerick Shannon Metropolitan Area Transport Strategy (LSMATS) document was approved by the National Transport Authority (NTA) Board during the summer of 2020. The LSMATS public consultation, to which all Members were invited, was launched by the NTA on 2nd September, 2020 and was on public display for an 8 week period up to 30th October. There were over 112 submissions during the process which the NTA have considered. The revised Draft LSMATs document was published on the 26th April 2022. There was a consultation period for 6 weeks until 10th June. A presentation of the revised draft LSMATs document was made by the NTA to the Physical Development SPC on May 31st, 2022 and a submission on the strategy was made by Clare County Council. Steering meetings were held by the NTA over the summer months and the NTA have prepared a final draft to present to their board.

Connecting Ireland

This project commenced in 2021 and is being led by the National Transport Authority. The aim of the project is to improve the public transport service provision in Clare by improving scheduling, dealing with gaps in the service and by introducing new public transport routes. Liaison and information sharing has commenced between the NTA and Clare County Council Municipal Districts and Road Design Section to support the NTA in a comprehensive rollout of the project. The local link from Kildysart to Kilrush was rolled out during 2021 as part of this project by the NTA.

Active Travel Programme 2022

Funding for the Active Travel 2022 programme was announced

by the NTA for County Clare on the 24th January 2022. The total allocation for projects across all MDs in the county is €5,298,000.

- Concept designs being prepared for Clare Road in Ennis,
 Tulla Road as part of the Ennis Cycling Network.
- Tender drawings are being prepared for Ballycasey in Shannon and Lissycasey.

Public lighting

Cork County Council published the tender for the Public Lighting Energy Efficiency Project in County Clare and four other counties on 1st October, 2020. Following the successful conclusion of the procurement process a contractor has been appointed as the Design Build Works Contract for this regional project. At present 52% of public lights in Clare have been changed to LED through the current maintenance contract.

A public lighting design as well as a Quality Audit are being prepared for submission to TII. The detailed design is progressing. The junction between Mount Charles Terrace and the N67 has been surveyed and a preliminary design to improve visibility has been developed. A Stage 1 Road Safety Audit for this junction has been carried out with Minister Place. CCC and the Auditor are working on solutions for the issues raised in the report. A Feasibility Report is being prepared for submission to the TII.

Ballyallia Amenity Park Enhancement Works

Informal consultations with both the National Parks and Wildlife Service and key stakeholders, who use the Amenity Park, have taken place and this has influenced design considerations. Specialist consultants have or are being appointed. Environmental & Ecological consultants are completing the ongoing surveys of Bats, Otters, Habitat, Tree Vegetation, Invasive Species, Breeding Birds and Winter Vantage Point Birds that are required to complete an 'Appropriate Assessment' and 'Environmental Impact Assessment'. A public consultation is to be completed on the 8th of September, 2022.

Town and Village Renewal Schemes

Corrofin Town & Village Renewal Scheme - topographical survey finalised and on file. Preliminary design investigations ongoing.

Parteen Town & Village Renewal Scheme - Contract awarded. Works due to commence September 2022.

CAPITAL DELIVERY / PROJECT MANAGEMENT OFFICE

PMO update for Monthly Report for September 2022 Meeting As there wasn't a Council Meeting in August, this update covers the main items progressed in the two month period since the last report in July. Significant progress across a number of PMO projects has been achieved with the main items being as follows:

Cloughnainchy Flood Relief Scheme

Despite our best endeavours, all Landowners impacted by this proposed scheme have not agreed to make their lands available as required. Until these are all submitted, unfortunately, the project cannot progress any further.

Ennis South Flood Relief Scheme

As the defects period deadline approaches, Clare County Council are identifying any items that have arisen since completion that need to be addressed. These are small in number and scale. Work has also begun on the erection of signage and street

furniture associated with the River Fergus Walkway. Information boards have been designed which will be erected along the route. These will provide a history of Clare Abbey, information on the flood scheme itself and the details of the rich flora and fauna associated with the Special Area of Conservation and Special Protection Area along the River Fergus.

Ennistymon Inner Relief Road and Bridge Crossing (Blake's Corner)

Clare County Council still await a decision by An Bord Pleanála as to whether the CPO application for the scheme will be confirmed, amended or rejected. The outcome of this will determine our next course of action.

Killaloe Bridge and By-Pass

The Project Team consisting of Clare County Council, Tipperary County Council, Department of Transport (DoT) and scheme Consultants, RPS Consulting Engineers are pleased to advise

that Construction Works for the Killaloe Bypass, Shannon Bridge Crossing and R494 Improvement commenced on the 17th of August 2022. The Main Contractor, John Sisk & Son (Holdings) Ltd are initially focused on access to the East and West side abutments of the new Shannon Bridge Crossing on the R494 adjacent the Roolagh junction and on the L3100 access road to Clarisford Park.

At the same time, works to the Main Construction Compound situated on the R463 adjacent to the Shantraud Woods Housing Development are being progressed. This will be the main base for the contractor and site supervisory personnel for the duration of this contract. Furthermore, there are also some environmental, ecological and archaeological tasks being carried out in tandem with construction activities as well as Condition Surveys of properties in close proximity to the scheme.

The Project duration is 3 years. Sisk's are currently engaged with the major stakeholders, suppliers and subcontractors and are preparing a comprehensive Works Schedule. Further information will be provided once the detailed Works Schedule is issued.

Other works currently ongoing include:

- The few remaining Land Acquisitions are currently being progressed.
- Detailed testing and carbon dating analysis of Archaeological items uncovered during the investigation works carried out on site in 2021 is ongoing. Following the provision of all of these results to Rubicon Heritage Services Ltd, the final reports can be prepared, and a public presentation organised as promised. We would hope to be able to hold this later in 2022.

Kilkee Flood Relief Scheme

Significant progress has been made in the development of the Fluvial (river) options during the July and August periods. Three emerging options for both the Atlantic and Victoria streams were produced with some sub-options included. It was agreed between CCC and the OPW that it would be prudent to present these emerging options as an additional Public Participation Day (PPD) in order to receive feedback from the Kilkee community. The PPD was advertised on radio and in newspapers in both Clare and Limerick as well as various posts on social media platforms. The event took place on Thursday 18th August in the Kilkee Community Centre between 2pm and 8pm and all comments received were recorded for consideration during the selection of a preferred option.

Assessment of the wave overtopping risk has progressed considerably during recent months. Due to the complex nature of this element, it is likely that some additional modelling will be required in order to produce an acceptable range of emerging options. JBA_JB Barry have specified the additional modelling that is required which is currently under review by CCC and OPW.

Other works that have been carried out include further CCTV surveys for the refinement of the Pluvial (trapped rainwater) options and seasonal environmental surveys. The Project Website www.kilkeefrs.ie has been updated with the options drawings and questionnaires from the recent Public Participation Day.

Local Infrastructure Housing Activation Fund (LIHAF)

Members will be aware of the High Court challenge taken in this matter but we are pleased to advise that as of July 19th last, terms were agreed which enable us to move to the next stage of development of this project.



Killaloe Bypass Project

The initial focus now is in completing the Ground Investigation works and to that regard this contract has been awarded to Priority Geotechnical Ltd. This survey work is critical to allow development of the detailed design necessary for the scheme consultants, RPS Consulting Engineers, to finalise the road design, land-take requirements and prepare the scheme drawings and specifications for a competitive Tender process. We have also commenced engagement with the relevant Landowners regarding the aforementioned survey works and acquisition of the necessary lands required for the road element.

Lough Donnell Culvert Repair works

Site Investigation work is due to be carried out in September which will inform the detailed design. On completion of the detailed design, tender documents will be prepared with the intention of appointing a contractor later this year.

Limerick Northern Distributor Road (LNDR)

The Council has been extensively engaging with the NTA over the past while to ensure the inclusion of the LNDR proposal in the upcoming final draft of LSMATS.

N19 Shannon Airport Access Road

Phase 3 (Design and Environmental Evaluation) is currently ongoing. Significant progress has been made over the Summer months in terms of junction design development, active travel measures, access strategies, scheme land-take requirements, construction methodologies and sequencing following a number of coordination meetings with TII Road Safety Section, NTA, the Gardaí, Shannon Airport and Shannon Commercial Properties.

Nationwide Data Collection Ltd have now completed the final road vehicle traffic surveys which will allow further assessment and consideration of traffic volumes during this Summer period. Earth-Sound Geophysics Ltd have are shortly due to complete Archaeology & Geophysical Surveys of the site. The purpose of

this survey is to provide information both on the location and extent of any potential geophysical anomalies and to assess the extent and state of preservation of archaeological remains, if present, as part of the process of archaeological assessment and risk management for this scheme.

The results gained from these surveys will assist the further development of the scheme design including the layout and junction arrangements, identifying the lands required for the scheme and the preparation of an Environmental Impact Assessment.

Phase 3 is expected to take up to mid-2023 to complete. As always, further information and associated literature on the project can be accessed via the scheme website www.shannon-access.ie

N85 Kilnamona Road Improvement Scheme

Clare County Council in conjunction with the Mid West Regional Road Design Office (MWRRDO) are compiling the necessary Tender Documents for the appointment of Technical Advisors. The tender competition will commence in Q3, 2022.

Piers and Harbours – Design and procurement works continue for the various projects which were allocated funding under the 'Brexit Adjustment: Local Authority Marine Infrastructure Scheme'. These include Doonmore Pier, Liscannor Pier, Shannon Estuary, Cappagh Pier, Knock Pier, Labasheeda Pier and Kildysert Pier.

Public Realm Regeneration project (Ennis)

Shareridge Contractors on behalf of Irish Water and the ESB are currently carrying out enabling works at Bank Place, High Street and O'Connell Street, involving the upgrade of the mains water network as well as the replacement of a Medium Voltage cable. These works are necessary to ensure the long-term integrity of the town's water, sewer and electrical supplies and will minimise the need for future excavation of the town centre streets

and pathways. The contractor is now at an advanced stage of completion, and the restoration of the through-route via O'Connell Street and Station Road is expected by mid-September 2022. Irish Water also has a need to replace certain sections of the Town Centre's Foul Sewer in Lower O'Connell Street which may necessitate an extension of time required for the construction works to take place. Irish Water/Shareridge have a Public Liaison Officer in place and will continue to inform all affected businesses of the works programme.

Tender submissions were received in August from the short-listed contractors in respect of award of main contract works. These tenders are currently being assessed with a view to the tender recommendation report being issued in mid- September to the Department along with the Final Business Case. Following review of same and subject to Dept approval and the availability of the necessary funding, it would be expected to award the contract in early 2023. Already, it is known that international supply chain challenges will result in delays in getting certain specified materials to site but this is unavoidable and will be carefully managed to ensure that works are aligned with deliveries of essential materials. We will engage with Elected Members and affected business owners/residents as the work progresses to keep everyone informed of developments.

Quin Flood Relief Scheme

Clare County Council along with the OPW continue to make preparations to commence works on site at the earliest juncture. Tree clearance works have been tendered and a contractor is expected to be appointed shortly. The scheme consultant Malachy Walsh & Partners are finalising construction issue drawings and preparing the relevant H&S documents.

Remediation of sites containing Asbestos Containing Materials (ACM)

Contract documents in respect of appointment of Technical Consultants were signed in July 2022 with Fehily Timoney & Co followed by the initial Project Team meeting and site visit by the Consultants to the various affected sites. Preliminary execution and contracting strategies were discussed, and recommendations in this regard will be developed by the consultant for review by Clare County Council. The design is now being developed in respect of informing tender documents for a main works contract in respect of the remediation of ACMs at all sites. Tenders have been issued for Topographical surveys and will be awarded in September 2022. The sites continue to be routinely monitored and maintained as required by Council staff in accordance with our agreed approach following consultation with the EPA.

Shannon Town & Environs Flood Relief Scheme

The SI contractor has submitted their interpretative report which is currently under review by the scheme consultant RPS. The additional coastal study, as required under the Limerick City & Environs FRS is on programme. Data from this study will need to be included in the coastal assessment for the Shannon scheme. Some elements of the Fluvial (river) model will also

need to consider this new data once available.

RPS continue to progress the various seasonal mammal and bird surveys throughout the summer months. Shannon Airport's maintenance works on the west embankments are expected to finish in the coming weeks. Coordination with the N19 Airport Access Road project team is ongoing.

Springfield, Clonlara FRS

Construction work on the embankments is now 90% complete. Side slopes have been shaped in accordance with the design, embankment erosion matting is in place and topsoiling has been completed for the majority of the wet face and crest of the embankment. The main culvert on the Illaunyregan stream is now installed. Hydroseeding of the embankment has commenced. Twin culverts along with associated penstocks and flap valves have been installed on the western stream. The twin culverts on the Illaunyregan Stream are installed and work on the installation of the associated penstocks will begin shortly. The main pump chamber is well underway and will be followed by the construction of the platform. The two pumps are on order with the suppliers. Work on the civil elements of the land raising area at Cottage is complete and landscaping has commenced. The scheme is progressing well and the weather of late has been favourable. The scheme is due for completion in late November 2022.

West Clare Railway Greenway (Section 1: Kilrush to Kilkee)

Clare County Council has appointed an Independent Agronomist in accordance with the 'Code of Best Practice for National & Regional Greenways'. The Agronomist will be available to offer impartial advice to landowners once the emerging preferred route is confirmed. The final preparations for 'Public Consultation 2' are being carried out and it will be on display from the 9th September to the 30th September 2022 at Kilrush Public Library and Sweeney Memorial Library in Kilkee. Information sessions with Clare County Council and the Design Team will be held on September 14th at Kilrush Public Library and September 15th at Sweeney Memorial Library, Kilkee where members of the public will be invited to submit feedback on the 'Route Corridor Options'. In addition, ecological field surveys are ongoing.

West Clare Railway Greenway (Section 2: Ennis to Ennistymon)

Clare County Council is finalising 'Public Consultation 1' which will involve displaying the study area and inviting feedback from members of the public and landowners. 'Public Consultation 1' will be on display in late September in Ennis and Ennistymon. Further details will be communicated in local media in the coming weeks. As always, we would welcome comments or suggestions from members of the public which can be emailed to pmoadmin@clarecoco.ie.

White Strand Miltown Malbay, Coastal Protection Minor Works

We are soon to have a meeting with the relevant section of the OPW to agree the next steps of development for this project and will be better informed to advise the Members following this meeting.

 Members attended a demonstration of a 4x4 electric vehicle hosted by Terra Firma Training.

Emergency Rest Centre

28 Ukrainian Displaced Persons took up residence in the Emergency Rest Centre on the Quin Road in June. Civil Defence members, with the assistance of Clare County Council employees provided 24 hour cover at the rest centre – CCC employees covered weekdays from 09.00 to 17.00 hrs with the Civil Defence members covering evenings, nights and weekends.

Alternative accomodation has been sourced for the residents in various locations (Dublin, Galway & Ennis). Members provided transport for the residents to their alternative accomodation. Transport was also provided to residents for clinical and hospital appointments. Information visits by various state and voluntary agencies were arranged for the residents – INTREO, CLDC, Clare Immigrant Support, Mid-West Simon, LCETB. The centre was closed on the 11th August.

ENVIRONMENT

Environmental Awareness

Clare Libraries initiative

As part of the Clare Libraries Summer Stars programme environmental information sessions were provided by Karen Foley, Environmental Awareness Officer during July at the public libraries in Shannon, Ennis, Miltown Malbay, Ennistymon, Scariff and Killaloe. Through interactive activities children learnt how to use resources wisely and do their bit in the battle against climate change. Children learned about Leave No Trace in addition to what can or cannot be recycled.



An Taisce Blue Flag and Green Coast Programme

As part of the Anti-Dumping Initiative a comprehensive summer beach campaign was delivered over July and August. Adverts were placed in the Clare Echo (x7), Clare Champion (x2), Limerick Post (x1) Clare Fm (5 days). This was further complimented by regular social media posts across Clare County Council and Greener Clare social media channels. Messages comprised of Leave No Trace; Bin It or Bring It Home, Beach Byelaws, Think Before You Flush and Clean Coasts photography competition.

Historic Landfills

The Environment Section were approved for a draft Certificate of Authorisation (COR) for Kilrush Historic Landfill, Dysert, Kilrush in July. The proposed capping of this historic landfill will proceed taking into account the conditions as a set in the COR.

Gardening

Throughout August, seasonal tasks such as watering and weeding continued at our public planted areas in Ennis to ensure floral displays are maintained to a high standard and shall continue to provide colour and enhancement in key public areas, despite the hot and extended dry weather conditions experienced for much of the month.

In line with various other projects undertaken in recent times to promote biodiversity and implement the actions contained within the All-Ireland Pollinator Plan, the Gardening Team has commenced planning for the enhancement of an existing planted area at Áras Chontae an Chláir. This work shall commence shortly and shall aim to showcase how pollinator friendly planting can be implemented in existing urban spaces.

Waste Management

Men's Shed Group

The Environment Section continue to work closely with the Ennis Men's Shed group at Doora with regards to further improvements on the site. Matured compost has been brought from Inagh Civic Amenity Site to be used in the garden area. This has been very beneficial for plant and vegetable growth,

which have been used by the members throughout the summer. Currently, additional fencing and gates are being erected which will benefit both Doora Closed Landfill and the Men's Shed group premises.

Waste Enforcement

Bicycle Recycling Scheme for Ukrainian Refugees

To date 12 childrens' and 14 adults' bikes have been delivered throughout the county under this initiative, with a similar amount currently ready for distribution. Clare County Council has linked in with the Clare Local Development Company (CLDC), and responds to requests for bikes, submitted by the Ukranian Co-ordinators in CLDC. Funding was secured under the Anti-Dumping Initiative. The public are invited to drop off bikes to our Civic Amenity sites for recycling, in line with the principles of the Circular Economy.



Enforcement of Beach Bye Laws

Our community wardens carried out patrols at weekends for the months of July and August, at our coastal beaches and inland waterways to monitor compliance with the Beach Bye Laws. The wardens engaged with the public and gave information on the requirements of the Beach Bye Laws.

A variety of issues arose and were dealt with on the ground, most notably littering, dog control, dog fouling and camping at the beaches. In total, 2 fines were issued under the Beach Bye Laws.

Waste Management Bye Law Campaign

In conjunction with the Beach Bye Law patrols, more than 50 households in the Kilkee area were written to under the County Clare Waste Management Bye Laws, requesting evidence of how they managed their waste. This campaign arose from complaints that short-term residents (in holiday homes / caravan parks) did not have a kerbside refuse collection service and were disposing of their waste in street litter bins. This campaign yielded a high response rate, with most respondents either providing receipts for the Lisdeen Civic Amenity site or providing a written statement that they bring their waste home to their primary residence.

The wardens also engaged with food retail businesses in Kilkee, requesting that they put additional measures in place to manage litter originating from their premises.



Gum Litter Taskforce

Gum Litter Taskforce

The 2022 Gum Litter Taskforce (GLT) "Bin It" gum litter education campaign was launched in Ennis by Ennis Tidy Towns in conjunction with Clare County Council. Councillor Clare Colleran Molloy, Mayor of Ennis Municipal District, Councillor Mary Howard, Cormac McCarthy, Chairperson of Ennis Tidy Towns, volunteers from Ennis Tidy Towns, and members of Clare County Council's Waste Enforcement team attended the launch.

Environmental Monitoring (Illegal Dumping/Litter)

The Waste Enforcement Team continued to respond to complaints relating to waste and litter. In total, 221 complaints relating to waste and litter were received from the 1st of July to the end of August. They have been investigated and are being closed out.

Notifications of Controlled Burning

In total, 7 notifications of controlled burning were received and processed between July and August, as per the Waste Management (Prohibition of Waste Disposal by Burning) Regulations 2009. Each of these applications is inspected by a Community Warden or Executive Engineer.

Lifeguards continue to monitor our beaches 7 days a week during the busy summer months.

WATER SERVICES

Annual Service Plan

The Water Services Section of Clare County Council continues to deliver the water services function as per the Service Level Agreement and the 2022 Annual Service Plan with Irish Water.

Future Delivery of Water Services.

The WRC published a framework document on the 24th June for the future delivery of water services for consideration by the relevant parties. This framework document will assist in ensuring a stable operational environment is maintained as the water sector completes the transition to a national water services authority. There have been no further developments regarding the framework.

Water Services Operations Water and Wastewater Operations

The following statistics provide an indication of the level of activity / work being carried out by the water and wastewater teams throughout the county from 24th June 2022 up to and including 25th August 2022. The figures do not however reflect the time invested by the teams which is required to resolve each complaint/issue.

Wastewater Operations

Two rising main breaks occurred on the foul rising main in Kilkee on the 11th and 18th of August. The breaks were successfully repaired by the West Clare Operations Crews without any disruption to service or negative environmental impact.

Works are progressing well on the new Kilkee twin rising main project with pipe connections to the pumping station nearing completion. Replacing the ageing rising mains with new and improved modern pipes will greatly reduce the risk of bursts causing disruption to service or water quality on the beach.

A total of five Office of Environmental Enforcement (EPA) Site Visits were carried out at wastewater treatment plants in Clare in August 2022. The site visits took place at D0424-01 Crusheen, D0422-01 Inagh, D0081-01 Ennistymon and D0086-01 Ennis North. These site visits are a sample on a particular day of an installation's compliance with some of its licence conditions.

Safety handrails, walkways, stairs and step-overs were installed at Miltown WwTP in July. The installation will ensure that maintenance staff will be able to easily and safely access various areas of the plant.



Planned upgrade works were successfully carried out to the existing clarifier at Clareabbey WwTP in July. The works involved the installation of a new scraper, scumbox and spraybar. The works took a total of 2 days to complete. Round the clock tankering of wastewater was required at Westfields Pump Station to facilitate the upgrade works. Clare County Council water services staff together with sub-contractors worked together to ensure the works caused as little disruption as possible





Irish Water Capital programme. Kilrush Wastewater Treatment Plant:

The new scheme will comprise of a new wastewater treatment plant near Skagh Point, a new rising main, additional storm storage and upgrade of the existing Francis St pumping station. Construction works are ongoing at the site of the new WWTP. The rising main from Frances Street pump station to the new WWTP was partially completed with a road closure and traffic diversions in place. The cofferdam for the new storm storage tank at Frances St Pump Station site has commenced. Completion of the overall scheme is due in mid-2023.

When complete, this scheme will end the discharge of raw sewage to the sea near Skagh Point.

Clarecastle Sewerage Scheme:

This scheme consists of a new pumping facility at Quay Road and new rising main from Quay Road to connect to the Clareabbey Wastewater Treatment Plant inlet.

The contractor has installed the rising main in the land adjoining the N85, from the Clareabbey WWTP to a point opposite the Maxol service station. They are also installing the rising main from Clarecastle School and are continuing northwards with temporary traffic management in place. Works on the rising main and pump station are programmed to be substantially complete by the end of November.

When complete this project will end the discharge of raw sewage to the Fergus at the Quay in Clarecastle.

Liscannor Wastewater Treatment Plant:

Construction of the Liscannor project is ongoing. The scheme will comprise of a new wastewater treatment plant at Corcomroe, a pumping station adjacent to John P Holland Park, rising main, gravity sewer and connection to the existing outfall. At the WWTP the main structures are complete.. Mechanical and electrical works are ongoing. At the pump station the permanent security fencing was installed in conjunction with the splayed entrance. Work on the pipelines is substantially complete.

Completion of the scheme is due in early 2023. When complete, this scheme will end the discharge of raw sewage to the sea near the pier in Liscannor.

Ballyvaughan Wastewater Treatment Plant:

A new wastewater treatment plant, pumping station including pipework extensions are proposed in Ballyvaughan. Design of the treatment plant and pump station is ongoing and a draft plant layout is being prepared. Draft EIA Screening and NIS have been prepared. A Landscape Architect is working on a design to screen the proposed plant. A Solar PV system is being considered and the sizing required will be based on the power requirements of the scheme. Following on from the planning process and planning approval, construction is anticipated to commence in late 2023 with completion in mid 2025.

Kilkee Wastewater Treatment Plant:

A new wastewater treatment plant, pumping station and rising main are planned for Kilkee. It is planned to continue the use of the existing sea outfall at Intrinsic Bay. Design of the treatment plant and pump station is ongoing. Site walkovers have taken place and preparation of all necessary ecology and environmental reports is continuing. A Solar PV system is under consideration. Following on from the planning process and planning approval, construction is anticipated to commence by Q3 of 2024 with completion in late 2025.

Ennistymon and Lahinch Wastewater Treatment Plant Upgrade:

The site selection report and the feasibility study report are with Irish Water for approval. A single site for a WWTP between Ennistymon and Lahinch is the recommended solution. When the reports are approved the Consultants will then commence work on selecting a location for the WWTP and commence studies on a new sea outfall.

Newmarket on Fergus Wastewater Treatment Plant Upgrade:

It is proposed to construct a new pumped 400mm diameter rising main which would outfall to the Rine River thereby ceasing discharge of treated effluent from the existing wastewater treatment plant to the Lough Gash turlough. Workshop 4 was held on the 12th of July. It is anticipated that the planning application will be lodged in October 2022.

Following planning approval construction is anticipated to commence in early 2023 and be completed by mid-2024.

Kilfenora Wastewater Treatment Plant Upgrade:

Construction is continuing on the WWTP scheme. Process pipework has been installed and testing is ongoing. Hydrostatic testing of the storm tank and pumping station are also complete. Works are continuing on the construction of the percolation areas.

Remedial Action Lists Water Treatment Plant Upgrades

Ward and Burke Construction Ltd have been appointed by Irish Water to undertake the Clare Remedial Action List (RAL) Upgrade contract. The project includes for the upgrade of three plants currently on the Environmental Protection Agency's remedial action list.

- 1. New Doolough Water Treatment Plant This plant is the regional treated water source for West Clare covering the large geographical area in the county and the third largest plant by volume produced. The project will modernise the treatment technology at the plant which will allow it to achieve the desired quality of output during events which cause high turbidity at the source. Works to upgrade filters, and construction of the new sludge thickener and lamella clarifier have been completed. Installation of the new sludge press is complete. Site surfacing and reinstatement works are underway. Testing and commissioning are expected to be carried out in the coming weeks.
- 2. Corofin Water Treatment Plant this plant provides water to the town of Corofin. The project will modernise the treatment processes on site which will enable production of water to the desired standard during high turbidity events in the source lake. Works are nearing completion with the main treatment process now complete and ready for testing with the sludge handling process to be constructed in Phase 2, once the temporary plant is removed. Work is underway to finalise the telemetry system and to detail the testing of the new equipment.
- 3. Ballymacraven Water Treatment Plant this plant provides water to the North Clare Region, including Ennistymon, Lahinch, Lisdoonvarna, Doolin and Ballyvaughan. The project will modernise the treatment processes at the plant as well as bringing the plant production capacity to the required level. Ordering of works materials has commenced and the contractor has mobilised plant to site to commence works.

Rockmount Water Treatment Plant\ Reservoir

These works involve the decommissioning of the existing water treatment tanks and installation of a new concrete storage

reservoir and associated siteworks. The Rockmount area is supplied with treated water from the old Doolough Water Treatment plant and the existing Rockmount plant no longer operates. Additional storage capacity is required to provide network stability and quality of service. Construction of the reservoir is now substantially complete. The anticipated completion and bringing into service of the reservoir is Q3 2022.

Rehabilitation of Watermains

The following watermain rehabilitation projects are currently programmed or underway:

- 1. Shannon Town, replacement of 300mm trunk main along edge of R471 at an Bóthar Mór -under construction
- Lifford Road, Ennis Installation of new main to replace backyard services – at design stage

Clareabbey Wastewater Treatment Plant Inlet & Storm Tank Upgrade Works

Work at this location includes the construction of a new inlet works and screens, and a new storm tank. The inlet works will provide improved screening of materials coming into the plant to both protect and optimise the downstream treatment process to improve discharge standards. The stormwater tank will allow capture of flow during rainfall events for later treatment through the plant. The work will also involve the construction of a new ESB substation. Civil Works on the inlet storm tank and ESB substation are now well advanced. The project is expected to be complete in Q1 2023.

Clonroadmore & Clareabbey Wastewater Treatment Plants

A project has commenced to examine the two wastewater treatment plants serving Ennis to ensure adequate capacity is available to cater for the future growth and development. The output of this stage of the project is a feasibility study report which will inform the decision on the most appropriate option to develop capacity in the plants. The consultant will then proceed to prepare an options report for each plant.

Ennis Drainage Area Plan

This project involves the gathering of all available data on the wastewater network in Ennis and surveying and monitoring of flows in the network. This information will be used to build a hydraulic model of the network. The hydraulic model can be used to model future growth in the town and accurately identify where upsizing of pipework/pumping infrastructure might be required. It will also be used to identify where groundwater is infiltrating into the network adding unnecessary additional loading. It will allow Irish Water to have confidence in obtaining the best value for money on network improvement. The project has been awarded and initial meeting with Council staff has taken place.

Asset Transfer

Following an assessment of the water and wastewater networks in County Clare, 381 sites have been identified for potential transfer to Irish Water to date. Following on site surveys, 64

of these assets have been determined to be non-operational assets which Irish Water will not accept. Of the remaining 317 assets, 209 have now been fully transferred or recommended for transfer to Irish Water.

The 108 assets remaining to be transferred are divided into the following four categories:

• Report prepared / Pending/ Internal Query (14 assets)

These consist of assets for which a report is being prepared or which need further investigation or information /approval from another council section to proceed. At present there are 7 assets under further query and 7 reports ready to issue to Irish Water.

• National Special Projects Office (NSPO) (60 assets)

This is a department within Irish Water dealing with special projects which includes facilitating the Asset Transfers from Local Authorities. The majority of assets in this category are folios under third party ownership but where long standing use and some evidence of previous land dealing is present. Irish Water are now advocating that property in long term operational possession but not in the Council name be obtained by the adverse possession process. Circular L1 2022 has confirmed department support for this approach. All assets which have not yet transferred will be examined to see if they can be progresses using this method.

Property Registration Authority Ireland (1 assets)

At present there are no assets submitted to the PRAI to be subdivided.

• Outstanding assets to be reported on (33 assets)

These are 3rd Party/Unregistered assets. To transfer these, detailed searches through historical Councils records are required in order to submit to Irish Water for their consideration on the best approach to proceed with. Many of the remaining assets have been examined and various routes being explored to close these out.

Rural Water Programme

Under the 2019-2021 Multi Annual Rural Water Programme a contractor has been appointed for the replacement of 4.2km of existing watermains on the Ballycar GWS. Construction is due to commence in late September pending a successful road closure application. Works due to commence on the connection of 6 no. dwellings to the Portdrine GWS is awaiting commencement. Due to the location of the works adjacent to the N18 licences and approvals by the TII are required. The installation of a bulk meter on the Lisdeen GWS was completed in mid August to facilitate the submission of a taking in charge application on behalf of the scheme.

Invitations for the submission of bids for the 2022-2024 Multi Annual Rural Water Programme by the Department of Housing, Local Government and Heritage are still awaited. Engagement continues with GWS's wishing to progress works under the upcoming programme.

The Mountrivers Group Sewerage Scheme (Doonbeg) was submitted by Clare County Council for taking in charge by Irish Water in August. The Rural Water Programme continues to work with a number of GWSs in respect of progressing funding applications to facilitate necessary works for taking in charge applications.

51 no applications have been received to date in 2022 under the 'Grant for Improvement Works to a Private Water Supply'. The Rural Water Team continues to work with group water schemes to ensure their members have a robust and sustainable quality and quantity supply of water available to them.

Measure A8 Unsewered Towns and Villages.

A workshop was held with the Dept of Housing Local Government and Housing on the 15th June and further clarifications on the proposed scheme were issued in July and August from the Department to enable bids to be submitted for funding prior to the September 15th deadline.

Two Ennis based projects have been shortlisted for the *Chambers Ireland Excellence in Local Government Awards* 2022 under the following categories;

Enhancing the Urban Environment: Ennis Public Realm Enhancement - Parnell Street, Lane-ways & Bow-ways

Age Friendly Initiative: The accreditation of Ennis as an Age-Friendly town

The implementation of the 'Ennis Age Friendly Town Strategy' (2021) project has also been shortlisted for the *National Age Friendly Achievement Awards* under the category 'Age Friendly Environment Award (Outdoor Spaces and Buildings)'. The implementation of this strategy continues to be a priority for Ennis MD.

Kayak le Chéile

An access ramp and gate have been installed at the rear of Cloughleigh school to link the school to the river walk, facilitating access to the river for the 'Kayak le Chéile' project which the school is delivering to its pupils.



Public Realm - Clarecastle

Work is continuing on the public realm project, with the overhead wires recently undergrounded by the ESB. The next stages will include, kerbing, paving, public lighting and a road overlay. EMD are engaging with Clarecastle Tidy Towns, preparing for the installation of bicycle stands and a bicycle service station at the plaza.



Clarecastle Sewerage Scheme

Works are continuing on the Clarecastle Sewerage Scheme, laying the rising main between Clarecastle and Clareabbbey [Shareridge on behalf of Irish Water].





Ennis Flood Relief Scheme

The Ennis Flood Relief Scheme, storm water pump maintenance has been carried out in recent weeks. These works will now be included in the annual maintenance programme.

Overlay Works

Recent overlay works have been carried out at Watery Road, Toonagh, New Road, Gort Road Industrial Estate and R458 Flannans roundabout to Clareabbey.



Accessibility/street maintenance

Hedge and branch trimming has been carried out in multiple locations around Ennis over the last number of weeks to ensure accessibility for all using the public realm. Responsibility for maintaining hedges and overhanging trees on private property that may impact public right of ways lies with the landowner.

ECONOMIC DEVELOPMENT



Shannon Estuary Economic Taskforce

The Shannon Estuary Economic Taskforce is meeting on a regular basis. Clare County Council continues to play an active role representing the Local Authorities including Limerick City & County Council, Kerry County Council and Tipperary County Council. The taskforce is scheduled to report to Government by year end.

Moneypoint Site

ESB is exploring the opportunity to repurpose the existing Moneypoint power generating station into a "renewable energy hub". At the moment Moneypoint is a primarily coal-fired power station, with the capability also for oil fired electricity generation. In line with ESB's 'Green Atlantic' vision for the future of Moneypoint, and the harnessing of floating wind energy from the Atlantic Ocean, part of the Moneypoint Station site is to be converted into a floating wind hub in the next number of years. On August 25th the Council's Elected Members and Management Team visited Moneypoint power station and received a number of presentations of power generation, power storage and offshore renewable energy (ORE).

The ORE facility, when constructed, will act as a dual-purpose deployment hub for the deployment of the proposed Moneypoint 1 and 2 wind farms (0.4GW & 1GW respectively). Additionally, it is proposed to develop a 1GW green hydrogen electrolysis facility on site, with electricity supplied by future

offshore floating wind projects. A project of this scale will be significant for the development of the offshore wind industry in Ireland, contributing to the creation of jobs both locally in County Clare and across the rest of Ireland.



Clare Economic Taskforce

The next meeting of the Clare Economic Taskforce is set to take place on the 2nd September 2022 with a continued focus on informing and guiding economic development and job creation in County Clare. Eoin Gavin, CEO of Eoin Gavin Transport and the newly appointed president of Shannon Chamber of Commerce, and Professor Kirsten Mey, President of University of Limerick recently joined the Taskforce and will attend the meeting.

STRATEGIC ECONOMIC INITIATIVES (SEI)

Shannon Town Centre Masterplan

Following the completion of the *Shannon Town Centre Masterplan* (January 2022), the required SEA and HDA environmental assessments were completed in July in addition to graphic design of the final masterplan.

Background work and stakeholder engagement commenced in August on the preparation of an application under URDF which is anticipated to be called by end of year. In addition, background work on number of projects and initiatives identified in the Implementation Strategy for the Masterplan continued, in particular in relation to the proposed One Shannon Hub.

One Shannon Hub

In July, a Design Brief for the One Shannon Hub, prepared over a number of months was completed. The Design Brief was prepared in consultation with the Elected Members of Shannon Municipal District, a targeted number of community stakeholder and followed a technical assessment of the site and comparative developments in Ireland and internationally.

The One Shannon Hub development will combine Shannon MD Civic Offices, an Adaptable Performance Space, Community Library, Co-Working facilities and Workshops on a site identified in the Masterplan in Shannon Town Centre. These facilities will include education and training spaces for local businesses, exhibitions and cultural events. Above all, it will be a meeting space for the local community. It is envisaged that The One Shannon Hub will play an important enabling role and focal point for the further implementation of the overall *Shannon Town Centre Masterplan*.

The Design Brief formed part of the second stage of the procurement process and Tender for an Integrated Design Team for the One Shannon Hub and Public Realm. The final stage of the procurement process is scheduled to be completed with the receipt of tenders in September. It is anticipated the design team of the One Shannon Hub and public realm will be selected in November.

In July, Clare County Council's property unit concluded the acquisition of the leasehold interest in lands at the centre of Shannon town, earmarked for the development of the One Shannon Hub. This acquisition from Shannon Venue CLG represents a significant step forward in the Council's ambition for the Town Centre.

It is anticipated the One Shannon Hub project and associated public realm in the town center will form a significant component of the URDF application referred to above.

Roche Masterplan

Following consultation with the Clarecastle community earlier in the year, and the completion of several environmental reports and assessments including Screening for both Strategic Environmental Assessment (SEA) and Appropriate Assessment, the Roche Masterplan is under preparation. It is anticipated that a Draft of the Masterplan will be ready in early December.

Clare Maritime Training Centre

Following the completion of a funding application under RRDF for the Maritime Training Centre and a subsequent invitation from the Department of Rural and Community Development, a promotional video was prepared as part of the proposed RRDF funding application https://vimeo.com/745361019/26ff5f991e. The proposal to support a maritime training centre in Kilrush formed part of a wider submission from Clare County Council to the Shannon Estuary Taskforce referred to above. Continued engagement with off-shore renewable energy companies and maritime agencies throughout the summer further empahsises the opportunities for a maritime training centre in West Clare to service the existing needs of the maritime industry and in particular the emerging renewable energy and off-shore developments anticipated over the coming years.

FORWARD PLANNING

Clare County Development Plan 2023-2029

The Chief Executive's Report on the 1,015 written submissions received during the Draft Clare County Development Plan 2023-2029 public consultation time period was issued on the 10th July 2022 to the Elected Members for their consideration. The report sets out a summary of each submission and the Chief Executive's response and recommendation for each. A series of informal workshops has commenced with the Elected Members, with five held during the week of the 18th July prior to the summer recess, and workshops will recommence on Thursday 1st September with a further 15 workshops scheduled. The informal workshops are arranged by Municipal

District to facilitate Elected Members to consider those submissions which relate specifically to their respective areas, as well as three workshops for the full Council to consider more strategic policy issues raised. The Elected Members have until late October to consider the Chief Executive's Report and to agree by resolution at a Special Council Meeting any proposed material alterations to the Draft Clare County Development Plan 2023-2029. Any proposed material alterations agreed require the planning authority to determine if an appropriate assessment and/or strategic environmental assessment are required and if so, to specify how long is required for these to be undertaken. This will determine the date for when the proposed

material alternations to the Draft Clare County Development Plan 2023-2029 will be placed on public display for a further period of public consultation, anticipated to be towards the end of the year.

Sixmilebridge Town Centre Masterplan

In December 2021, the Minister for Rural and Community Development announced that Sixmilebridge has been selected as a pilot town under the Town Centre First Initiative to prepare a masterplan for the town to tackle dereliction and revitalise the town centre. Following a tender process the successful tenderer, Allies and Morrison Ltd., were appointed at the beginning of July and on the 12th July an inception meeting was held and site visit to Sixmilebridge organised. This was attended by several members of the multi-disciplinary Design Team from Allies and Morrison Ltd., Tobin Consulting Engineers, Southgate Associates and Repucon Consulting Ltd. as well as Councillors


John Crowe and PJ Ryan and representatives of the Shannon Municipal District Office and the Forward Planning Team. Work has been on-going since the July by way of follow-up to the wealth of information shared during the meeting and site visit. Public consultation is central to the project and the first of three public consultation stages will take place in Sixmilebridge in mid to late September when a Walkability Audit of the town centre will also be undertaken.

The Masterplan, due to be completed by June 2023, will be key to leveraging funding from multiple funding streams, including RRDF and Town & Village Renewal Scheme as it will provide a co-ordinated programme of investment for the town into the future.

Residential Zoned Land Tax (RZLT)

Housing Policy Objective 15.2 of Housing For All - A New Housing Plan for Ireland, 2021, proposed a new tax to activate vacant land for residential purposes as a part of the Pathway to Increasing New Housing Supply. The RZLT, introduced by the Finance Act 2021, will come into effect from 2024 and will be managed by the Revenue Commissioners. The purpose of the tax is to activate existing planning permissions as well as zoned and serviced residential and mixed use lands to increase housing supply and to ensure regeneration of vacant and idle lands in urban locations. The first step involves the preparation of maps which identify lands that fall within the scope of the tax. The Forward Planning Team are currently engaging with stakeholders, including Irish Water and Transport Infrastructure Ireland, in this regard. Draft Mapping will be placed on public display in early November and submissions invited from landowners and the public.

Ennistymon Enhancement Plan

Clare County Council, together with its partners Clare Local Development Company and Ennistymon Town Team, and the design team led by Helena McElmeel Architects continued work on the preparation of the Ennistymon Enhancement plan. A public event exhibiting the enhancement plan was held in the Teach Ceoil on the 12th July. The event was well attended by the community, and the plan was positively received. The design team issued a draft of the final report in August, and it is expected that the final report will be issued in September.



Corofin Enhancement Strategy

Clare County Council and National Parks & Wildlife Services (NPWS) continued in their partnership to prepare an Enhancement strategy for the village of Corofin. The steering group met with the design team in July, where they gave an update on their progress. The first stage of the design process continued into August. The second stage of Public Consultation will be held at the Corofin Community Hall on the 14th September, where the design team will present emerging proposals on the enhancement strategy to the local community and key stakeholders.

The Manchester Martyrs Monument

The Manchester Martyrs Monument in Kilrush is being repaired and restored with grant aid from the Department of Housing, Local Government and Heritage under the Historic Structures Fund. Works progressed well in July, and the restored railings were installed in August. The restoration of the wrought-iron railings was carried out by a historic blacksmith, and the installation of the repaired railings marks a significant milestone in the overall project. Work will continue through September, and it is envisaged that the project will be completed in October.

Flexible Outdoor Structures

Clare County Council has received funding under the Outdoor Public Space Scheme as promoted by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media. This funding stream asks us to reimagine how we use our outdoor public spaces. The project team prepared the tender documentation in July and tenders for the fabrication of the structures were sought in August. It is expected to conclude the tender process in September.



Hastings' Farmhouse, Shannon

Clare County Council and Dúchas na Sionna have been successful in a small funding application to the Heritage Stewardship Fund as promoted by The Heritage Council. The application focused on Hastings Farmhouse in Shannon, a protected structure and a rare building type of historic and architectural significance. The Fund provides support to bodies who have responsibility for the care of heritage objects and those who play a key

role in the heritage infrastructure of Ireland and are vital to the delivery of national policy and plans. The partnership between Clare County Council and Dúchas na Sionna is a key step in safeguarding the heritage of Hastings Farmhouse. This project will look to put in place key structures and frameworks which will guide the future development of this protected structure and to determine a cost plan for proposals developed. A primary goal of this project is to increase accessibility to the site, and works will be undertaken to allow better access for all members of our community. An event was held at Hastings Farmhouse as part of Heritage Week.

An on site meeting with Duchas na Sionna, Clare County Council officials and QS company was held on site on 31st August to examine the key elements of the proposal for restoration.

Clare Heritage Week

Clare Heritage Week was a huge success with eighty-eight events and projects organised, with good numbers attending the wide variety of heritage activities that took place over the nine days of Heritage Week.

The National Heritage Week Awards 2022 are now open for nominations until the Monday 5th Sept @5pm. This year's Heritage Week Awards will comprise the county awards, as well as a number of special categories: National Heritage Hero

Award; Sustainable Heritage Award; Biodiversity Award; Wild Child Award; Water Heritage Award, Sustainable and Inclusive Event Award.

Lisdoonvarna Heritage Plan

Clare County Council in partnership with Lisdoonvarna Failte has appointed a multi-disciplinary team led by Drake Hourigan Architects to prepare a Heritage Plan for Lisdoonvarna, which is funded through the Heritage Council (Clare Heritage Plan Fund) and Clare County Council.

The Plan will look at the heritage opportunities and challenges within Lisdoonvarna and incorporate them into a sustainable Heritage Plan, including the wider Green Infrastructure. The Heritage Plan will identify key actions and projects for future development, together with opportunities to be delivered that will have a positive impact on Lisdoonvarna. This will include the identification of specific proposals for the improvements to the Heritage assets of the study area, including to the public realm, to expand or improve green infrastructure, improved access arrangements, connectivity and linkages. It is envisaged that the heritage plan will feed into the tourism plan and a future masterplan for Lisdoonvarna.

Good communication is part of the ongoing process of heritage awareness, local community participation and involvement and is essential in the process. To this end a public consultation strategy is a key part of the project with review and presentation of the findings to the community and relevant stakeholders during the course of the project. Heritage Week provided a great opportunity to engage with the local community on the project and several community workshops have taken place. A questionnaire has been distributed to the wider community and town walks have been organised, while the first stage in the design process is underway, all very much informed by the outcomes and observations obtained from the public consultation process.

Clare Community Archaeologist Service

Edel Barry is actively involved with communities in Clare, visiting archaeological sites and advising on appropriate conservation work, best practice and access to resources. Edel showcased several important aspects of archaeology in Clare during Clare Heritage Week, including the conservation of old buildings, Holy Wells, High Crosses, Derrainy, Whitegate and its history and a cycling tour of Kilfenora. This role is funded and administered by Clare County Council and co-funded by the Heritage Council.

Clare / Irish Community Archive Network

Several new communities have signed up to join the Clare section of the Irish Community Archive Network (iCAN) which is a portal for community heritage and an archival network in County Clare. The new Clare groups will be involved in training to establish their own heritage websites. In addition they will attend networking events and be involved in further projects and ongoing training on many aspects of heritage and IT. Details can be viewed on https://clareheritage.org/.

The Community Archives Conference 2022 was held in NUI Galway in July. The Community Archives and Heritage Group (CAHG) is part of the Archives and Records Association (UK and

Ireland). Every year it gives awards to outstanding groups and projects to highlight and celebrate their work across the UK and Ireland. The winner of the Gathering and Preserving Category was Scattery Island Heritage Group, Kilrush, which was an amazing achievement given the many other entrants from Ireland and the UK.

Roundabout Shannon Heritage Group gave a presentation on the work and research going on at Hastings Cottage in Shannon at the conference.



Kilrush Collaborative Town Centre Health Check

Fifteen masters' students from Queens University Belfast will be undertaking a Kilrush Collaborative Town Centre Health Check and will be in Kilrush in September to undertake the studies. This research exercise is being completed in conjunction with Kilrush Town Team, the Heritage Council and Clare County Council. All information collected will feed into a Collaborative Town Centre Health Check for Kilrush, which will then be compared to the previous Town Centre Health Check undertaken in Kilrush. The planning students will be involved in detailed land use studies using CHTHC methodology. They will use online questionnaires, foot fall counts, vehicle counts etc. Car parking (on-and off-street) utilisation rates will be recorded across the study area, as well as walkability audits including permeability, legibility and floor scape maintenance and quality will be completed. A consultation with young people from local secondary school as well as interviews will be pre-organised with key actors in the study area.

Quin Heritage Action Plan

The Heritage Officer attended the briefing meeting held to create an action plan to identify some of the opportunities for awareness, interpretation and access to Quin Abbey and surroundings, to provide visitor information and services and to add to the attraction that will help locals and visitors understand, experience and enjoy the cultural and natural heritage of the area while acting as a boost the local economy. This work is funded by LEADER and commissioned by Quin Heritage group.

Clare Cillíní survey

Clare Cillíní survey is continuing with all sites surveyed to date being uploaded the Clare Heritage website.

Clare Wetland Survey

The Clare Wetland Survey tender has been awarded to Wetlands Survey Ireland who are at present gathering further data to guide the direction of the survey work which will begin in the autumn.

Barn Owl Survey

The Barn Owl Survey is coming to completion with an estimated 14 pairs of Barns Owls proved breeding in Clare. This is less than was anticipated. Barn Owl nest boxes will be allocated and erected throughout the county in the coming months.

Review Invasive Alien Species (IAS) Control Measures

Clare County Council have commissioned the expertise of Prof. Joe Caffrey of INVAS Biosecurity Ltd to review Invasive Alien Species (IAS) treatment in the Clare Municipal Districts. This work aims to assist Clare County Council in the treatment and control of Invasive Alien Species and advise where needed. Round-table discussion with Roads staff will take place and site visits to view some of the Invasive Alien Species (Knotweeds and Giant Hogweed) treated sites in County Clare.

Lesser Horseshoe Bat Species Action Plan (SAP)

The Lesser Horseshoe Bat roosts continue to be discovered along the Shannon Estuary at several different locations towards Kilrush, which indicates a spread of their known territory and a positive indicator for the Clare population of this bat species. The Lesser Horseshoe Bat SAP has just been published by National Parks and Wildlife Service and is available now on the NPWS website here: https://www.npws.ie/publications/species-action-plans.Clare County Council are involved in the initial Steering Group meeting for the Lesser Horseshoe Bat SAP and hope to be active in the implementation of this plan.

The film Sammy | A Pine Marten Story

The Heritage Officer attended the preview screening of the film Sammy | a pine marten story, made in Loophead by Tony Whelan of Canola Pictures. It features the story of a pine marten rescued in Loophead and its short life at the Querrin Nature Reserve and of the care and attention it received from all the people who encountered it, among them Trea and Kevin Heapes and Frank O'Neill. It showcases these incredible creatures and their struggle for survival.

CONSERVATION AND BUILT HERITAGE

Built Heritage Investment Scheme

Works to the protected structures allocated funding under the Built Heritage Investment Scheme are ongoing. An updated progress report on works is to be issued to the Department of Housing, Local Government and Heritage on Friday, September 16th. Monitoring of works by the Architectural Conservation Officer are ongoing.



Historic Structures Fund

Works to the protected structures allocated funding under the Historic Structures Fund are ongoing. An interim report on progress works is to be issued to the Department of Housing, Local Government and Heritage on Friday, September 16th. Monitoring of works by the Architectural Conservation Officer are ongoing. Beneficiaries include Killaloe Cathedral & Frawleys Pub, Lahinch.



Community Monuments Fund 2022

Clare County Council was awarded a total of €29,520 under the Community Monuments Fund 2022, under Stream 2. The money is to be used to complete Conservation Management Plans of the three medieval churches of Killofin, Labasheeda, Killchreest, Ballynacally and Templemaely, Ballyallia. A team compiled of architects, environmentalists, engineers and archaeologists has been appointed with the Conservation Management Plans due for completion in mid-October 2022.

- The Enhanced Trading Online Voucher Scheme, which
 provides grant support to small businesses to develop an
 ecommerce website, has continued to see strong interest.
 So far in 2022, thirty-six applications have been approved,
 seven in July and August, while in a further four grants
 were drawn down totalling €8,825.00.
- Mentoring: LEO Clare continue to receive a strong requirement for all of our Mentoring Options including mentoring in Starting a Business, Finance, Digital Marketing, Export Development and Brexit. In July and August, over 25 mentoring applications have been assigned.
- Green For Micro/LEAN/Digital Start: As part of our supports Local Enterprise Office Clare have approved the following supports to help businesses in 2022. This includes 11 Green for Micro applications,10 LEAN applications and 1 Digital Start Application
- Training: Although a quiet period for Training Programmes, LEO Clare held four training courses over the two months which saw 40 participants take part. These included training digital marketing and start your own business. LEO Clare also began planning our 2023 programme with over 50 courses already confirmed.

Digital Start Funding & Google Partnership Commences

LEO Clare along with colleagues in Limerick and Tipperary procured several Digital Consultants to help local businesses to digitalise their businesses via the new Digital Start Fund.

Digital Start is a pilot initiative from the Local Enterprise Office designed to give Local Enterprise Office funded clients that digital edge - from optimising processes to delivering a seamless

digital customer experience, the aim is to help businesses prepare and implement a plan for the adoption of digital tools and techniques across the business.

Alongside this, LEO has also launched a digital learning platform in partnership with Google, "You're the Business", which aims to help business by educating them on how to Get Online, Grow Online and Go Global.

Although both are now open for applications, LEO Clare will officially launch the Programme and the Google initiative on Tuesday October 18th at the Future Mobility Campus in Shannon.

Client Engagement

Local Enterprise Office Clare engaged via our Business Advisors with over thirty of our current and former grant aided clients. In each meeting, clients were made aware of currents supports available to the businesses.



PROPERTY MANAGEMENT

Schools Capital Projects

Under a Memorandum of Understanding with the Department of Education, local authorities acquire sites for some new school development projects. In Kilrush, the Council acquired a site on the Back Road in recent years for a permanent building for Gaelscoil Uí Choimín. A further meeting has been held with the

Department of Education and the Limerick Clare Education and Training Board in August to advance this project to the design stage. Clare County Council has almost finalized a masterplan for the overall site to include the school portion of the site and the remainder of the site.

Property Transactions

The Table below shows the number of property transactions completed by Property Management Unit in July and June, together with the totals for 2022 to date.

We continue to assist many solicitors with enquiries to the Property Management Unit on issues associated with title, boundaries, old leasehold folios etc which is indicative of continuing activity in the property market in the County generally.

Emergency works were completed on the roof of the rear extension to Blake's building in Ennistymon, in order to safeguard the integrity of the building, which is a protected structure. The Council also cleared out some of the waste material in the rear yards, making this a much safer site. All material worthy of retention was retained for re-use, including the flag stones that were on the roof of the extension.

Casual Trading

As events and festival returned for Summer 2022, a number of casual trading licences issued were issued. In the period, a further one was issued for the Willie Clancy Festival in Miltown Malbay and two were issued for the Lisdoonvarna Festival to be held in September. Continued vigilance is needed around the County to ensure that only those with licences are trading in the designated trading areas.

Derelict Sites

To date this year, 46 new derelict site files have been opened and represents a significant effort by the Derelict Sites Team to take action against derelict properties throughout the County. This is the highest level of activity in any one year since the Act was first introduced in 1990/1991. Initial engagement with owners or their representatives is key to resolution of the issues

of dereliction and gaining an understanding of the reasons why the properties are in a derelict stage. A number of owners have brought the properties to the market and some are at 'sale agreed' stage with engagement with the new owners ongoing to ensure they are aware of their responsibilities under the Derelict Sites Act, 1990.

We are also seeing the outcome of sales agreed in late 2021 and early 2022 with planning applications for refurbishment and commencement of works on individual properties. This is not to say that there are not many challenges in dealing with derelict sites as we come across many issues which need to be resolved. However, with time and effort, working with owners, financial institutions and other departments, there are definitely options for positive re-development and revitalisation of many such derelict sites.

The announcement by Government of grant aid for the refurbishment of vacant properties, for occupation as a principal private residence is very welcome. Details of the scheme for towns and villages can be found on the website where you can access all the information on the scheme, frequently asked questions and the application form for the Grants scheme - gov. ie - Croí Cónaithe (Towns) Fund Scheme (www.gov.ie) We have notified owners that we are engaging with and all solicitors

in the County of the Scheme as it may be of interest to them dealing with properties where it may be applicable, particularly first time buyers who are buying and intending to do up vacant or derelict houses in towns or villages for their permanent residence

This month, the improved properties highlighted are in Clonlara village and in St. Patrick's Terrace in Kilkee, where works have been completed or are underway. It is important to recognize the effort put in by the owners to improve their properties.

To date in 2022, the CPO acquisition process is completed on two properties, one in Kilrush and one in Ennis, both of which will now be redeveloped by Clare County Council for social housing. A further 2 CPOs are underway.

On-going Works:

Overlay works in Athlunkard and Sixmilebridge have been completed.

Grass cutting contract has continued with the 11th cut currently under way. Much favourable commentary has been received this year, especially for Shannon.

The second cut and lift of the designated Biodiversity areas was completed in August.

Line marking associated with our Surface Dressing programme has been completed. A number of other locations have had road markings upgraded.

Own crews have commenced works on the Low Cost Safety Scheme Cratloe NS and also on a footpath linking O'Garney Heights to Sixmilebridge which will include an upgrading the path outside the Sixmilebridge GAA pitch to increase capacity.

Bike Rental Scheme

The Bike rental scheme roll out by Co-motion is up and running, initial teething issues saw a temporary suspension of the scheme. These have been worked through with bikes being available again week beginning 22nd August. Approx. 1,000 trips occurred during the first three weeks.

Meelick Active Travel – continuing contact with Landowners. Drainage works at several locations have been carried out. Work has completed on the Bunnabinnia, Cratloe LIS.

Funding for Outdoor Recreation Infrastructure Scheme (ORIS)outdoor projects

The Cathaoirleach of Clare County Council, Cllr Tony O'Brien, has welcomed the announcement of funding of €171k for seven outdoor amenity projects in County Clare. The projects were included in a recent funding announcement (3rd August, 2022) by Minister for Rural and Community Development, Heather Humphreys TD, of almost €6 million to develop 200 outdoor adventure projects across rural Ireland. The Department of Rural and Community Development highlighted that the investment, under the Outdoor Recreation Infrastructure Scheme (ORIS), will be key to enhancing our outdoor amenities such as our walkways, cycleways, rivers, lakes and beaches. It will also provide a major boost to local economies by attracting visitors and furthering our reputation as a destination for adventure tourism.



As part of the announcement, almost €4.3 million will be used to improve some 163 outdoor amenities across the country. Each project will receive up to €30,000 to support their enhancement. Furthermore, funding will also be invested in 37 outdoor projects that are currently at the early stage of development. These projects are to receive funding of up to €50,000. The seven projects in Clare, which will receive a total of €171,132 in funding, are:

- Cullaun Lake Amenity works: Development of a community area at Cullaun Lake, Kilkishen €20,102
- Doon Lake Amenity Development (PDM): Design and planning for development of lake amenity at Doon Lake
 - €22,304
- Ennistymon: Development of a looped walking trail €15,508
- Kilnamona Walking Trail: Creation of a new walking trail adjacent to Kilnamona GAA complex - €28,975
- Kilrush Forest Trails: Link the cycle routes from Kilrush Town Centre and along the nearby coastal roads - €21,207
- O'Brien's Bridge Riverwalk: Improvement to Errina Canal

trail surface in O'Brien's Bridge - €13,036

 River Fergus Walk & Cycleway (PDM): Plan and prepare for River Fergus Walk & Cycleway - €50,000.

Announcing the funding, Minister Humphreys said: "We're at the height of the Summer and whatever the weather I know families are getting out and enjoying Ireland's great outdoors. "The funding I'm announcing today will support the further development of our greenways, blueways and hiking trails making them even more enjoyable places for families to visit. "Every county will benefit from today's announcement so if you're a walker, a swimmer, a cyclist or even a fisherman – check out the list to see what's happening in your county. "Getting active in the fresh air outdoors can be a tonic for the body and soul and this was brought home to us all during the pandemic. "Some of these amenities are often hidden gems on our doorsteps so I'm encouraging people to get out and discover them over the rest of the Summer."



Welcoming the funding for County Clare, Cllr Tony O'Brien, Cathaoirleach of Clare County Council, said: "Seven local projects can now be undertaken in County Clare as a result of this funding announcement. These are projects that can bring

economic and social benefits for the communities in question and collectively they will enhance the outdoor recreational offering in the county. I would like to thank the Minister and her Department for making this funding available and I look forward to the projects progressing."

Director of Rural Development at Clare County Council, Leonard Cleary, said: "Investment in our outdoor amenities helps to promote social interaction and improve the health of our communities. These projects will increase recreational opportunities and will attract visitors to our lakes, trails, walkways and cycleways. The projects will benefit a number of locations in the county."

Minister Humphreys added: "Over the last number of years my Department has provided unprecedented investment in our outdoor amenities, underpinned by our most ambitious rural development policy in decades – 'Our Rural Future'. "Outdoor recreation tourism is a growing sector internationally, and has the potential to have major economic spin-off benefits for our rural towns and villages. "My Department is at an advanced stage of developing the new National Outdoor Recreation Strategy which will underpin this investment and give it a platform for further growth."

Completed CLAR Projects

Works have been completed on 3 CLÁR-funded projects in Killaloe, Kilkee and Crusheen. The CLÁR (Ceantair Laga Árd-Riachtanais) programme is funded by the Department of Rural and Community Development and forms part of the Government's five-year policy for rural Ireland, 'Our Rural Future'. The funding is directed to small scale infrastructural projects in rural areas that have suffered significant levels of population decline.

The works in Killaloe were completed under a 'Community Well-being Measure" and the funding was used to enhance the community allotment and gradens through the purchase of a polytunnel and garden shed. In addition, a potting shed was constructed which doubles as a covered outdoor space in the garden. The garden was also secured by the erection of nylor fencing around the entire perimeter

The works in Kilkee and Crusheen were completed under Measure 1 – Schools/Community Safety Measure. In Kilkee, a new pedestrian crossing was put in place on the busy R487 road linking the Cluan na Mara and Marian Housing Estates and Kilkee Community College. This project was delivered by the

West Clare Municipal District office. In Crusheen, funding was provided to improve the footpath infrastructure at the National School in addition to the provision of a number of other safety measures to cater for the significant volume of traffic at school drop-off times. This project was delivered by the Killaloe Municipal District Office.

Town & Village Renewal Scheme 2020 - Lisdoonvarna Community Park

Works have been completed in Lisdoonvarna Community Park. The project was funded (€90,242) under the Town & Village Renewal Scheme 2020 and is part of a larger project involving the creation of a universally accessible, looped heritage and bio-diversity trail through community owned parklands and the town centre incorporating wellness, exercise, recreation, culture and historical interpretation. The project was delivered by Lisdoonvarna Failte and has resulted in an attractive amenity and recreational space for use by the local community and visitors to the town. Lisdoonvarna Failte previously received funding of €25,000 under the Town and Village Renewal Scheme (Accelerated Measure) which enabled them to create an attractive public meeting space incorporating planting, seating and a heritage focal point within the Park. The group have also submitted an application under the 2022 Town & Village Renewal Scheme for the provision of a bike pump track facility which if funded and delivered will be a flagship component of the regeneration project within the 30 acre community park.

CLÁR funding boost for Clare community projects

The Cathaoirleach of Clare County Council, Cllr Tony O'Brien, has welcomed the announcement of funding of €481,468 for 10 community groups, sports clubs, and schools in County Clare, under the CLÁR programme Measure 1.

These clubs and groups were included in a recent funding announcement (15th August) by Minister for Rural and Community Development, Heather Humphreys TD, of €7.4 million to support 175 community groups across the country. The CLÁR (Ceantair Laga Árd-Riachtanais) programme is funded by the Department of Rural and Community Development and forms part of the Government's five-year policy for rural Ireland, 'Our Rural Future'.

Measure 1 of the CLÁR programme provides funding for the enhancement of existing, and/or the development of new, accessible community recreation facilities. Sports clubs, schools and community groups will receive grants of up to €50,000 to develop a wide and diverse range of community facilities in rural areas with successful projects including outdoor cinemas, astro-turfs, sensory gardens, hurling walls, basketball courts, walkways, public toilets, community gyms, renovations to old handball alleys and much more.

The 10 groups in Clare, which will receive total funding of €481,468, are:

- **Kilkeedy Community Group:** Development of the Kilkeedy Community Playground €50,000
- **Scoil Mhuire Lahinch:** Car Park Enhancement project €50,000
- Kilkee Playground: Enhancement of the Kilkee Playground Facilities - €45,716
- Kilfenora National School: Provision of multi-use games area with fencing and access gate for use by the whole community - €50,000
- Scariff Rugby Club: Provision of Safety Works on the Club Car Park - €35,753

- Kilmaley Meitheal: Development of the Kilmaley Community Walkway - €50,000
- Lissycasey GAA: Development of the Lissycasey Running Track - €50,000
- **Kilmihil People's Park:** Provision of Public Walkway around Astro-turf pitch €50,000
- Tulla GAA Club: Surfacing works on the Car Park including drainage, lining, and lighting at Tulla GAA Club - €50,000
- Crusheen Sports Arena and Community Hub: Development of a Multi-Use Games Area/Astro-turf in Crusheen - €50,000.

Announcing the funding, **Minister Humphreys** said: "Our Rural Future is all about a ground-up approach to rural development. Every community is different and the people who know best what their town, village or parish needs are the people who live there.

"It was for that very reason that I broadened the scope of the CLÁR programme this year to allow for a much wider range of eligible projects. The response from communities across the country has been overwhelming and that is evidenced by the diverse range and variety of successful projects under this year's scheme.

"I am pleased to award funding to a record number of applications this year. This funding will support sports clubs, schools, local development associations and other community groups in developing community facilities which will benefit people of all ages in our rural communities."

Welcoming the funding announcement, Cllr Tony O'Brien, Cathaoirleach of Clare County Council, said: "Ten communities in Clare stand to benefit from the development of facilities being funded under this announcement. The sports clubs, schools and community groups are to be commended for what they are achieving in developing these projects. I would like to thank Minister Humphreys and the Department for making this funding available and I look forward to the projects progressing."

Leonard Cleary, Director of Rural Development, Clare County Council, said: "I am delighted to see such deserving community projects receive funding under the CLÁR programme Measure 1. These projects will allow each local group to develop facilities for the future enjoyment of residents and visitors, creating new recreational opportunities in communities across the county. I would like to acknowledge the commitment and dedication of all the groups involved."

Minister Humphreys added: "I want to congratulate all of the successful applicants and I wish them the best of luck in carrying out these works which will make our rural communities even more attractive places to live, work and raise a family. "In view of the hugely positive response from communities, I am exploring the possibility of providing further funding for a second tranche of projects under CLÁR and I hope to make an announcement on this in the near future."

Cultural Companions visit to SCATTERY ISLAND and VANDELEUR GARDENS



The Cultural Companions Programme is funded annually through the Creative Ireland Fund and is part of the Clare Age Friendly Programme. It is a network of older people interested in attending arts and culture events together as a group. The aim is to provide increased opportunities for older people to engage with Ireland's vibrant arts and cultural scene as well as developing social connections.

In July, the Clare Age Friendly programme took 49 of the Clare Cultural Companions Members on an excursion to Scattery Island and Vandeleur Gardens. They learnt about Saint Senan, who was born in the area and built his monastery in the early

sixth century. The island boasts a mighty round tower, which at 36 metres is one of the tallest in Ireland. St. Senan's biggest legacy is that the River Shannon is named after him.



Built in the early 6th Century, stands 36 metres tall. One stormy night it was hit by lightning and a split occurred in the tower. In 1855 on the initiative of the Catholic Curate of Kilrush, the split was repaired with a grant of £40 from the Limerick Harbour Board.



To the west of the round tower, you can see St Senan's Well. Legend says it appeared when the saint plunged his staff into the ground while praying for water during a drought. The well still features in pilgrimage today, and is visited during the pattern on March 8th, Senan's feast day.

It was said to cure ailments particularly those relating to eyes.

The Head Gardener at Vandelueur Gardens, Karai, gave a great talk about the Vandeleur family who previously owned the estate and were descendants of Maximillan van der Leur, a Dutch Merchant, who settled in Ireland in the early 17th Century. Today the gardens have numerous trees, plants, a labyrinth, a maze, as well as a garden chess set.

CISC and LCETB are collaborative partners on the Clare Ukrainian Response Forum. The visit was attended by Ukrainian volunteers, and representatives from Clare Volunteer Centre.

Rural Development Strategy Draft for September



Clare County Council launched its Rural Development Strategy 2026 in 2017. This Strategy outlined a pathway to revitalised and reinvigorated rural communities across the county. As the Strategy reached its mid-point in 2021 it was important that a review of same took place. This Draft Renewed Strategy is based on the review of implementation of the original Rural Development Strategy adopted for Clare in 2017. The review recommended a renewal of the objectives and targets of the 2016 Strategy to allow the Clare Rural Development Forum to lead out delivery of additional actions to 2026, underpinning the successful implementation of the original strategy. The Draft Renewed Strategy has already been the subject of extensive consultation with key agencies, public participation bodies and the Elected Members of Clare County Council. It is currently available in draft form on the Councils Have Your Say Portal, offering all an opportunity to review the Draft Renewed Strategy 2026 and contribute submissions and comments via an online survey below prior to finalisation and adoption of this Strategy. The survey and questionnaire remains open until Friday 16th September 2022. Following receipt and review of submissions a final version will be prepared with a view to adopting and publishing in Q3.

Autism Awareness Program

Clare County Council was awarded €78,500 from this fund to promote and implement the "Autism Aware County Clare" programme. This multi-level, county-wide training programme will increase awareness of autism spectrum disorder in the wider community. Given that one in every 65 children of school age has an autism spectrum disorder diagnosis, this project has the potential to have a direct impact on a large number of individuals across County Clare. The Rural Development Directorate team have been active preparing a detailed specifications document and project plan around this program. This will be going to tender via the e-Tender process during September with a view to having consultants appointed in Q3 and the program rolled out county-wide in 2023.

Local Economic Community Plan

Clare LCDC will be commencing a process of reviewing the existing LECP Plan in the coming months and preparing a new Six Year Plan for 2023 to 2028. A steering committee is being finalised at present based on the prescribed socio-economic structure. It is expected that the LCDC will go to tender in Q3 seeking consultants to support the review of the existing LECP plan and development of new plan. This will involve wide and extensive engagement with the public and with state agencies, NGOs, and community groups county wide.

Pilot "Engagement" Project during LECP Process

In tandem with the above process, the LCDC in partnership with Clare Local Development Company, Clare Public Participation Network and Limerick Clare Education Training Board will be running a pilot project to ensure greater engagement of marginalised communities in the LCEP process. This portion is being funded by the Department of Rural and Community Development where Clare has been selected as one of four pilot projects nationally and will also receive mentoring support and guidance throughout this portion of the consultation.

Vandeleur Walled Garden



The Vandeleur Walled Garden was the host venue for the wonderful "Voices for Cancer" fundraising event on Friday 19th August, 2022 with all proceeds going to The West Clare Cancer Centre and Milford Care Centre. 



UKRAINIAN SERVICES DEVELOPMENT



Ukrainian Response

In July 2022, the Chief Executive established a new directorate in Clare County Council to respond to the impact of the ongoing crisis in the Ukraine.

The new directorate is led by Acting Director of Services, Jason Murphy with Administrative Officer, Pádraig MacCormaic. New members will be joining the team in September. The team is meeting the various stakeholders both locally and nationally to both fully understand the dynamics of the response effort and inform the next steps.

Background:

The EU Council activated the 'Temporary Protection Directive (2001/55 EC)' on the 4th March 2022 to provide immediate protection in EU countries for people displaced by the Russian invasion of Ukraine. The Directive was subsequently adopted into Irish law through Section 60 of the International Protection Act 2015.

Community Response Forum:

The new directorate will oversee the coordination of all elements of support required for the community in Co Clare through its Community Response Forum. The multi-agency forum includes elected members, Clare County Council cross-directorate services, state agencies, NGOs, and the Community and Voluntary Sector. The Community Response Forum met on 25th August. Membership includes:

Several regional fora are also being put in place to cover regions of the county such as North Clare / West Clare, Ennis and surrounds, Shannon and East Clare. There will be scope for greater representation form local groups to be involved in these regional fora.

Hotel / Hostel Accommodation

There are currently approximately 2,700 displaced Ukrainians accommodated in hotel/ hostel accommodation throughout County Clare across 23 premises covering 12 towns and villages. While it is difficult to be accurate with projections it is expected that these numbers will rise during in the coming month.

As new accommodation is activated by IPAS (International Protection Accommodation Service) the various services respond to settle-in our visitors while seasonal factors also re-focus the response as necessary – i.e., transport and educational needs into September. All agencies are responding as appropriate and there is significant interaction, support, and collaboration between services.

Emergency Rest Centre

Clare County Council operates an emergency Rest Centre which is based in the Quin Road, Ennis, with capacity for 30 people. This facility was developed by the members of the Clare Civil Defence and has proven to be a vital focal point in the County's response efforts: The facility is a credit to the Civil Defence Team and the volunteers who spent many hours building and operating it over the last number of months.

We are currently finalising arrangements for on-going facility management of this service, and we continue to monitor the availability of accommodation across the county.

A second centre is managed and operated through Obair in Newmarket-on-Fergus with capacity for between 10-20 depending on the nature of family units.

Pledged Properties

An initial call for pledged property was made in March through Irish Red Cross. Clare County Council are working in partnership with Mid-West Simon to match Ukrainian individuals and families to approximately 35 remaining pledged properties.

Ukrainian Hubs

The Ukrainian Hub, established and run by 'Mna Ag Gaire' (Women's Shed), has proven very successful in Ennis. It provides a venue for a pop-up shop and is an ideal location for meet and greets, training courses, yoga, art and many other classes and activities.

It has recently been visited by Dept officials and the Ukrainian ambassador. This project has received funding supports from Clare County Council. Working with our Community Response Forum partners we are exploring the opportunities for other hubs in other locations.
