Check the Register

The National awareness campaign which commenced on Monday 6 November highlighted the changes to the electoral registration process and invited the public to engage with the process specifically to either confirm or update their details - including by adding their date of birth, PPSN and Eircode.

This campaign and the campaign led by Clare County Council in October has resulted in a significant increase in the number of individuals, both registering to vote for the first time and those updating their details on www.checktheregister.ie

Business Innovation

The Innovation team, consisting of representatives across all Grades and Directorates, continue to meet bi-monthly to discuss and progress Innovative projects. Several projects are now completed. These include the availability of Energy Awareness kits for rental via the Library Services and provision Beach QR Code at public beaches to access Beach Bye Laws and maps.

Most recently, the Private Rented Inspection team has now moved from a paper-based system to a digitally based tablet system, whereby information gathered at properties is input directly into handheld devices at the inspection location and uploaded to an online database. This innovative measure has resulted in faster inspection times and an increase in the number of inspections completed. An online applications platform is also being developed to streamline various grants and other application processes.

The Communications Office communicates and promotes Council activities and services and raises public awareness of issues of local and national interest. Media releases issued during November included:

ICT

On 15th November, the Information and Communications Technology (ICT) department conducted a presentation with a focus on how ICT is enabling and supporting workers on the move, as well as the ongoing digitisation efforts to replace existing paper-based inspections. The presentation showcased the successful digitisation of processes, including Housing Inspections, Fire Safety Inspections, Traffic Management, and Tree Surveys.

During the presentation, the Housing Inspection team provided an update on how the digitalisation of their inspection process has significantly improved their operations. The digital solution has led to reduced inspection times, improved data quality, streamlined follow-up processes, and simplified records management and management reporting. This update clearly

demonstrated the tangible benefits of embracing digital solutions within their operations.

A key element of the successful implementation was the collaborative development process, which involved partnering with the system users to ensure that the solutions met their specific needs. The active involvement of the end-users in the development process ensured that the solutions were tailored to address their unique requirements.

The presentation generated immediate interest among other sections, leading to requests for four additional solutions shortly after the presentation. The impactful outcomes of the presentation and the subsequent requests for additional solutions indicate a promising impact ICT is having on service delivery. It is anticipated that there will be many more successful showcases of ICT solutions soon, further demonstrating the department's commitment to enabling operational efficiencies and embracing digital transformation.

The presentation on ICT support for mobile workers and the ongoing digitisation efforts was well received, with tangible examples of success in the form of improved operations and immediate requests for additional solutions. The collaborative approach to solution development and the positive stakeholder response further validates the strategic direction of the ICT department. The upcoming showcases will provide additional opportunities to highlight the department's achievements and contributions to the organization's overall success. This report serves as a testament to the ICT department's commitment to innovation, operational excellence, and partnership with stakeholders to drive digital transformation and support mobile workers.



Employee Wellbeing



The Wellbeing Hub was launched with a message from the Chief Executive to all staff. The hub is accessible through the intranet and extranet and is a repository of local and national wellbeing information and events. An updated Staff Census on Disability was undertaken in November. The census is a requirement in accordance with the Disability Act 2005 whereby statistics are compiled and submitted to the Department on an annual basis on the number of staff with disabilities.

Autism Awareness Workshop



A successful in-person workshop exploring autism awareness, acceptance and understanding from individual to group settings took place at The Temple Gate Hotel in Ennis f on Wednesday, November 22nd. The event supported by Clare County Council, was hosted by autism consultant and founder of Get Autism Active Dr Susan Crawford. The event was open to parents, professionals, businesses, and community groups as part of the 'Clare Autism Aware' initiative.



The aim of this free workshop was to ensure people in County Clare receive the opportunity to gain knowledge and skills about autism and especially how to accommodate autistic people to attain their potential. This workshop forms part of ongoing efforts across the county to promote a countywide awareness, understanding and acceptance of autism.

The success and positive engagement of the evening was reflected in that the discussions overran by ninety minutes .Clare County Council's Rural Development Directorate are delighted to support the Clare Autism Aware initiative.

CLÁR Funded Projects

Kilfenora National School MUGA

On Friday, 17th November 2023, the new CLAR-funded Multi-Use Games Area was officially opened in Kilfenora National School. The works were funded with a €50,000 grant under CLAR 2022. The facility will be open for bookings for use by the wider community and will serve as a valuable community spaces in the village.





Cloonanaha National School

CLAR funding of €50,000 has enabled Cloonanaha National School to transform a vacant piece of land adjacent to the local school into a vibrant, educational, and communal space.

The garden serves as an outdoor classroom for school activities and nature-based learning as well as a recreation area for the students and an outdoor meeting space for wider community use.



Lahinch National School

Lahinch National School have completed works aimed at improving car parking arrangements at the school. These works were part-funded by a €50,000 grant under the CLAR 2022 Scheme. The new carparking arrangements provide a safe path for pedestrians, safe parking for staff and a safe passage for students to enter/exit the school.

In addition it is available to visitors to the town outside of school hours thereby helping to alleviate parking shortages within the town at busy time





Kilkee Playground

Works have been carried out in Kilkee Playground with grant funding of €45,000 from the CLAR Grant Scheme. The works involved the replacement of a senior area play piece to a stainless steel, all inclusive, disability friendly unit. Enhancing the Playground is not only a matter of safety but also a commitment to creating an inclusive and welcoming community space.





Pride of Place 2023

Clare has once again excelled in the IPB Pride of Place competition, celebrating exceptional community development initiatives. At the awards ceremony held in Armagh City Hotel, three Clarebased projects showcased their remarkable efforts, gaining recognition for their contributions to community development.

The Winning Projects were as follows:

Tourism East Clare were winners of the Community Tourism

Initiative category. Tourism East Clare is recognised for promoting sustainable tourism development by fostering local relationships and offering unique tourism products and packages. Nominated by Clare County Council, it highlights the region's dedication to sustainable tourism practices.

Common Knowledge's "Rekindle Festival of Lost Skills" received a Special Award for empowering individuals with knowledge and skills necessary for joyful and sustainable living. Their project emphasises the importance of preserving and passing down traditional skills for a more sustainable future.

In addition, **Ennis Men's Shed** were Runners-up in the Community Wellbeing Category. The group were acknowledged for their proactive approach in addressing mental health issues by establishing a modern community facility.

Clare's success in the IPB Pride of Place competition reflects the dedication and innovation of its community-driven initiatives. The awarded projects signify the region's commitment to sustainable tourism, traditional skills preservation, and mental health support, contributing significantly to the region's overall development.

Each of the projects were assessed by judges from IPB Pride of Place during August when group representatives made a formal presentation to adjudicators before hosting tours that highlighted the elements of the community and volunteer efforts of which they are most proud.

Clare Farmers Weaving Stories Together Booklet Lunch & Health & Wellbeing Expo

Traditional farming practices, the importance of the family farm, social isolation, and the advent of online marts are amongst the themes that have emerged in the 'Clare Farmers Weaving Stories Together' initiative. The event was organised and supported by Clare County Council's Healthy Clare, Age Friendly Clare and Creative Clare programmes in partnership with Cuimhneamh an Chláir / Clare Memories, the Irish Farmers' Association (IFA) Clare and the HSE's Mid-West 'Connecting for Life'. Guest speakers on the day included Finola Colgan from Mental Health Ireland's Farming Resilience Project, while more than 20 community, charity and State organisations hosted health and wellbeing information stands at the venue.

Ukrainian Services

The CSO figures show there are currently 5,124 Ukrainian Beneficiaries of Temporary Protection (BoTP's) in County Clare. Approximately 3,688 are accommodated in 34 multi-occupancy facilities located throughout the County. The remaining people are accommodated in residential settings in formal hosted arrangements through the Irish Red Cross and Clare County Council's 'Offer-A-Home' scheme. We currently have 186 homes offered under this scheme, with an average of 3 homes being offered each week. To date our Matching & Relationship Manager has facilitated the accommodation of 354 people that were originally living in hotel and multi-occupancy facilities.

The Department of Housing, Local Government and Heritage (DHLGH) has relaunched the Offer a Home scheme in partnership with the Irish Red Cross appealing to those who have unoccupied properties or rooms to offer them as temporary homes for those fleeing the conflict in Ukraine.

This new call comes as hundreds of Ukrainian people continue to arrive in Ireland each week, seeking safety. A tax-free recognition payment of €800 per month is available to anybody offering a room or property to house Ukrainian people or families.


Since the conflict began, more than 98,500 people from Ukraine have arrived in Ireland. Irish people have been extremely generous in offering many of them accommodation and other community supports. As winter begins and thousands continue to require temporary homes, this appeal aims to encourage anyone who can make an offer of accommodation to consider it.

From the 1st of November to date the Active Ennis Leisure Complex has had a total of 22,800 visitors. The average daily number of visitors is 842 people per day.

Schools & Youth

- Our post-primary sportshall athletics programme is completed for this school year.
- Get Going Get Rowing started in St. Patrick's Comprehensive school in Shannon is concluding this week.
- Primary schools are continuing to borrow playground markings and sportshall athletics packs to roll out in their schools in the run-up to Christmas.
- Our 6-week teen boys programme in conjunction with Spartan Fitness in Ennis will finish this Wednesday Nov 29th. 7 teen boys got the opportunity to experience strength training, boxing and Muay Thai as part of this programme.

Education & Training

- We ran a SG3 course this month. That concludes all our safeguarding courses for this year. We will have next year's courses on the website soon.
- We have Disability Awareness Training workshop online, next Monday December 4th.

Sports Inclusion

- Inclusive gymnastics with Ennis Gymnastics Club is ongoing on Monday and Tuesday evenings.
- Primary School Inclusive Gymnastics is now in week 6 and caters for 130 children with ASD.
- Our 4th Learn to Cycle course of 2023 in conjunction with ENNIS Voices for Autism and Cycle Right has concluded.
- We have started a new inclusive learn to cycle programme with Derg Athletics Club.
- We have started a brand new integrated physical education programme with TY students and students from the ASD hub in St. Caimins Secondary school in Shannon.

Older Adults

- Our Banner Balance programme is ongoing. We have two programmes including 16 participants.
- We continue to support out tutors in delivering weekly classes to over 300 older adults in County Clare.

Active Communities

- Our Healthy DOJO programme in conjunction with the HSE, concluded on November 2nd. We had 24 participants in total sign up to the programme.
- We are into our final week of our Couch to 5k training programmes in Shannon and Kilrush as the attempt their 5k as part of their local parkrun on December 2nd. Almost 90 men, women and children took part.
- Two beginner swimming programmes for female adults in Ennis and Lahinch with 24 taking part has now concluded.
- Two women in sport intermediate swimming programmes has just begun in Ennis and Lahinch for another 24 ladies.
- We supported West Clare Cycling Club to establish a youth section within the club. Over the first three sessions, almost 30 youths have taken part.
- We have had our first session with our new Women in Sport Leadership programme, 22 female sports coaches from 8 different sports are taking part.

Minority Communities

- The membership bursary is still active. We have redesigned the application system to deal with the increase in applications.
- We had a very successful fitness workshop and information stand at Lisdonvarna Wellness Day on November 4th which targeted adult refugees and Ukrainians.
- We are delivering a Winter Wellness programme including dance fitness and yoga classes in the Pavillon in Lisdoonvarna. This is in conjunction with Lisdoonvarna Fáilte
- We are planning our 2024 traveller exercise & sport programmes for both Ennistymon and Ennis.

The Social Directorate continues to face challenges in the remaining months of 2023.

- We are on course, despite the challenges, to meet our Housing delivery targets of 149 units for this year. There are 75 houses completed to date, thereby providing high quality homes to approved applicants on our social housing waiting list. Work on the remainder of these units is at various stages of development.
- We continue to support circa. 80 clients with Notice to Quits in existing private rental agreements. Our staff area actively engaging with these clients to assist them in accessing other housing solutions and to avoid the need for entering homeless services. We are in process of purchasing a number of properties with tenants in situ while AHB purchases are supporting further clients. We continue to provide advice and support to clients who do not qualify for social housing support but may be able to avail of the Cost Rental tenant in Situ program through the Housing Agency.
- Shannon Electoral Area was designated a Rent Pressure Zone from 30th November and this limits rental increases on private rental tenancies to a maximum of 2% per annum. This will hopefully help those currently in private rental agreements with more certainty in relation to future costs. The Ennis Electoral Area was designated a Rent Pressure Zone earlier this year

- Work on the new County Library continues at pace and great progress is now visible on site. This will prove to be a fantastic addition to the town and county and enhance the attractiveness of the town from a visitor perspective.
- The Enhanced Defective Concrete Block [DCB] Grant Scheme went live in mid-July, with the required Department Regulations now in place. The scheme is open and the Councils DCB team are accepting applications online. The Community Facilitator, and other staff, have held a number of workshops in Shannon to assist homeowners with the application process and guide them through the DCB process.
- Expressions of Interest for the delivery of Affordable
 Housing Schemes by developers at Ennis and Shannon
 were advertised this month again and is open until end
 of December. A scheme of priorities for allocating properties should demand for same exceed availability has been
 approved by the Minister, and was adopted by Elected
 Members at the September meeting of the Council. A
 new online portal went live recently at https://affordablehomes.ie/. A number of proposals are currently being
 appraised with one with Dept for approval. It is hoped the
 first schemes will be announced in early 2024.

Social Housing Needs Assessment 2023

The Council has completed the 2023 Social Housing Needs Assessment with over 480 applicants written to seeking updated information to assess their continued qualification for social housing supports. The "count" date was 1st November, with returns submitted to Department and this data will help inform future demand and targets for delivery in the county.


Social Housing Demand - Assessment of housing need

Our greatest demand throughout the county remains for 1 and 2-bedroomed properties. There are 2,120 applicant households (76%) who have a requirement for this property type.

Housing Allocations


Clare County Council continues to work with the Approved Housing Bodies in relation to the provision of social housing. In this regard 3 and 4 bedroomed houses located at New Park Grove, Cappahard, Tulla Road, Ennis which are being delivered by Co Operative Housing Ireland (CHI)were recently advertised on the Choice Based Letting website. This new social housing development attracted almost 300 expressions of interest. As these properties are being provided by an Approved Housing Body i.e CHI Clare County Council nominate the households from the housing list who have expressed interest in this development via the CBL website to take up the tenancy of these properties. Once these household are accepted as a tenant(s) by CHI, Clare County Council deems that the accommodation needs of that family has been met.






In addition, 2 no 3 bedroomed houses located at Doire More, Tulla Road Ennis were recently advertised on the CBL website. These properties were made available by CHI. A substantial number of expressions of interest were received. These properties were made available for social housing under the Part 5 Scheme which allows a local authority to require developers to set aside a certain proportion of new development for social and affordable housing. The Assessment process has been completed and 2 households have been nominated to CHI for tenancy of these properties.








Tenant Purchase Incremental Scheme


Having consulted with elected members in relation to maintaining our newer stock we have agreed that properties purchased or built since 1st January 2016 will not be available for sale under this scheme. 

The Tenancy Enforcement team carry out continued patrols of Local Authority housing estates and Traveller sites and have a very visible presence to manage and mitigate against complaints of antisocial behaviour. The team engage proactively with tenants to help prevent anti-social behaviour and between daily patrols of local authority sites, specific meetings with tenants as well as engaging with local communities representatives they have amassed over 9,000 engagements this year to date. You will note 141 notifications/warnings issued this year and in cases where further breaches occur we will proceeding to next steps in legal process. While one Repossession Order has been granted to date we also have a number of other cases within court proceedings at present. The working hours of the TEO team are flexible to meet required need, involving working after hours and weekends as the need dictates. Traveller Accommodation

The Department introduced a nationwide Pilot Caravan Loan Scheme in 2022 under Section 25 of the Traveller Accommodation Act 1998. The Department have recently issued a circular confirming that this scheme has now been extended to March 2024. Clare families have availed of the scheme in 2022 with more families set to benefit from current 2023 allocation.

Clare County Council continue to progress our Traveller Accommodation Program [TAP] and are currently working with the Traveller Community Development Program in preparing a detailed needs analysis around traveller needs in preparation for the next TAP for which consultation is expected to commence in Mid 2024

Homeless Services [Homeless Action Team HAT]

The demand on the Homeless Action Team within Clare County Council continues to rise. This is evident given the increased levels of support being requested from households around areas such as Homeless Services, Advice and Support and the need for Emergency Accommodation within this region. The impact

of the cessation of the moratorium on eviction/Winter Eviction Ban (Residential Tenancies (Deferment of Termination dates of certain tenancies) Act 2022), is still being experienced by the Homeless Action Team, which includes an increase in the number of presentations, queries and matters arising around Notice to Quits. This continues to have an impact on both Family and Single Households, while also on Family/Single Households that exceed the Social Housing Income Limits.

The demands on the Homeless Action Team surrounding assessments and the requirements for assessments to be carried out, with the appropriate actions or referrals put in place following this remains considerably high. The workload of each staff carrying out assessments has increased significantly with an increased level of complex cases presenting.

In conjunction with this there has been a significant rise in the number of presentations of individuals and households experiencing difficulties and concerns around addiction or mental health concerns, dual diagnosis, physical disabilities, and a further increase in the number of households presenting from the Travelling Community.

Presentations to Clare Homeless Action Team [HAT] November:

During this period there was 480 points of contact to the Homeless Action team. This was made up of 52 new presentations and 428 repeat. A further 3 presentations surrounding general queries. This figure included 284 points of contact regarding single presentations,172 for family households and 10 regarding couples.

During this period within the 42 new presentations this can be broken down to 10 regarding families, 31 new single presentations and 1 regarding a couple. Of the 323 repeat presentations this can be broken down to 124 regarding families, 194 regarding single presentations and 5 regarding couples.

Prevention and support remains a key factor in the workings of the Homeless Action Team. A number of single and household presentations worked with staff around prevention options and supports which in turn prevented the need for Emergency Accommodation and avoiding entering a homeless situation. Advice regarding legislation on NTQ's, support from the HAP Place-finder, allocations in advance of homelessness situations, and other supports offered by the team ensured a number of these clients avoided the requirement of being placed within emergency accommodation. This demonstrates both the hard work of staff along with the positive effect the prevention work employed by the HAT Team, which is an equally imperative part of this team's work.

Other individuals and families were supported in accessing Emergency Accommodation either within our services or through private establishments. However, as Emergency Services and Accommodation remains at capacity with continuous demand for additional capacity, a number of individuals remain overstaying with friends or family until a vacancy presents within Emergency Accommodation.

The Homeless Action Team works with every individual that presents to this service. Unfortunately, during this period there was an increased level of animosity and aggression experienced by the team. This form of behaviour was also experienced by our partner services in Emergency Accommodation where staff safety and welfare has been put at risk. Staff safety within the Homeless Action Team and it's partner services remains paramount.

The Homeless Action Team continues to pursue additional emergency accommodation options. However, this is proving challenging due to competing demands for accommodation in the County. A significant number of providers within the Hospitality Sector have been contacted by the HAT team in an effort to secure alternative private emergency accommodation, however, this was not successful. Reasons for this would include, tourist season, unable to accommodate large family compositions and not willing to engage with Clare County Council.

An advertisement was placed in the Clare Champion in September 2023 looking for expressions of interest from local establishments to provide emergency accommodation. There was no response to this to date. The Homeless Action Team are currently engaging with our Communications Department to readvertise this expression of interest via social media. This is in progress.

Clare Homeless Action team continues to engage with all necessary stakeholders, service providers and local supports in order to adopt a collaborative approach to the tackling of Homelessness.





There has been a very visible increase in presentations to HAT during the month of November.

Affordable Housing Schemes for County Clare

CCC have received approval in principle on foot of a detailed application to DHLGH by CCC, to prove there is potential for affordable housing schemes in both Ennis & Shannon. In this regard, DHLGH have requested CCC to submit detailed applications for specific developments so that CCC can gain access to the Affordable Housing Fund (AHF), through the Housing for All programme. In this regard, CCC launched an Expression of Interest (EOI) Campaign running until the end of December seeking proposals from developers to deliver affordable homes in Ennis & Shannon. This EOI is advertised on various social media channels, local newspapers and also local radio. Also,

CCC has prepared a Scheme of Priorities (SOP) in accordance with the Affordable Housing Act 2021, which has received Ministerial approval recently, and was adopted by the elected members at the September Council meeting. This SOP will be referenced regarding the future allocation of affordable homes. CCC have received submissions from developers through this EOI campaign, which are currently being assessed and will continue to engage with these interested parties in the coming weeks. CCC submitted their first affordable housing submission to the DHLGH in early November, and plan to make further submissions before year end for evaluation by the DHLGH.

Defective Concrete Blocks Grant Scheme

Clare County Council have the relevant staff and systems in place for the administration of the Enhanced Defective Concrete Blocks Scheme. The Defective Enhanced Defective Concrete Blocks Scheme went live in mid-July for private dwellings, with the finalised Act, regulations, updated YQA's (Your Questions Answered) & Ministerial Guidelines published. Applications to the scheme can be submitted on-line through CCC's website with supporting information to further assist homeowners regarding the application process on CCC's website.

In addition, CCC's Defective Concrete Blocks Team are willing to assist with any queries homeowners may have. This Team can be contacted by email at dcb@clarecoco.ie or alternatively by phone at 065-6846385, 065-6846468 & 065-6846309.

CCC have received and a number of applications since the commencement of the scheme, through the online portal and continue to validate applications prior to sending them to the Housing Agency for their review and assessment.

A DCB Community Facilitator commenced employment on the 11th September 2023, to further assist the homeowner's with the DCB application process. CCC DCB Team have also included a video on CCC's website recently on "how to make on application" to further assist homeowners in the application process.

CCC DCB team provided an information meeting on the 21st November last in Shannon Library, to further assist Homeowners on how to make an application to the Enhanced Defective Concrete Blocks (DCB) Grant Scheme using Clare County Council's (CCC) online portal. This information meeting was targeted for people with limited digital resources and/or capabilities, to assist them further in making an application. A second information evening is planned for the 28th of November in the Shannon Library, with further locations to be planned thereafter.

CCC continue to engage with the DHLGH to ensure social houses affected by DCB also are included in a similar scheme. CCC had a meeting in early October with the DHLGH to get information on the upcoming proposed Social Housing DCB Pilot scheme. DHLGH personnel are visiting Clare in Mid-December to view Social Houses affected and to give an update on the proposed scheme.

CCC continue to engage with the DHLGH to ensure social houses affected by DCB also are included in a similar scheme. CCC had a meeting in early October with the DHLGH to get information on the upcoming proposed Social Housing DCB scheme.

New County Library Construction Project

Construction work continues to make progress on the new Clare County Library and Art Gallery building. The external composite cladding panel installation, Level 03 primary structure steel frame and all other reinforced concrete works are now complete. Internal blockwork is also complete, with partitions to be completed on second floor office area shortly. Curtain wall and glazing frames installation is nearing completion. Precast Stairs throughout the building have also been installed. Roofing Contractor is on site with main Library roofing membrane complete, with entrance lobby nearing completion. M&E contractors are making good progress with first- fix and second fix

works for both trades. Plastering is complete on the main external walls and will return when internal partitions are installed. Raised Access flooring on all three floors commenced in early October and is now complete. Other main trades like External Wall Insulation and External Render is now ongoing, with External Cladding to follow thereafter on the external façade and on the 2nd Floor. Ceiling and Internal Wall Partitions trades have also commenced on site and are making good progress. The state-of-the-art new build will provide a key resource for research, study, recreation, and art in a centralised location of Ennis town adjacent to the well-established Glór theatre.











Update on capital programme

Works are continuing to progress well on the housing capital programme, with schemes in Scarriff, Clarecastle and Sixmilebridge under construction currently. Design work is ongoing on a number of other social housing projects, which are at various stages of development.



The final event in the Clare "Decade of Centenaries" programme is an art exhibition by Ennis native Mick O'Dea entitled **Divided Loyalties** showcasing his art depicting the revolutionary years. The exhibition opened in glór on Friday 17th November and will run until 13th January. The launch will take place on Friday 8th December at 6pm.

Local Studies

The Local Studies Centre has added another resource to its collection. Justice in Ireland (1838) is a collection of correspondences between the Irish Government and David John Wilson, the improving landlord who founded Belvoir school, and who resigned as Commission of the Peace over the treatment of tenants. This is a very rare example of a book printed in Ennis in the 19th century, by Marcus Talbot of Church Street and includes inscriptions by the author.

Conservation and listing work on the Barrett Collection is ongoing, the Dunboyne News Cuttings 1824-1878 transcription project is continuing, and the transcription of the 1825 Freeholders list has begun.

Clare Archives

The Archivist is presently on a career break and interviews for the position of temporary Archivist will take place in December. Enquiries will be handled via the Local Studies Centre until the position is filled.

Clare Arts Office

Over 30 applications were received for the "Artist in Schools" Scheme and the "Embrace Arts and Disability" Programme call outs. Partnership meetings took place on the Levelling Access Disability Report, Helium Arts and Visual Artists Support meetings. Support for a Climate Change Arts Project was secured

from the Arts Council and a meeting with a French artist on climate change themes also took place. Three exhibitions took place in Ennis, Scariff and Kilkee and one film was shown in Cultúrlann Sweeney. Clare Arts Office supported the Libraries Decade of Centenaries exhibition by Mick O'Dea in glór. A visit was made to Ennis Men's Shed and a support meeting was held with one artist. Two Arts in Clare slots happened on Clare FM.

The Arts Officer attended the local authority arts officer's conference which comprised of presentations from the Arts Council, research on digital media and festivals, Bealtaine and a workshop on Creative Places. The Arts Officer also attended an Arts and Health day by Creative Ireland and Pobal Community Empowerment training. The Arts in the Community programme continued in St. Joseph's Hospital, Ennis and in Raheen Hospital. Clare Youth Theatre continued in glór and Creative Places in Shannon. PRISM Street Art Works continued in Ennis.

Filming took place at Tulla Stables Studios for RTE's Home Rescue programme.

Clare Museum

The new Winter Lecture series began this month with a talk on the painter William Mulready by Dr Maire Bourke. Talks have been organized from January to April of next year.

The curator gave a presentation at the Limerick School of Art and Design on the "Clare Embroidery" collection. The collection, which is in storage, was taken to the venue and put on display. The patterns and designs were used to inspire participants in the workshop. The LSAD is keen to continue working with Clare Museum and using the collection in the new year. Some cataloguing of the Georgina Frost collection was carried out during the month. Promotion of Clare Museum through the use of information about objects on the website continued during the month.



Progress on Scarriff Rural Regeneration and Development Fund (RRDF)

Progress continues this Category 2 project, with the phase of this element of the overall project near completion. At the November meeting of Killaloe Municipal District, the Elected Members adopted a proposed design for the Enhancement of Market Square and Town Centre of Scarriff under Section 38. This was a significant milestone in the investment in Scarriff of over €500,000 by Clare County Council and Department of Rural and Community Development.

In 2022 RRDF Funding was awarded to undertake feasibility work, obtain planning consent for the overall integrated town centre project in Scarriff comprising of the

- Purchase and renovation of an existing derelict premises in Scarriff Town centre and its conversion to a community Hub and work facility
- Purchase of a greenfield site to the rear, change of use to a car-park associated with the Hub and for car-parking use as part of wider enhancements to Scarriff Town Centre
- Enhancement of public realm of Market Square (town centre) of Scarriff.

The approval of the design for Market Square in November now ensures planning consent for the entire project has been obtained. The agreed Market Square Plan reflects the outcome of a number of months of community engagement with Scarriff Town Team, Scarriff Community Council and members of the public, who have shaped and influenced the project throughout. The design of the public realm was largely based on work and designs and public realm improvements to Market Square, that the had undertaken by Scarriff Town Team and Scarriff Community Council as part of their Scarriff Market Square Plan in July 2022.

Planning consent for these elements are a significant requirement to enable an application for Capital funding under the recently announced Category 1 RRDF call for funding application. The focus now is now on the next stage of the project and that is obtaining further funding to undertake this ambitious project, with an application deadline of February 2024.

Additional Car Parking provision in Scarriff Town Centre

In November and in advance of the busy Christmas season, Killaloe MD secured the provision of additional free 24-hour daily public car-parking in Scarriff town centre, accessed directly from the R352 Mountshannon Road with pedestrian access to Market Square. Killaloe Municipal District has proactively entered into an agreement with a local property owner to repurpose an existing underutilised town centre site to provide free public carparking for 16 cars each day until end of 2025. Business owners, retailers and employees in Scarriff town centre are encouraged to utilise this free carpark for staff car parking.

This proposal is part of a wider Killaloe MD initiative for enhancements to Scarriff Town Centre. This proposal is in addition to the proposed 45 space car-park located nearby in the town centre, and for which planning consent was obtained earlier this year. Development of that 45 space carpark, and a Bus Coach Parking area, is subject to an impending Rural Regeneration and Development Fund (RRDF) application, and subject to funding, is anticipated will commence construction in late 2024 early 2025.



Crusheen Community Meeting

In November, in conjunction with colleagues from Rural Development Directorate, Killaloe Municipal District staff hosted a Community Meeting in Crusheen. This meeting provided an opportunity for the community of Crusheen to consider and discuss the needs of the village, and to identify potential future developments and projects, and how the community can collaboratively work towards achieving these ambitions. Arising from the meeting, staff from Killaloe MD have since commenced project development and a number of initiatives to respond to the issues raised.

Mountain Bike Trail Centre - ORIS Feasibility Funding

In November, funding under the Outdoor Recreation Improvement Scheme was awarded to Killaloe Municipal District, following an application earlier in the year. Feasibility Funding of €50,000 was awarded to examine the potential for a Mountain Bike Trail centre in the Slieve Bearnaghs.

The receipt of the funding follows a successful hosting earlier in April of this year of a National Enduro Series Event in Ballycuggeran and also assists with the delivery of an objective in Killaloe Elected Members Strategic Workplan which seeks to maximise opportunities for recreation in the Ballycuggeran /Two Mile Gate area for mountain biking.



Rural Transport in Killaloe MD

Following the meeting with Irish Rail in May of this year in relation to advocating for the reopening of Crusheen Railway Station, in November TFI Local Link presented an update on the new bus routes in East Clare to the Elected Members and Killaloe MD. Outlining the improved access and availability of routes into and throughout Killaloe MD, TFI welcomed the engagement to date with the Killaloe MD and the proposals and suggestions from the MD to enhancing the bus services to provide socio-economic opportunities for all residents, communities and social services across the MD and to enhance access to the variety of tourism assets and amenity sites in East Clare from around the Country. The meeting concludes a focus by the MD in 2023 on enhancement of accessibility into and around the Municipal District with progress on Killaloe Bypass and Bridge Crossing, advocating for the reopening of Crusheen Railway Station, and enhancement of TFI bus and other public transport services into and around the MD.

- Initial Design Scoping has been completed following site walkover.
- A supplementary Ground Penetrating Radar (GPR) Survey is currently being undertaken to identify risks prior to detailed design.

Connecting & Co-creating Ennis:

Junction tightening works are continuing along Clon Rd with Meadow Court recently completed.

'Safe Routes To School' programme:

- The draft Outline Delivery Plan for St Mochullas, Tulla has been received and an internal review currently in progress.
- The NTA visited the Holy Family National School to go through the preliminary design proposals for the scheme. Discussions are ongoing, it is hoped to progress to the next phase in the coming weeks.
- Construction works will begin at Clonmoney National School Scheme as soon as the contractor can mobilise on site.
- The week-long "School Street" trial for An Gaelscoil Mhíchíl Cíosóg took place in late October and was deemed a great success with the school planning to carry out additional weeks in 2024. This trial will involve students walking, cycling or park and striding to school. A topographical survey in Glenina Residential estate and the green areas around An Gaelscoil Mhíchíl Cíosóg has been carried out. The Safe Routes To School design concepts are now being developed.

Health And Safety

The Trial of the ProWorks Traffic Management Software has been completed with 32 Tablets rolled out to Transportation Staff in each of the Municipal Districts in order to select and record Traffic Management Plans and Safe System of Work Plans at each roadworks site using the ProWorks App. All registered users attended a half days training on the 15th November in the use of ProWorks and the project is now moving onto a monitoring and inspection phase.

The Internal H&S Audit Plan 2023 approved by the Safety Management Committee in order to conduct an Internal H&S Audit of each Directorates Compliance with the Clare County Council Occupational Health & Safety Management System commenced in November and is due for completion by end of December.

CAPITAL DELIVERY / PROJECT MANAGEMENT OFFICE

Progress throughout November on the Major Capital Projects being managed by the PMO is as follows:

Doolin Pier Visitor Services Building

A submission is being developed for the Department requesting the allocation of additional funding to progress this project to Statutory Consent stage. This follows completion of environmental evaluation surrounding land use options, and re-engagement with appointed design team and local landowner.

Ennis Public Realm Regeneration (Project B)

The first phase of the works involving the installation of a new foul sewer at Upper O'Connell Street has been completed on schedule and the section has now been re-opened to facilitate normal Christmas trading activity.

The completion of this phase also represents the first step in the Uisce Eireann (Irish Water) investment in the infrastructure of Ennis involving significant upgrade and replacement works to a large section of the foul sewer running through the Town Centre. We are delighted that these additional works, paid for by Uisce Eireann, are being carried out as they will resolve longstanding legacy issues with the sewer as well as future proofing capacity in the town for many years to come.

Shareridge also completed site investigations at O'Connell Square in recent weeks whereby the information gathered will be used to inform the construction methods to be employed when completing this phase in 2024. Road Closures Notices have recently been issued for works to commence in January 2024, thereby enabling public consultation to commence. Upon approval, these road closures will enable works to proceed at O'Connell Street, and at High Street. Further road closures will be advertised during 2024 to facilitate the works programme and to complete certain foul sewer replacement works in advance of the streetscape works.

The works requirement within the contract obliges Shareridge to have a Public Liaison Officer (PLO) as part of their Team who is based in their Project Office in Ennis Town Centre. The PLO is engaging extensively with affected parties as the works progress and, in advance of commencement of every work phase. The public and traders are encouraged to take every opportunity to meet with the project team to ensure that their needs are communicated, and disruption is minimised wherever possible. The contractor and design team are also convening fortnightly drop-in meetings, as well as issuing weekly progress update bulletins. Affected/interested parties are invited to email ennispublicealmb@shareridge.ie if they wish to be added to mailing list.

As one would expect, there will be some disruption/inconvenience during the works phase experienced but this is unavoidable in major civil and infrastructural works of this nature. It is expected that the longer-term benefits in terms of user amenity and accessibility will far outweigh the shorter-term inconvenience and cooperation and understanding in this regard is greatly appreciated.

Ennistymon Inner Relief Road and Bridge Crossing (Blake's Corner)

The third-party challenge to An Bord Pleanala's decision to confirm the CPO is still before the Courts with the next date for mention being December 11th. On conclusion of same, Clare County Council will determine the next course of action. If the Boards decision is upheld, we will move at pace to progress this much needed infrastructure. Pending same, we are exploring the options available to us in terms of completing the final design and other works not affected by the Court proceedings.

Killaloe Bridge and By-Pass

Work is progressing well across the Project despite the adverse weather and recent extreme weather events experienced by Storm Debi. There is significant body of construction activity currently underway across all areas of the site with a busy schedule of works planned for the remainder of the year.

Kilkee Flood Relief Scheme

Progress continues to be made on the relevant documents required for next year's planning application to An Bord Pleanála. The Natura Impact Statement (NIS) was recently issued by our Technical Advisors and is currently with the Council for review. The Environmental Impact Assessment Report (EIAR) is still on course for completion by year end. The pre-planning application consultation request has been completed and will issue shortly. Clare County Council continue to lead the Project Team in finalising landowner drawings which will enable us to engage further with affected landowners regarding the necessary land acquisition required for the scheme.

Local Infrastructure Housing Activation Fund (LIHAF)

The additional information on the mechanisms that are currently in place to assist in the delivery of housing for the site has been submitted to the Department of Housing, Local Government and Heritage (DHLGH). This, along with updated total scheme cost estimates are in parallel being considered by the LIHAF Section of the Department.

Discussions with the relevant landowners is ongoing regarding the acquisition of the necessary lands for the scheme. It is hoped that all lands necessary can be acquired by agreement however, we may have to consider the CPO process for acquisition of any remaining lands required but this would be our last option. To that end, our Consultants RPS are preparing the relevant maps & schedules for a CPO should the need arise.

Lough Donnell Culvert Repair works

Construction works are now complete and the situation on the ground is being routinely monitored.

N19 Shannon Airport Access Road

The project is currently at Phase 3 (Design and Environmental Evaluation) and a Draft Preliminary Design has been prepared for the Preferred Option identified during Phase 2 of the Project. The issues identified during the Design Peer Review Process along with recent updates to the Cycle Design Manual are currently being considered by the project consultants FTC, with the view of updating the design drawings to ensure that the Scheme is updated to the latest Design Standards in advance of finalisation of the Environmental Impact Assessment Report (EIAR) and any potential An Bord Pleanála Oral Hearing that may arise.

Over the month of November, works continued regarding the EIAR chapter compilation. It is expected that EIAR, along with the Development Consent Application, will be made to An Bord Pleanála in Q2 2024.

Discussions continue surrounding the necessary Land Transfer Agreements between The Minister for Transport, the Shannon Group and Clare County Council.

Quin Flood Relief Scheme

All 40 piles were successfully installed in early November. Testing of same has also been completed and functioning as intended and per design. This has allowed the FRC (Formwork, Reinforced Concrete) contractor to return to site and commence construction of the outstanding sections of wall. Accommodation works including drainage has been completed to the back of two of the affected properties.

Shannon and Ennis Fire Brigades took part in the exercise together with their colleagues from Shannon Airport Fire Service, An Garda Síochána, National Ambulance Service and the Defence Forces Explosive Ordnance Disposal Team. The exercise simulated a cargo plane crash landing after a chemical leak onboard. An Inter-Agency Communications Team participated as part of the exercise including Kennas Fitzimons.

Oil Tank - Safe Check campaign

Oil Tank - Safe Check campaign social media campaign continued over November to raise awareness about the prevention of oil leaks from home heating oil tanks. Our Environmental Awareness Officer participated in a Clare FM Morning Focus interview. In addition the campaign got coverage as a news item on Clare FM as well as The Clare Champion and Clare Echo print and social media outlets.

Clean Air Campaign

A print and social media campaign was carried out during November to promote the Department of Environment, Climate and Communications (DECC) Clean Air Campaign. The public are advised to keep our air clean by using low smoke coal, cleaning chimneys, and reflecting on alternative heat sources.

Gardening

While we are yet to experience the first significant cold snap of winter, the Gardening Team has been fully engaged in their winter maintenance works programme comprising of hedge cutting, pruning, and shaping of trees, together with the other seasonal duties such as weeding and removal of dead vegetation within the numerous pollinator friendly planting spaces.



This important work ensures strong and sustained future growth of perennial plants and to provide pollen and protection for various pollinating insects.

Within the Gardening Nursery during November, works also continued with the planting and establishment of juvenile plants, to ensure that the team can continue to provide colourful planting schemes throughout public spaces in Spring and Summer 2024.

Waste Enforcement

Solid Fuel Regulations and Sampling Programme

As it has been one year since the introduction of the Solid Fuel Regulations, *Air Pollution Act 1987 (Solid Fuels) Regulations 2022*, The Environment Section combined in multi–Local Authority Solid Fuel Sampling Programme of a random representative sample of Solid Fuels on the market in Clare and neighbouring Counties. Following receipt of results from the accredited laboratory, Clare County Council, Limerick City and County Council, Tipperary County Council, Laois County Council, Meath County Council and Offaly County Council will undertake a collaborative approach to the enforcement actions required.

This programme was funded by the Department of Environment Climate and Communications.

Additionally, retailers in Clare have been issued letters reminding them of the new Regulations and obligations with respect to sale of compliant fuels only.

Clare County Council's Environment Section throughout November is implementing an inspection programme, comprising visits to retailers and distributors to raise awareness of the implications of the new Regulations, and to check that stock that does not meet the new technical standards is no

longer being sold. A link to the DECC Clean Air web page with information and FAQs for Retailers, Householders and Haulage companies can be scanned below.



Anti-Dumping Initiative 2023

A claim for €99,565.91 in Anti-Dumping Initiative funding was approved by the Department of the Environment, Climate and Communications (DECC) in November 2023. This has been spent on the following projects:

- Vandeleur Gardens: Inter-agency clean-up
- Mattress Amnesty Days: Held in Kilfenora, Kilrush and Scariff marts.
- **3. Household Hazardous Waste Amnesty Day:** Ballyduffbeg Civic Amenity Site
- **4. Shopping Trollies, Shannon:** A pilot project linking in with Shannon Tidy Towns, Shannon Active Retirement Group and local Councillors.
- Purchase of Solar Compactor Bins and Hallowe'en Cleanups
- 6. Skips were provided by Clare County Council at a location prone to stockpiling and burning waste at Halloween. This eliminated air pollution and reduced the number of Fire Brigade callouts at Halloween.

Environmental Monitoring (Illegal Dumping/Litter)

The Waste Enforcement Team continued to respond to complaints relating to waste and litter. In total, 97 complaints relating to waste and litter were received and dealt with by the Waste Enforcement team in November.

Notifications of Controlled Burning

In total, 10 notifications of controlled burning were received and processed in November, as per the Waste Management (Prohibition of Waste Disposal by Burning) Regulations 2009. The exemption to the provisions of the Waste Management (Prohibition of Waste disposal by burning) (Amendment)

PHYSICAL DEVELOPMENT

Regulations 2022 is due to expire on 30th November 2023. Thereafter, no applications will be accepted or processed.

Historic landfill

The Laboratory team continued monitoring the Kilrush historic

landfill as per requirements of the Certificate of Authorisation as issued by the Environmental Protection Agency. Monitoring of the Whitegate Historic landfill continued in November to obtain base level data in preparation of receipt of the Certificate of Authorisation.

CLIMATE ACTION

Community Climate Action Programme

The Community Climate Action Programme launched on the 6th of December. The application process will be made available through the Clare County Council website from 9:00 am on December 6th and will remain open until 5:00pm on February 28th 2024. The overall objective of the Community Climate Action Programme is to support and empower communities to take direct climate action and the programme provides funding for small, medium and large scale projects. The community-based projects/initiatives will take action across at least one, preferably several, of the following five themes: community and energy, travel, food and waste, shopping and recycling, local climate and environmental action.

Not for profit community groups/organisations who are registered with a PPN or connected with other collectives such as the Wheel, Tidy Towns and /or a community group with Articles of Association or a Constitution, which hold an AGM, and for which approved minutes are available are eligible to apply to this programme.

Of the €572,000 allocated to Clare County Council under phase 1 of the programme, €57,200 is available for to fund small projects up to €20,000, €228,800 is available for medium sized projects valued in the range of €20,000 to €50,000 and €286,000 is available for larger projects in the range of €51,000 to €100,000. In parallel, the Government's Shared Island Fund is providing €3 million for strand 1a of the programme which enables communities and Local Authorities to propose a crossborder project in partnership with organisations in Northern Ireland. The application process for strand 1a will also be made available through the Clare County Council website from 9:00

am on December 6th and will remain open until 5:00pm on February 28th 2024.

The Community Climate Action Programme provides 100% funding for selected projects with the availability of prefunding if required. The key milestones of the programme are detailed in the graphic below. Elected members were briefed on the programme on November 30th.



Biobus

The Climate Action team welcomed the biOrbic team to Co. Clare as part of the national Biobus tour that visited 35 locations around Ireland. The mobile exhibition was a part of a national campaign to raise awareness about the bioeconomy, the part of the economy which uses renewable resources from agriculture, forestry and the marine to produce food,



feed, materials and energy while reducing waste, in support of achieving a sustainable and climate neutral society. Throughout the afternoon, the Biobus was visited by members of the public who had the opportunity to explore the exhibition and discover just how many day to day products have crude oil components and find novel ways of producing the items we need from plants, animals and microbes instead.

Climate Action Plan Development

The Draft Climate Action Plan went on public display on Tuesday October 10th. The closing date for submissions was 4pm on Thursday November 23rd. The Climate Team held five Public Consultation evenings to support information sharing regarding the Plan. The events took place in:

- West Clare MD Kilrush November 6th (5pm to 7pm).
- West Clare MD Ennistymon November 7th (5pm to 7pm).
- Shannon MD Shannon November 6th (5pm to 7pm)
- Killaloe MD Scarriff November 7th (5pm to 7pm)
- Ennis MD Ennis November 8th (5pm to 7pm).

There also was a targeted social media presence to engage with the public with frequent posts on Facebook, Instagram and X.

The total number of submissions on the Draft Plan received by November 24th was 148. This is substantial feedback in comparison to other counties. The work will now begin towards working through these responses in detail and the preparation of the Chief Executives Report for the Elected Members towards adoption of the Climate Action Plan in February 2024.

Energy Awareness

Clare County Council has achieved the ISO50001 Energy Management Accreditation. Staff awareness and engagement forms a vital part of that accreditation and in that regard the Climate Section held a Climate Action and Energy Awareness day for staff in the foyer of the Aras on October 19th. Information was available on the types of renewable energy used by the council in our buildings and well as promotion of the Draft Climate Action Plan. Electric bikes were also showcased which are available for use by the staff.

WATER

Asset Transfer

Following an assessment of the water and wastewater networks in County Clare, 384 sites have been identified for potential transfer to Úisce Eireann to date. Following on site surveys, 71 of these assets have been determined to be duplicate, non-operational assets or assets which Úisce Eireann will not accept. Of the remaining 313 assets, 221 have now been fully transferred to Úisce Eireann. The 92 assets remaining to be transferred are divided into the following four categories:

- Internal Query (10 assets) These consist of assets for which need further investigation or information /approval from another council section to proceed, or sites under transfer via a different section of the council.
- National Special Projects Office (NSPO) (58 assets) This is a department within Úisce Eireann dealing with special projects which includes facilitating the Asset Transfers from Local Authorities. Most assets in this category are folios under third party ownership but where long standing use and some evidence of previous land dealing is present. Úisce Eireann are now advocating that property in long term operational possession but not in the Council name be obtained by the adverse possession process. Circular L1 2022 has confirmed department support for this approach.

- All assets which have not yet transferred will be examined to see if they can be progresses using this method.
- Outstanding assets to be reported on (0 assets) All identified sites have now had reports completed.
- With County Solicitor (24 Assets) These assets are now with the County Solicitor to progress by ordinary transfer or by adverse possession processes.
- A review of assets which were originally determined to be disused is underway.

Rural Water Programme

The Rural Water Team continues to support group water schemes to ensure a robust and sustainable quality and quantity supply of water is available.

The Clare Rural Water Programme awaits the publication of the 2022-2025 Multi Annual Rural Water Programme. This is the leading to frustration amongst the GWS's who have already engaged in the process and have submitted bid details to the Clare Rural Water Programme.

Under the 'Grant for the Improvement of a "Private Water Supply to a House" 75 applications have been received to date in 2023.

New Initiative to Promote One Of Ireland's Rarest Pony Breeds



The Kerry Bog Pony Cooperative Society has teamed up with Bunratty Castle and Folk Park in County Clare as part of a joint initiative to preserve and promote awareness of one of Ireland's rarest breeds of pony. The popular visitor attraction, which already is home to a range of Irish native breeds, has engaged with the Society to secure a pair of Kerry Bog Ponies for its farm.

The Kerry Bog Pony has experienced a resurgence in recent years having declined in numbers throughout the 20th century to only 26 known mares and 6 stallions in 1990. Today there are around 450 ponies with approximately 50 foals being registered each year. Little is known of the origins of the Kerry Bog Pony. The original ponies identified by John Mulvihill were located in South Kerry. Based on their genetics it has been suggested that the ponies could have been imported by the Vikings who had an encampment at Beginish near Valentia Island from the 10th to the 12th century.

"We are very grateful to The Kerry Bog Pony Cooperative Society for the support they have given us in reaching out on social media to pony breeders and owners across the country with a view to securing a pair of ponies," explained **Niall Moloney, Farm Manager at Bunratty Castle and Folk Park**. "One of our primary missions in Bunratty is to increase awareness of native

Irish breeds and how they have formed part of our social and cultural history in Ireland down through the centuries," he continued. "We are looking to expand on our collection of native Irish animals from Droimeann cattle to Irish Wolfhounds and from Irish Red Deer to Tamworth pigs, and, in doing so, help to preserve and promote our heritage."

Tomás Rosengrave, Chair of The Kerry Bog Pony Cooperative Society commented, "We are very excited to have the opportunity to work with Bunratty Castle and Folk Park on this project and in the future on educating all visitors to the Folk Park on our native Kerry Bog Pony while also celebrating its heritage and character. The Kerry Bog Pony is a very versatile breed, makes an excellent child's riding pony but also excels in many equestrian sports such as carriage driving for adults. We are delighted that all visitors to the Bunratty Castle Folk Park Farm will have the opportunity to get know this great Irish breed of pony."

Town Centre First

The Town Centre First Network meeting took place in November in the Tullamore Court Hotel. We await the funding call in early 2024 for new Town Centre First initiatives.

FORWARD PLANNING

Shannon Town and Environs Local Area Plan 2024-2030

The Forward Planning team visited the Transition Year group in St. Patrick's Comprehensive School in Shannon on November 7th. The students undertook a practical workshop with the Forward Planning Team. The workshop allowed the students to develop and demonstrate their insights and perspectives in relation to the present and future of Shannon Town and Environs. The students' ideas and opinions on how Shannon should grow in the future were obtained through the workshop and this feedback will inform the preparation of the Draft Local Area Plan. The workshop involved desk-based mapping exercises with the class, as well as a visit to the nearby Shannon Town Wetlands, where the students met representatives of the Shannon Wetland Restoration Project, and discussed the value of this asset to the town.

Engagement has also progressed with the primary schools within Shannon. Each of the primary schools in Shannon has returned completed workbooks from their 5th and 6th Class groups which had been prepared and issued by the Forward Planning team. The workbooks focus on topics relevant to the LAP and will help to inform the preparation of the Draft LAP. A total of 200 workbooks were completed and returned.

Preparation of the Draft LAP by the Forward Planning Team is continuing during November and December. Specialist consultants have been appointed and are assisting with various aspects of the Plan, namely Strategic Environmental Assessment (Fehily Timoney & Co.), Appropriate Assessment (RPS), Strategic Flood Risk Assessment (JBA) and Transport Accessibility Assessment (AECOM). The combined input from those disciplines will inform the optimal Land Use Zoning and Development Objectives for Shannon Town and Environs, for inclusion in the draft LAP.



Clare County Heritage Plan 2023-2029

Clare County Council is preparing a new Heritage Plan for County Clare. The Pre-draft public consultation phase has concluded, and a draft heritage plan has been prepared. The Draft County Clare Heritage Plan 2024-2030 was placed on public display on 10th November 2023 and submissions and observations are being accepted up to and including the 1st December 2023.

Following this, all submissions and observations received will be considered in the making of the final Heritage Plan which is due to be completed in Q1 2024.



Residential Zoned Land Tax (RZLT)

The RZLT aims to activate existing planning permissions, increase housing supply and promote the regeneration of vacant and idle lands in urban locations. The public consultation phase of the current process has concluded. The final RZLT Map for 2024 has been finalised and will be published on 1st December 2023. The Tax is due to come into effect on 1st February 2025. The first annual review of the RZLT map will commence on 1st January 2024.

Public Realm Enhancements at Cappa Village, Kilrush

The Forward Planning team were successful in securing funding to deliver works at Cappa Village under the Town and Village Renewal Scheme 2022. The project arises from the Cappa Enhancement Strategy which identified key sites to sustainably develop the village while preserving its maritime character and scale. The funding provides for a new connection to be made from an existing recreational amenity to the adjoining coastal walk. This will further usage and increase connectivity with adjoining residential areas while opening up views to the Shannon Estuary. The public consultation process was finalised and targeted consultation meetings took place in November. The design team have initiated the next stage of the design process, which involved integrating the findings of the public consultation process into the project, and this will continue into December.


Public realm works at Parliament Street, Ennistymon

The Forward Planning team were successful in securing funding under the Town and Village Renewal Scheme 2022 to undertake public realm enhancement works at Parliament Street, Ennistymon. This follows on from the Ennistymon Enhancement Plan, where Parliament Street was identified as an area with high potential to contribute positively to the streetscape of Ennistymon town centre. This plan-led project proposes to enhance the public realm offering at Parliament Street to make it a more pedestrian friendly, age-friendly, and accessible street. Helena McElmeel Architects have been appointed to lead a multi-disciplinary design team. The steering group undertook a site visit to Ennistymon with the design team in November. The consultation process will initiate at the end of the month with a consultation event in Ennistymon, and the process will continue into December.

One Shannon Hub

The One Shannon Hub is the key transformational project to emerge from the Shannon Town Centre Masterplan. The One Shannon Hub is located in Shannon Town Centre, and combines a town hall, an adaptable performance and community space, library, and flexible co-working spaces. The new development will also feature public realm improvements to the town square adjacent to the site. BDP Architects and Tom McNamara & Partners will provide specialist consultancy services on the project. The concept design stage is underway, and meetings

were held with the project team and cross-directorate steering group in November. The public consultation process will initiate in early December with a public consultation event taking place at Shannon Town Centre on the 7th of December from 4pm – 7pm. A preliminary design for the One Shannon Hub will be on display and the project team will be available to meet the public to discuss the proposal and to get feedback. The public consultation process will enhance the vision for this important civic and cultural hub for Shannon.

Corofin Enhancement Strategy

Clare County Council and National Parks & Wildlife Services (NPWS) worked in partnership to prepare an Enhancement strategy for the village of Corofin. The enhancement strategy is now finalised and contains public realm proposals in addition to proposing new uses for vacant and derelict buildings. The project reached a significant milestone in November with the submission of a Part 8 planning application for public realm works and the reuse of a vacant and derelict building. A signage plan has also been prepared and this forms part of the submission. In addition to this, representatives from Clare County Council and National Parks & Wildlife Services led Minister Malcolm Noonan on a visit to Corofin in late October. The project team gave Minister Noonan an overview of the Enhancement Plan and undertook a walkabout throughout the village to review the project sites and to give an overview of the visions contained in the plan. This visit was an important endorsement of the Corofin Enhancement Plan.



Kilrush Maritime Training Centre

At a meeting with the Mayor of Halifax during the recent study visit to Canada with respect to the potential establishment of the Kilrush Maritime Training Centre, Cathaoirleach Joe Cooney and Councillor Ian Lynch also raised the absence of a direct flight from Shannon to Halifax as a key priority. Since the meeting, Westjet has announced the return of a seasonal transatlantic service to Halifax with non-stop connectivity to Dublin. A transatlantic flight historically had been in place and its re-establishment, albeit to Dublin at this point, is a welcome development .The return of this service will strengthen the region's critical connections to global hubs, tourism, and business economies. Canada and specifically Nova Scotia is an important market for Ireland, and direct flights play a key role in leveraging these markets. The potential for a direct flight from Halifax to Shannon will remain on our agenda in future discussions with the Mayor of Halifax.

Smart Regions Enterprise Innovation Scheme

A new fund of €145 million was recently announced by Minister for Enterprise, Trade and Employment, Simon Coveney and Ministers Dara Calleary and Neale Richmond. The Smart Regions Enterprise Innovation Scheme is aimed at accelerating economic growth and sustainable job creation across all regions of the country.

The Scheme will be administered by Enterprise Ireland and is already open for applications. Co-funded by the Government and the European Regional Development Fund (ERDF), the funding will capitalise on existing regional enterprise partnerships and complement priorities set out in the nine Regional Enterprise Plans. The Mid-West Regional Enterprise Plan to 2024 for the Mid-West outlines a specific Strategic Objective under Action 5.5 to establish a world class Marine, Renewable, Science and Climate Change Centre in Kilrush. The Clare MEZ project team have therefore commenced discussions with Enterprise Ireland to prepare an application in consultation

with its Regional Manager to close the remaining funding gap for Kilrush Maritime Training Centre.

The overall objective of this Scheme is to drive job creation and enterprise development in each region throughout Ireland. In addition, Smart Regions funding will support the micro and SME client base in strategic regional locations by addressing deficits in key infrastructure. Successful projects will be collaborative in nature, innovative, financially viable, sustainable and will support existing regional infrastructure.

The first call for the Smart Regions Enterprise Innovation Scheme is open for applications and closes on 31 March 2024. Clare MEZ will be preparing an application under Stream 1 which relates to Local Infrastructure Projects with varying investment levels, up to €10m covered by this Stream. The Project Team hope to have an application ready for submission in early Q1 of 2024.

Kilrush - Plouzané Twinning Meeting

Following the successful visit by the French Ambassador to Ireland H.E. Vincent Guérend, on the 10th of October, and building on the introductions made by the Honorary Consul Dr Loic Guyon to the Mayor of Plouzané and the Twinning committee in France, Clare County Council attended what is hoped will be the first of many calls and discussions between the Kilrush and Plouzané Twinning Teams.

A Zoom meeting was facilitated on the 7th of November to engage both teams in the reestablishment of the twinning between Kilrush and Plouzané. The meeting was attended by representatives from the European Institute for Marine Studies, the organisers of Sea Tech Week in Brittany in October 2024, the Irish Whale and Dolphin Group, Kilrush Town Team, Clare County Council together with members of the Plouzané Twinning Committee. The meeting was a significant step forward in strengthening the twinning relationship between Kilrush and Plouzané. The meeting served to build connections and establish mutual benefits to groups on both sides of the Atlantic and with our nearest EU neighbour. It is anticipated that bi-lateral meetings will be held over the coming months between the various sub-groups involved in the call.

Marine Spatial Planning Saoirse Wave Energy Project

The proposed Saoirse Wave Energy Project, is being jointly developed by ESB and Simply Blue Group. This will be a pioneering 5MW wave farm array, located approximately 4km off the County Clare coast, Northwest of Doughmore Bay as outlined below. This project is a wave energy demonstration project which aims to prove the viability of wave energy in Irish Seas. The project was pre-selected for €39.5 million funding by the European Commission's Innovation Fund programme in July 2023. The EU Innovation fund is targeted at supporting pilot projects for technology solutions that can reach considerable scale and make a significant contribution to decarbonization. The chosen technology for deployment is Corpower Ocean's Wave Energy Converter (WEC). The Corpower Video is available at https://www.youtube.com/watch?v=9qu2Olw4-p8 and


the Corpower website is at <u>CorPower Ocean - Wave Power. To</u> Power the Planet.

The project commenced initial early-stage development in 2020 and has undertaken considerable engineering and environmental assessments alongside stakeholder engagement through the period to date. The project has the capacity to power 3,500 homes and will displace 10,868 tons of CO2 per year. The awarding of the Innovation Fund is the largest award to Ireland through Innovation funding and is recognized as the biggest award to a wave energy project to date. This project

represents a significant opportunity for Ireland to lead on an international stage in the deployment of wave energy at scale and for County Clare to once again be world class leaders in energy generation. Following a briefing to the Council meeting on the 13th of November the Forward Planning team of the Economic Directorate are meeting with the Department of Housing Planning and Local Government with a view to establishing a mechanism for the timely preparation of a West Coast of Clare DMAP - Designated Marine Area Plan to incorporate the potential for Wave Energy.

CONSERVATION AND BUILT HERITAGE







Built Heritage Investment Scheme (BHIS)

The 2024 round of the Built Heritage Investment Scheme was announced on 2nd November 2023. The Scheme is designed to assist with the repair and conservation of structures that are protected under the Planning and Development Acts. In certain cases, the scheme also supports the conservation of structures within Architectural Conservation Areas (ACAs) where, in the opinion of the local authority, a need for works to enhance the character and appearance of an ACA has been demonstrated. The primary purpose of the scheme is to support privately owned properties in need of repair and conservation. Projects that incorporate a traditional skills training element may also be supported by this fund. Any such projects must be agreed in advance by the Department.

The grants scheme operates on a 50/50, grant/match funding basis. The minimum funding awarded for successful projects will be €2,500 (works value of €5,000) up to a maximum of €15,000 (works value €30,000). Clare County Council will put an assessment process in place to determine which applications are eligible to go forward for funding. Priority will be given to small-scale, labour-intensive projects. Projects should demonstrate a range of conservation skills and will not be concentrated in a particular geographical area or on a particular type of structure.

Historic Structures Fund

The 2024 round of the Historic Structures Fund Scheme was announced on 2nd November 2023. The primary focus of the Fund will be on conservation and enhancement of historic structures and buildings for the broader benefit of communities and the public.

There are four streams of funding under the HSF:

- Stream 1 will offer grants from €15,000 up to €50,000 and is aimed at essential repairs and smaller capital works for the refurbishment and conservation of heritage structures. The grant can cover up to 80% of eligible cost.
- 2. Stream 2 Historic Shopfronts sub-stream For essential repairs and small capital works for the refurbishment and conservation of historic shop facades, windows, signage and other associated details to safeguard them and keep them in use. The grant can cover up to 80% of eligible cost.
- 3. Stream 3 will offer a small number of grants from €50,000 up to €200,000 for larger enhancement, refurbishment or reuse projects involving heritage structures. A grant of over €200,000 may be awarded in exceptional circumstances

where a case is made by the applicant in relation to the significance of the project and the works proposed.

4. Stream 4 - Vernacular Structures Stream - The purpose of the stream is to support conservation repairs and small capital works to vernacular structures that are not listed in local authority Records of Protected Structures or otherwise legally protected.

Community Monuments Fund (CMF) 2024

The 2024 round of the Community Monuments Fund was announced on 16/11/2022. The Community Monuments Fund (CMF) is investing essential capital in our archaeological heritage to help owners and custodians of archaeological monuments safeguard them into the future for the benefit of communities and the public. The Fund is available for structures on the RMP

(Record of Monuments and Places). It must be noted that the CMF covers 100% of the cost and requires no match funding.

There are three streams of funding under the CMF:

- Stream 1- Grants up to €100,000 for essential repairs and capital works for the conservation of archaeological monuments.
- Stream 2- Grants of up to €30,000 for the development of Conservation Management Plans/Reports and detailed Specification of Works aimed at identifying measures for conservation of archaeological monuments and improving public access.
- Stream 3- Grants of up to €30,000 for the enhancement of access infrastructure and interpretation (including virtual/ online) at archaeological monuments.

'Winter Wildlife Talks' series - Biodiversity

Clare County Council's Biodiversity Officer, in conjunction with Clare Libraries organised 'Winter Wildlife Talks' series during November at Kilrush Public Library and De Valera Public Library Ennis. Four separate talks were given to children, adults, and community groups. John Lusby, Raptor Conservation Officer with BirdWatch Ireland, gave two talks in relation to the ecology of barn owls at Kilrush Public Library.

On the 23rd of November, Dr Kate McAney, Ireland Mammal Programme Manager of the Vincent Wildlife Trust, gave two talks at De Valera Public Library in Ennis, and spoke about the ecology of bats and projects the Vincent Wildlife Trust have been involved in particularly conservation efforts for the lesser horseshoe bat.





The talks have generated significant interest and interaction on social media and appeared on local print media (Clare Champion and Clare Echo)

The next talk will be given by Clare County Council's Biodiversity Officer Barry O'Loughlin on the 5th of December at Sean le Mass Public Library Shannon. Barry will give a presentation on peatland restoration methods, funding sources and county wetland inventory surveys. He will outline the benefits of ecosystem services associated with rewetted peatlands and wetlands for biodiversity, climate, water management and local communities.

School Visits - Biodiversity

Along with members of the forward planning team, the Biodiversity Officer visited transition year students at St. Patrick's Comprehensive School Shannon to carry out a workshop on sustainable town planning which incorporated biodiversity as part of student engagement under the Shannon Town and Environs Local Area Plan 2024-2030. The workshop helped students identify biodiversity within Shannon Town and informed students learning to identify ecological constraints around town planning.

In late November, Clare County Council's Biodiversity Officer and Environmental Awareness Officer visited CBS Primary School Ennis. Teachers at C.B.S. Ennis organised a Green Schools Day of Action as part of their awareness-raising efforts, including a Biodiversity parade, performed their school Green Code, and carried out other biodiversity-related activities. CBS Ennis was one of the schools that recently participated in the 'Clare Schools Biodiversity' Initiative workshops organised and coordinated by Clare County Council's Biodiversity Officer.

Irish Garden Bird Survey

In late November, Clare County Council's Biodiversity Officer and Employee Welfare Officer have teamed up to sign up council staff to participate in the Irish Garden Bird Survey. Council office headquarters on New Road and De Valera Library Ennis will be surveyed as part of this initiative.

National Invasive Species Management Plan – Limerick Stakeholder Workshop

Clare County Council's Biodiversity Officer Barry O'Loughlin attended the National Invasive Species Management Plan stakeholder workshop in Limerick. The National Parks and Wildlife Service are working to develop a National Invasive Alien Species (IAS) Management Plan. This work is being supported by the National Biodiversity Data Centre, a steering committee of relevant state agencies and other sectors .

Following the two workshops, NPWS and NBDC will integrate feedback into a collaborative draft version of the national plan. Invasive alien species are recognised as one of five key drivers of biodiversity loss globally alongside climate change, habitat loss, overexploitation, and pollution. Recently, the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES) published a landmark assessment report on invasive alien species. Their findings identified that IAS have been a major factor in 60% of species extinctions and the direct cause of 16% of global animal and plant extinctions. They also found that species introductions have quadrupled every decade since the 1970's and a further 36% increase is anticipated by 2050 if action is not taken to curb their introduction and spread. In Ireland great efforts are being made to address the threat of invasive alien species by a diverse range of stakeholder groups including practitioners, government departments, state agencies, local authorities, eNGO's, businesses, volunteer networks, community groups, researchers and experts.


Shannon Dolphin Project

The Irish Whale and Dolphin Group have completed a range of communication work packages that was successfully funded by Clare County Council and the National Parks and Wildlife Service (Department of Housing, Local Government and Heritage) through the Local Biodiversity Action fund (LBAF). The LBAF Shannon Dolphin Project was funded by three local authorities (Clare, Limerick and Kerry) and aims to share the knowledge gained demonstrating the estuaries (Shannon) uniqueness in supporting a unique dolphin population. The

Bottlenose Dolphin is a qualifying interest of the Lower River Shannon SAC. The project involved the publication of a Shannon Dolphin Book by the Irish Whale and Dolphin Group; outreach to schools (along the Shannon Estuary), production of a short film; exhibition of Images by John Coughlan; creation of Shannon Dolphin Story Boards; undertaking a Dolphin Bio Blitz; production of Shannon Dolphin podcasts; and an event held for interested stakeholders in Limerick 'Shannon Dolphin Seminar' and the compilation of a seminar report. In late September, Clare County Council's Biodiversity Officer was in attendance at the book launch to support the Irish Whale and Dolphin Group. The event was launched by the Minister of State for Heritage and Electoral Reform, Malcolm Noonan.

Quagga Mussel - LBAF Project Results (Invasive Species)

Clare County Council along with nine other local authorities funded research into the expansion of the quagga mussel within the Shannon system. The project was also funded by the National Parks and Wildlife Service (Department of Housing, Local Government and Heritage) through the Local Biodiversity Action fund (LBAF).

The project focuses on the quagga mussel (*Dreissena rostri-formis bugensis*), a high impact invasive alien species discovered in the Shannon in 2021 and in 2022 was shown to be spreading and increasing rapidly. In 2023, Clare County Council provided

funding to researchers with University College Dublin (Invasive Ecology Laboratory) to carry out surveys along the Shannon system to monitor the expansion of mussel populations. Extremely high densities were recorded in Ballina, which are the highest densities detected in Ireland other than those attached to boats. In many sites along the length of the river, quagga mussel now constitutes more than 80% of the mussel density, suggesting zebra mussel may be entirely outcompeted in this system over the next few years.

Sites in Lough Derg surveyed in 2021 & 2022 were again surveyed in 2023. The results indicate that the quagga mussel is in its exponential growth phase (as it is in many parts of the Shannon) and has increased its distribution and density significantly over this short period of time. The 2023 results also demonstrated that Quagga mussels regularly attach to boats which can move substantial distances and are likely to play a significant role in the spread of the Quagga mussel. Biosecurity is seen as a vital step in preventing and reducing the spread of quagga mussel attaching to boats through checking and cleaning equipment.

Lands At Ballaghafadda, Kildysart Road, Ennis

An advertisement was placed in November seeking expressions of interest for these lands with a focus on sports and recreational uses. The Council's aim in respect of the property is to facilitate development of the following (a) additional sports and

recreational activities and facilities in the Ennis / Clarecastle area and (b) a project which adds value to the recreational and sporting use of the site (or part of the site) while allowing space for amenity projects to be also developed on the site. The closing date for same is 8th December.

Casual Trading

As we come to the end of the year, the licences to be issued between now and year end will be for Kilrush Horse Fairs on various dates and some Christmas related events. Two licences were issued in November and one application was refused.

DERELICT SITES

The Derelict sites team are currently dealing with 255 properties that are considered derelict, an increase of 3 properties since last month. The activity in recent years has substantially increased with 69 derelict properties identified and reported on in 2022 and to date in 2023, we have opened files on 55 new properties. Initial engagement with owners or their representatives is key to resolution of the issues of dereliction and to understand the various reasons why the properties are in a derelict stage. The level of activity in the property market for vacant and derelict properties has increased and of the properties we have identified as derelict, a number of them have been brought to the market and some are at 'sale agreed' stage. We continue the engagement with the new owners of those properties to ensure they are aware of their responsibilities under the Derelict Sites Act, 1990.

We are also seeing the outcome of sales agreed in recent months, with planning applications for refurbishment increasing and works commencing on individual properties. We are advising property owners of the vacant property refurbishment grant , where they are suitable for residential use. The amalgamation of the Vacant Homes Team and the Derelict Sites Team earlier in 2023 is accruing benefits. With time and effort, working with owners, financial institutions and other departments, there are definitely options for positive re-development and revitalisation of many such derelict sites.

Compulsory Acquisition of Derelict Sites (CPO)

The Department of Housing, Heritage and Local Government has launched a CPO activation programme for local authorities and has set targets for CPOs for each local authority. We commenced this programme in 2022 and the Table below sets out the status of those CPO's commenced in 2022 and 2023 to date.

In addition, the Urban Regeneration and Development Fund will provide funding for CPO's on a rolling basis in the town of Ennis with the objective being that these properties would then be sold on the open market. A particular emphasis will be on properties that have potential for residential use.

Derelict Site Levy

Determination of valuations on the derelict sites which are on the Derelict Sites Register has commenced and notices have issued to four property owners. One of these has appealed the valuation to the Valuation Tribunal and a decision is awaited. The levy is an annual levy while the property remains on the Derelict Sites Register and amounts to 7% of the value of the property, on an annual basis. This will be further progressed in 2024.

Survey of Vacant and Derelict Properties

The Team is currently carrying out surveys of vacant and derelict properties in towns and villages around the County. Based on the Geo-directory data, the Department of Housing, Heritage and Local Government has asked the Council to validate the data that they hold. To date almost 800 properties have been surveyed, with the data being uploaded digitally and there are a number of towns and villages yet to be done. The data collected will be the basis for future policy direction by the Department and will guide the work programme of the Derelict Sites Team and the Vacant Homes Team.

Key items to note include:

- The processing time for applications has reduced with additional resourcing to the Team. Technical inspections are being undertaken on a weekly basis.
- The percentage of the total applications to be made available for rental remains reasonably constant at 25% / 26%.
- Since May 2023, the time period for completion of works is 13 months from the date of grant approval and this may be challenging for applicants to achieve.
- The revised maximum grant amounts introduced in May 2023 are being applied to all existing approved applications.
- We have processed our first payment under the Grant, including the signing of the Deed of Charge. Two further payments are being processed at present following completion of works.
- The applications in rural areas account for 57% of all applications and those in towns and villages account for 43%.
 This has remained fairly consistent since the grant was introduced.

Full details of the scheme and eligibility criteria are published on the Council's website. We continue to meet individual owners to guide them through the process and to ensure they have all the documentation when submitting their application.

Based on the applications received and the revised grant levels, there is a potential investment of €6 to €7 million by Government in the refurbishment of vacant and derelict properties in County Clare to be returned to economic use as permanent homes.

People's Park Clarecastle



Clon Road Business Park New Footpath

Ennis MD have commenced work on a new footpath to provide safe pedestrian access to Clon Road Business Park. This project was funded by Elected Members using GMA funds. The scheme also involves a new pedestrian crossing at the junction of Clon Road, new public lighting and the relocation of an existing boundary wall.

Ennis Public Realm Update

The first phase of the works involving the installation of a new foul sewer at Upper O'Connell Street has been completed on schedule and the section has now been re-opened to facilitate normal Christmas trading activity. Works are intended to recommence on site on January 8th 2024.

Ennis Transport Plan Update

Systra Ltd have been appointed to undertake the Area Based Transport Assessment (which will form part of the upcoming Local Area Plan for Ennis). A Baseline Assessment of the Plan and Surrounding Areas is being undertaken with the first round of public consultation currently underway. Ennis Municipal District are seeking feedback on how local residents, students, workers and visitors currently travel to and around Ennis, to identify what would make travel easier for people including journeys made by foot, bike, public transport and by car. This will help us understand the challenges and opportunities facing users of the transport network in Ennis and will inform the development of the Ennis Local Transport Plan. The closing date for submissions is the 7th December 2023.

Tulla Road Cycle scheme

Detailed design is underway on this project, this is being undertaken by AECOM Consulting Engineers.

Limerick Road (incl. St. Flannan's Drive) Cycle scheme

Contract signing took place on the 7th November with Tobins as the Consulting Engineers. Concept design and route option selection is progressing. Traffic Count Surveys are being undertaken at a number of key junctions along the proposed route. This data will help inform the correct design parameters to be followed for the scheme.

Public Bus Service Update

Ennis MD continue to liaise with the National Transport

Authority to deliver this important infrastructural project which is projected to commence in Q1 2025.

Francis Street

Presentation of proposed scheme to Council Members on 28th November 2023. An application for 39 affordable homes is being prepared in conjunction with the Housing Department for submission to the Department.

Abbey Street

The concept design is being finalized with public consultation expected during Q1 2024.

Harvey's Quay

A concept design for this location is being finalized with public consultation to follow.

Post Office Field Masterplan

This is a key amenity and biodiverse area located in the centre of Ennis Town. Draft Master Plan completed to be brought forward for stakeholder consultation.

Urbact IV Action Planning Networks 2023-2025

The Lead Partner and Lead Expert from the project 'Econnecting - greener & closer communities', visited Ennis on November 1st. Various sections of the Council presented on current and future plans in terms of mobility projects in Ennis. Representatives from TFI and the NTA public bus service presented also.
