



HEALTHY CLARE

Community Recognition Fund

Limerick and Clare Education & Training Board (LCETB) was awarded €23,800 under the Community Recognition Fund 2023, aimed at enhancing community infrastructure in appreciation of local efforts to support arrivals from Ukraine and other countries.

The funding facilitated the development of the allotment space at Hastings Cottage, Shannon. Investments included the installation of a polytunnel, garden shed, raised beds, and essential gardening tools. These improvements have supported the delivery of horticulture-related classes for local learners, covering areas such as winter gardening, potting, and plant recognition. Programmes offered on-site are certified at QQI Levels 1 to 3.

A key highlight was the Celebration of Learning event held in May at the Hastings Cottage allotment. The event marked the progress and engagement of learners and staff, drawing over 50 attendees including. Conor Leyden, Rural & Community Development Officer attended on behalf of the Rural & Community Development Department. The event showcased the positive impact of the facility and celebrated the inclusive educational environment fostered through this initiative.



Building Blocks Capital Funding

The Building Blocks Capital Funding to support Community Childcare facilities was announced on Monday 19th May 2025, with four successfully applicants being awarded in Clare, with the Rural & Community Department playing its part in helping strengthen their application's before they were submitted to the department.

The successful projects are as follows:

- Lisdoonvarna Cois Ceim Childcare, was awarded €500K (to generate 27 new places.
- Obair New Market on Fergus, were awarded €500K, (to generated 27 new places)
- Little Rockers Boston, awarded €428,894 (to generate 20 new places)
- Loughgraney Kids Corner, were awarded €189,989 (10 new places)

Launch of Not Around Us in Clare Co. Council Playgrounds



During the month of May, to recognise World No Tobacco Day, Healthy Clare and Clare County Council have come together to place 'Not Around Us' signs across all local authority playgrounds. 'Together, we're creating a safer, smoke-free spaces in sport, in playgrounds, in any place where children gather across the county.'

"Not Around Us", is an initiative supporting people and spaces to work towards a Tobacco and Vape Free Clare by promoting environments where it is easier for those who smoke to quit and stay quit and to help de-normalise smoking for the next generation. The campaign is in response to the government's national target for a less than 5% smoking prevalence in Ireland by 2025.

Speaking at the local launch Bernadette Haugh SEO, acknowledged Clare Comhairle na nÓg's coordination of the short film on period dignity entitled 'It should be like toilet paper" noting that feedback has been overwhelmingly positive, and it's clear that the key messaging and content of the production has resonated strongly with young people and the wider community. National Older People's Convention May 8th & May 9th hosted by South Dublin in Tallaght.

From May 7th to May 9th, 2025, four representatives from Clare Older People's Council had the incredible opportunity to attend the highly anticipated South Dublin Older People's Council Convention in Tallaght, Dublin. Supported by Clare County Council and the Clare Age Friendly Programme, their participation in this inspiring event reflected a shared commitment to celebrating wisdom, experience, and the invaluable contributions of older people in shaping society.

This year's theme, "The Wisdom of Years – A Lifetime of Perspective," set the stage for two days of engaging discussions, thought-provoking insights, and powerful reflections. The convention opened with the charismatic Brendan Courtney serving as Master of Ceremonies. He captivated the audience by sharing heartfelt stories of his own family's experiences with positive aging and navigating challenges related to ill health.

A lineup of esteemed speakers brought their expertise and vision to the forefront, addressing key issues affecting older people today. Minister Kieran O'Donnell TD, Minister of State at the Department of Housing and Older People, emphasized the importance of enabling individuals to remain within their communities. He also highlighted ongoing efforts to develop a national rightsizing policy and a new, forward-thinking national housing strategy.

Health and well-being were central topics, with Prof. Ronan Collins—Consultant in Geriatric & Stroke Medicine and South Dublin's Age Friendly Ambassador—delivering an enlightening talk on Brain Health and Stroke Prevention. Additionally, Prof. Graham Hughes, clinical lead for NCPOP, shed light on his organization's mission. A collaborative effort between HSE Clinical Design and Innovation and the Royal College of Physicians of Ireland, NCPOP works diligently to enhance and standardize the quality of care for older individuals across Ireland.

The conversation extended beyond health and housing into financial security, as Moyah Murdock, CEO of Insurance Ireland, led a dynamic Q&A session. She addressed pressing concerns surrounding insurance policies for older people, offering valuable clarity and guidance.

Among the distinguished voices at the event, Clare's own Age Friendly Ambassador, Mike Hanrahan, inspired attendees with his personal journey of lifelong learning. As a Senior Atlantic Fellow at the Global Brain Health Initiative at Trinity College Dublin, he shared his passion for exploring meaningful avenues to support cognitive health and personal growth through continued education.

This enriching convention provided an invaluable platform for exchanging ideas, fostering connections, and championing policies that empower older people to lead fulfilling lives with dignity, security, and opportunity. The experience reaffirmed the collective commitment to ensuring that wisdom and age are celebrated as strengths that enrich the fabric of our communities.

Dublin City Council are the lead authority for this project. Work will be paused in September 2025, due to the impending Presidential Election.

Children's Services

The Little Library Bag initiative 2025 was launched by the Department of Children, Disability and Equality, the Department of Rural and Community Development, and Local Government Ireland on 9 May.

Little Library Bags are now available to collect from libraries across Clare. All children who are due to start primary school this year are entitled to a free book bag, with books in English or 'as Gaeilge.'

Clare Libraries Children's Services participated in Coláiste Muire's 'Coláiste Fest'; a week of non-curricular activities. Clare Libraries provided supplies for a STEM sculpture workshop and the Children's librarian made a presentation on reading for pleasure.

Healthy Ireland

Three Healthy Ireland at your Library events took place this month.

Tutors from Mid-West Aries facilitated a **Creativity for Wellbeing** workshop in De Valera Library, Ennis, 11 people attended. A second workshop also took place in Scariff Library.



Kilrush Library hosted a Connect Café in partnership with West Clare Family Resource Centre and Mental Health Ireland. 24 people attended and gained much insight into 'The Benefits of Walking' a talk by Pius Murray, together with mindfulness and meditation which was led by Breda Latham & Pauline Burke.

Creative Ireland

The national launch of Cruinniú na nÓg took place on Friday 9 May at King John's Castle in Limerick with Minister Patrick O'Donovan. This year it is being celebrated on Saturday, 7 June with over 1,000 free creative activities and events taking place across the island of Ireland. 35 workshops are taking place across 22 locations in County Clare. The full Clare programme is on https://cruinniu.gov.ie/events/location/clare/ Distribution of 1000 programmes and posters has taken place across the county.

The Creative Ireland programme is also delivered collaboratively by the Culture & Creativity Team with representatives from the Libraries, Arts, Heritage, Climate Action, Biodiversity, Healthy Clare, Museum, Local Enterprise Office and Age Friendly sections of Clare County Council.



A recent project delivered by Climate Action, funded by Creative Ireland is the Rubbish Film Festival. Transition year students from 5 local Secondary Schools took part in the intensive 2-day workshop to create a 1 minute short on climate action. The regional winner, Coláiste Muire, went on to be placed second in the national awards.

Creative Ireland Recently Funded Projects:

- Ennis Library Comic Fest a series of workshops in animation, comic illustration, gaming and mask making took place in De Valera Library.
- Words for Mother E-ART-H Poetry and Pottery workshops in Mountshannon to inspire creativity through Nature Writing and Ceramics. The participants in these workshops will go on to exhibit at Mountshannon Arts Festival

Clare Arts Office

There were eight support and strategic meetings with artists and arts organisations.

Two films, one concert and an improvisation workshop took place in Cultúrlann Sweeney, Kilkee.

Two Arts in Clare slots were broadcast on Clare FM.

The Arts in the Community programme continued in Raheen Hospital and in St. Joseph's Hospital, Ennis where a visit from the National Museum of Country Life took place. Bealtaine was celebrated with a performance by Mike Hanarahan and four local choirs to an audience of three hundred people on the steps of the Ennis Courthouse. We launched an initiative with Music Network and glór to encourage older people to take up playing music again.

In preparation for the Clare Mela in Shannon, Fidget Feet Aerial Dance Company worked with 160 students from schools in Shannon, Cratloe and Clarecastle.

Clare Youth Theatre had performances from their senior group and one from their junior group in Súil gallery. Both groups continue to meet weekly. Over one hundred people attended.

Our Embrace Hooley took place on April 29th with nearly two hundred people in attendance. Cllr. Mary Howard launched the event with performances from participants from Dulick centre and Down Syndrome Clare. The Embrace art exhibition ran in glór until 31 May featuring work from the Dulick Centre, Brothers of Charity, Acquired Brain Injury Clare and Ennis Voices for Autism.

Three exhibitions took place in Clare Museum, Scariff Gallery and Cultúrlann Sweeney.

Súil welcomed over three hundred visitors during this period.

In Tandem, an exhibition by three local artists, finished in Súil and was followed by an exhibition JOURNEYS – Everything begins somewhere. JOURNEYS is in partnership with Helium Arts, the national children's art and health charity. Helium Arts brings artists to children and young people living with lifelong physical health conditions. Artists work at bedside in hospitals as well as in the community. A stakeholder gathering with Helium also took place in the gallery.

Súil continues to host weekly staff yoga sessions on every Monday.

Five Riches of Clare concerts took place in St. Columba's Church as part of the Fleadh Nua with an audience in excess of 1000 people during the wee

Clare Museum



The Festival of Polish Culture took place. This was the Museum's Creative Ireland project. It was a 10-day festival of exhibitions, films, public talks, music and food tasting. It was opened by the Mayor of Ennis Clare Colleran Molloy and the Polish Honorary Consul was also in attendance. The recital by the Polish choir in the cathedral and the food tasting event had 150 people attending both.

The curator and the education officer were involved in promotion of museum activities during the month including press releases and 25 social media posts and an interview on Clare FM.

A total of 342 children from seven schools visited the Museum. This included primary and secondary school children and students from the language school.

The uploading of the museum's Axiell database to the cloud was completed during the month.

Photographs of 37 objects and one blog entry were uploaded to the museum website during the month.

The education officer brought butter making equipment to an active retirement group in Shannon Library.

The final monthly lecture of the current series took place during the month.

Local Studies



The Local Studies Centre has received drawings and images from

Clare County Council. This collection includes drawings and images relating to the Tidal Barrage at Clarecastle. This structure continues to be pivotal to the prevention of flooding in Ennis. The Local Studies librarian hosted the launch of Patrick MacNamara's memoir in Killaloe Library. Patrick had previously donated his collection of GAA-related papers to the County Archives. An exhibition of books and ephemera from the library collection relating to Irish Traditional Music was held in the Local Studies area during the Consairtín festival in Ennis.

Clare Archives

Digitisation of Daniel O'Connell material was completed in association with Clare Museum. The digitisation of a GAA club's minutes dating from 1947-1980 also took place.

Work is nearing completion on the Barrett Collection. The archivist also answered a number of archival queries from the public.

Killaloe MD welcomed Jeanette Seymore, Tusla Mid-West Fostering coordinator to our Killaloe MD May meeting. Ms Seymore provided the members with an overview of fostering in the Mid-West and the severe need for foster carers in the region. Foster Care Ireland are currently looking for a diverse pool of parents, there is no typical foster family, single people (over 25 yrs) are also eligible to apply and there are different types of foster care from Emergency, Short-term, Respite to supported lodging.

HOUSING


The housing public counter will remain open to the public, without appointment, from 9am until 1pm and by appointment after 1pm. The Allocation process in relation to the new social housing development comprising 10 units at Cnoc an Chláir, Clarehill, Clarecastle is completed. Pre tenancy meetings were held with the new tenants on 28th May last and on that day the new tenants received the keys to their new homes. This development comprises 10 units made up 7 no 3 bedroomed houses, 2 no 2 bedroomed bungalows and 1 no 4 bedroomed house.







The new social housing development located at Garrán Cathaigh, Leadmore West, Kilrush was recently advertised on the CBL website. This development comprises 8 no 2 storey 3 bedroomed houses and 6 no 2 bedroomed bungalows and almost 200 expressions of interest were received. The Assessment process in relation to this development is completed and offers of accommodation have issued to the prospective tenants.



Tenant Purchase Incremental Scheme


There remains significant interest in the LA Tenant Purchase Incremental Scheme. We currently have 27 open cases at various stages of the process. The sale of seven properties under the tenant purchase scheme completed in 2024. Two properties have been sold in February 2025. It is expected that more sales will complete in June 2025.

Having consulted with elected members in relation to maintaining our newer stock we have agreed that properties purchased or built since 1st January 2016 will not be available for sale under this scheme. This can be reviewed at end of current Housing Delivery Plan period in 2026. We have also agreed that 1-bedroom properties will not be available under the scheme.

Estate Management

The Estate Management Team continue to undertake regular routine and response calls to tenants, dealing with complaints re breaches of Tenancy and ASB as well as inspecting Local Authority tenancies and providing the necessary supports to tenants. The team were successful in securing 3 Repossession Orders in court in 2024. A number of further Repossession Applications will be going through the Courts in the coming months.

The team continue to be extremely active in carrying out tenancy visits. It should be noted that the follow up on complaints received and the no. of visits carried out do not correlate with an increase in instances of anti-social behaviour or tenancy breaches but rather that a more proactive approach is being taken with the team in engaging with tenants.

The team carry out continued patrols of Local Authority housing estates and Traveller accommodation sites and have a very visible presence to manage and mitigate against complaints of antisocial behaviour. The team also engage proactively with

tenants to help prevent anti-social behaviour, facilitate the daily patrol of local authority sites, arrange specific meetings with tenants as well as engaging with local communities.

The team recently led the establishment of Gauras Residents Group, with support from the Rural and Community Development Officer. The group will serve residents from three social housing estates, providing a shared platform to raise concerns, exchange ideas and work together to build a strong, more connected, and sustainable community. Residents are encouraged to get involved, contribute their perspectives and help shape a positive future.

Private Rented inspections





Local Authority Purchase and Renovation Loan

The Local Authority Purchase and Renovation Loan was introduced on the 22 July 2024. This is a government backed mortgage and loan for the purchase and renovation of derelict and non-habitable homes. The property must be eligible for the Vacant Property Refurbishment Grant, whether derelict, non-habitable or simply vacant.

The Homeless Action Team

The level of complex cases presenting to the Homeless Action Team in Clare has continued to increase. Additional demands are being placed on the Homeless Action Team to provide Emergency Accommodation in a safe and appropriate manner. The levels of support, advice and advocacy, being requested from households around areas such as Homeless Services, Housing Requirements, Health supports, Outside Support referrals and the need for Emergency Accommodation within this region is increasing.

There has been a notable rise in the number of presentations of individuals and households experiencing difficulties and concerns around Hospital discharges, Prison releases, Family or relationship breakdown, addiction or mental health concerns, dual diagnosis, and a further increase in the number of households presenting from the Travelling Community.

The level of aggression being experienced by the Homeless Action Team staff and supporting agencies staff which increased in 2024 needs to be monitored and addressed in 2025.

Prevention and support remain a key factor in the workings of the Homeless Action Team. Several single and household presentations worked with staff around prevention options and supports which in turn prevented the need for Emergency Accommodation and avoiding entering Homeless services. Other individuals and families were supported in accessing Emergency Accommodation either within our services or through private establishments.

The Homeless Action Team continues to pursue additional emergency accommodation options at a time when accommodation is in high demand generally.

Homeless Services [Homeless Action Team HAT]

Clare Homeless Action team continues to engage with all necessary stakeholders, service providers and local supports to adopt a collaborative approach to the tackling of Homelessness.

Affordable Housing Schemes for County Clare

CCC continue to run Expression of Interest (EOI) Campaigns seeking proposals on options to deliver affordable homes in County Clare. CCC are also engaged with developers with potential for Part V affordable delivery.

To date, CCC have received approvals for access to the Affordable Housing Fund for the following developments:

- Tulla Rd Ennis 10 units.
- Lahinch Rd Ennis 11 units (8 units allocated to successful applicants)
- Shannon 10 units (All units allocated to successful applicants)

The successful applicants nominated for the homes on the Lahinch Road, Ennis are liaising directly with the developer and their agents to finalise the sales.


CCC are currently engaged with other developers, that have expressed interest in affordable housing, for potential inclusion on the scheme. There is an online information portal at https://affordablehomes.ie/ providing general information to the public with regards to affordable housing.

Defective Concrete Blocks Grant Scheme

The Enhanced Defective Concrete Blocks Scheme went live in mid-July 2023, for private dwellings, with the finalised Act, regulations, updated YQA's (Your Questions Answered) & Ministerial Guidelines published.

On the 7th of November 2024, The Minister approved an increase in the grant cap from €420,000 to €462,000.


Clare County Council continue to administer and validate applications since the commencement of the scheme via the

online portal. Clare County Council are engaging with the Housing Agency and the DHLGH and continue to carry out all associated duties.

To date, Clare County Council have issued 50 Remedial Option Grants, with the total value of €15.12m awarded and are awaiting input from the Housing Agency to further process 92 applications with grant amounts to follow.

NSAI (National Standards Authority of Ireland), are carrying out a review of the current I.S.465 standard of deleterious materials on behalf of the DHLGH, which is out for public consultation currently until the 28th May.

CCC carried out recent information evening's on 31st March last in Shannon and 6th May in Ennis. The main focus of these evening's was orientated towards applicants who have received their grant option. These events were attended to capacity with positive feedback from attendees.

CCC intend to hold further information evenings in various locations in 2025, to target people with limited digital resources and/or capabilities, to assist them further in making an application and other elements of the DCB application process. Clare County Council continue to engage with the DHLGH to ensure social houses affected by DCB are included in a similar scheme.

Update on capital programme:

Direct build projects currently under construction include the Back Road project in Kilrush, the Doonbeg project, the Gort Road project and the Shallee Drive/Cloughleigh Road project. These projects are all progressing well. Other housing capital schemes are at varying stages of design and construction across the county.

Approved Housing Bodies

The Approved Housing Bodies have an ambitious housing programme this year. A total of 41 no units over 3 projects have been completed to date in 2025. During May Phase 2 at Loughville, Ennis was delivered by Tuath Housing Association. This Phase of the development consists of 18 units -2 no. 2-bed bungalows, 14 no. 3-bed semi-detached houses and 2 no. 4-bed semi-detached houses. We continue to support All AHBs through regular meetings with individual bodies that are involved in delivery, and through quarterly meetings of the AHB Forum.

UKRAINIAN SERVICES TEAM

As of 14th May, CSO figures show there were 451 Temporary Protections granted nationally in the past month with an average of 16 granted per day. There are currently 5,048 Ukrainian Beneficiaries of Temporary Protection (BOTP's) living in County Clare, representing a decrease of 13 people in the County compared to figures released previously. There are 1,211 people accommodated in 25 multi-occupancy facilities located throughout the County - this reflects a decrease of 13 people compared to previous figures. The remaining people are accommodated in residential settings, in formal hosted arrangements, through the Irish Red Cross and Clare County Council's Offer-a-Home scheme. To date our Matching & Relationship Manager has facilitated the accommodation of 485 people that were originally living in hotel and multioccupancy facilities.

The Government recently announced it's decision on the Accommodation Recognition Payment (ARP) and has decided to reduce the payment from €800 to €600 from June 2025 onwards. As the payment is payable monthly in arrears, the first payment at the reduced rate will be received by hosts on 8th July 2025.

The following is an outline of some of the main options homeowners might be considering in light of the forthcoming changes:

- 1. Continue staying under the Offer a Home Scheme, regardless of changes to the payment.
- 2. Continue staying under the Offer a Home Scheme, but seek an additional financial contribution from the guest to 'top-up' the ARP when the current rate of ARP is reduced. The legislation on ARP states that an additional financial contribution from the guest, beyond utilities, may be considered a rental agreement, regardless of whether this was intentional or not on the part of the host. Simply, its illegal to top up the ARP payment if its not the payment for the utilities. It's also illegal to have a rental agreement and claim the Accommodation Recognition Payment. Further information on the ARP can be accessed at: gov.ie Accommodation Recognition Payment Scheme: Your questions answered
- 3. Continue in the existing living arrangements but transition into a rental agreement.
- The property will have to be withdrawn from the Offer a Home Scheme;
- 4. The property must be registered with the RTB (contact the RTB for advice on the specific arrangement).
- 5. Check with Revenue and/or Intreo to determine whether there are tax implications or impacts to any social welfare entitlements (income will be taxed). Rental income is taxable but expenses might get some relief (e.g. RPRIRO Income relief).
- Any agreement is discussed openly with everyone involved, is put in writing and has a clear end date (the sample of the Residential tenancy agreement can be found at the following link: <u>Residential Tenancy Agreement Template</u> |

Residential Tenancies Board)

- Consider what is a fair amount of money this will vary based on the individual situation and guests' circumstances.
- The tenant (formerly guest) may be able to apply for <u>Rent</u> <u>Supplement or Renters Tax Credit</u> to help with the cost of rent.
- Ukrainians in Ireland are currently not eligible for social housing schemes like Housing Assistance Payment (HAP) as they do not have 'a legal right to remain in the state on a long-term basis'.
- End the current hosting agreement, and give your guests notice to find alternative accommodation. If the time has come to end the household participation in Offer a Home Scheme, that is absolutely understandable. Local Authority Integration Team



The Local Authority Integration Teams (LAITs) have been set up in all local authorities. Their purpose is to help coordinate the different kinds of support available for people who are applying for international protection, refugees, and others in similar situations.

The goal of LAITs is to help IP applicants and refugees become independent, settle into their new communities, and participate in Irish life. They do this by connecting people to important services that can help them integrate into the community.

Who do LAITs support?

LAITs provide support for:

- Applicants for International Protection (IP)
- People who have been granted refugee status or other forms of protection, such as subsidiary protection or permission to remain
- Refugees who have been resettled in Ireland through a government programme
- Beneficiaries of Temporary Protection (BOTPs)

How is the support provided?

LAITs operate under the principle of 'Integration from Day One'. This means that LAITs provide integration support to people who need it as soon as they arrive in Ireland.

What services do LAITs provide?

The work of LAITs isn't meant to replace existing services. Instead, LAITs help connect people with the existing services that are most suitable for their needs. This includes things like:

- Being a direct contact for new arrivals, helping them with any problems they might have when dealing with public services
- Connecting new arrivals with services like legal help, childcare and healthcare
- Connecting new arrivals with services that improve their ability to live independently, like job training, English classes, education, and apprenticeships
- Guiding new arrivals through the process of applying for financial support, medical help, child benefits, and other services they might need
- Holding meetings in local areas and using community development principles to help those who attend
- Supporting people if they face racism or other unfair treatment, helping them report it to the right authorities
- Helping vulnerable new arrivals get in touch with nongovernmental organisations (NGOs) and other services if they need extra help










Clare County Council was re-accredited by Engineers Ireland.

Clare County Council has become the longest continuously accredited local authority in the country after securing re-accreditation for a further three years with Engineers Ireland's Continuing Professional Development (CPD) Accredited Employer Standard. President of Engineers Ireland Laura Burke today Áras Contae an Chláir to present the award, which Clare County Council first received in 2003 for its high-quality CPD systems and practices that support the growth and expertise of its engineering and technical staff.

Clare County Council achieved the 'Transformational' Standard in three of the seven accreditation criteria - an advanced level reserved for organisations that demonstrate exceptional CPD practices with strategic impact.



Employee Wellbeing

The Focus of the Staff Wellbeing Hub for May was Mental Health. This coincided with a free Swim & Gym at Active Ennis and a lunchtime walk marking Workplace Wellbeing Day.

A bespoke Financial Wellbeing Programme for council staff was launched in May. There are webinars scheduled for May and June with further sessions planned for the Autumn. Staff also have the opportunity to book a free one to one clinic with the programme.

Safe Talk Training Session (Suicide Awareness) took place on 15th May 2025. All staff including new employees were encouraged to take the opportunity to attend this short course. Skills learned from this training empowers from every perspective, work/personal/community, in helping to prevent Suicide.

May 15th was also "Hello How are you Day", a day to connect with each other. The campaign was promoted by Mental Health Ireland & Clare Co. Council registered with Mental Health Ireland to join in and connect with the event by way of our Coffee Break, which was complimentary.

Unions

The Human Resources Department engages with Unions on various matters.

FINANCE

This council submitted its quarter 1 2025 financial returns as set out below. Some of the highlights in this first quarter are:

- Government Debtors have increased by circa €4.7m to €38m. This is becoming an increasing challenge for Clare County Council and one which requires focus as we progress through the year.
- Severe weather conditions have over the years become more common. January 2025 was no different and the County once again suffered as a result of Storm Eowyn and snow. The resulting cost of both these incidents is estimated at €1.3m of which €900k has been incurred to date. It is
- not yet known what level of funding if any will be made available to Local Authorities to cover this expenditure.
- Activity at Clare Tourism East sites is recording adverse variances to budget in the first quarter of the year. There will be close monitoring of this business area as the year progresses.
- In 2025 a full review was completed on the Schedule of Municipal District Works with both grant and own resources allocated differently across the Municipal Districts. The financial and staffing implications of this are under constant review with no significant variances to these budget in the first quarter.

Kilrush Town Centre First Plan

The Town Centre First Department is working together with the Kilrush Town Team and the West Clare Municipal District to advance the Town Centre First plan for Kilrush. Architects, funded by the Department of Rural & Community Development and commissioned by the Council, are leading extensive background data collection.

THRIVE Ennis - Town Centre First Heritage Revival Scheme

In March 2025, elected members approved a Part VIII Planning application to repurpose and adaptively reuse the Cloister building in Ennis as a multi-use arts and community hub. Clare County Council submitted a funding application under the THRIVE Strand 2 Town Centre First Heritage Revival Scheme to the Southern Regional Assembly in April 2025. If successful, this funding will allow the project to move to the detailed planning stage. On May 16th, the Town Centre First Department hosted the first of several site visits from specialists representing the Southern Regional Assembly to review the proposals. Additional site visits are anticipated in the coming months. A decision on the funding application is expected to be announced by the Southern Regional Assembly in

Quarter 4 of 2025.

FORWARD PLANNING

Clare County Development Plan 2023-2029 - Chief Executive's Two-Year Progress Report 2023 - 2025

The Elected Members were issued with a Two-Year Progress Report on the Clare County Development Plan 2023-2029, to demonstrate the progress that has been made towards achieving the objectives of the Plan in its first two years of operation. The provision of the Two-Year Progress Report to the Elected Members is a statutory requirement under Section 15(2) of the Planning and Development Act 2000, as amended. A presentation was given to the Elected Members on the findings of the report providing the opportunity to give their considered feedback. The report includes an extensive and detailed analysis of planning applications and decisions in the

two-year period, including the delivery of commercial development and the progress made towards the achievement of Core Strategy targets, in terms of both the completion of residential units and the granting of planning permission for residential units, in settlements and in the countryside. The report also provided updates on the projects and programmes that are given policy support in the County Development Plan. The Elected Members formally noted the report at the May Council meeting.



Marine Planning

In early May, Minister for Climate, Environment and Energy Darragh O'Brien announced the commencement of work on the preparation of a National Offshore Renewable Energy (ORE) Designated Maritime Area Plan (DMAP). As previously outlined, the South Coast ORE DMAP was approved by both Houses of the Oireachtas last October and the work on a National DMAP will further this work.

Minister O'Brien stated that "An integrated, national approach will ensure that strategic forward planning for skills, enterprise and the industry-wide supply chain development can take place. Ports will have the ability to forward plan for the necessary large-scale offshore infrastructure build-outs required to support ORE development, while forward planning for grid and interconnection can occur within the framework of a long-term holistic view. By foucssing on a single DMAP, we will be able to maximise our resources, in terms of financial, human and time."

The National DMAP will be delivered by a Project Team in the Department of the Environment, Climate and Communications, supported by a Steering Group comprised of sectoral experts from across relevant government departments. Preparatory work is well underway, and work can commence immediately on the statutory process. The identification of suitable areas for offshore renewable energy will be determined following a process of rigorous analysis of maritime and environmental data using Geographic Information System (GIS) software.

Technical feasibility will be a key factor in determining the outer boundary for the DMAP. The department will work with the State's maritime experts, such as the Marine Institute, to ensure that the approach will be evidence-based using robust and best available data. Progress on key milestones, including public engagement milestones, will be reported on in a dedicated National DMAP workstream under the Offshore Wind Delivery Taskforce and through the Project Ireland Marine 2040 Group. It is expected that this DMAP will be completed by the end of 2027.

Residential Zoned Land Tax (RZLT)

A total of 24 submissions were received regarding the final Residential Zoned Land Tax (RZLT) map for 2025. A rezoning request acknowledgment letter, which includes details of the recent planning history of the applicable land, has been issued to the respective landowners. This letter can be used to support a claim for exemption from the tax for 2025. The council will notify landowners of its decision on whether to proceed with a rezoning request, based on their submission, through a variation to the Clare County Development Plan 2023-2029 by 30 June 2025. Decisions on rezoning requests cannot be appealed to An Bord Pleanála.

Additionally, 16 submissions were received concerning the annual draft map for 2026. Land-owners will be informed of decisions

regarding requests to exclude lands from the annual draft map by 1 July 2025, with the option to appeal these decisions to An Bord Pleanála by 1 August 2025.

All submissions have been published on the council's website.

RZLT Liability

The Residential Zoned Land Tax came into effect on 1 February 2025. The final RZLT map for 2025, published on 31 January 2025, indicates the lands subject to the tax. The deadline for payment of the RZLT to the Revenue Commissioners has been extended to 30 May 2025.

CONSERVATION AND BUILT HERITAGE

Section 57 Applications

Section 57 Declarations are issued to owners of buildings or structures that wish to conduct works to their structures. A Section 57 Declaration determines whether works would be considered exempt from planning. A Section 57 Declaration can also be used to clarify the curtilage of a protected structure, or what elements are to be protected. There is no fee for a Section 57 Declaration.

Drumcliffe Union with Kilnasoolagh, Church of Ireland Parish - €6,050

The funding awarded to Butterfly Conservation Ireland will support it in its moth mapping, monitoring, and training initiative. This project will document moth populations in Clare and provide training to local volunteers.

The funding awarded to Drumcliffe Union will support the second

phase of the "Conserving Kilfenora Cathedral Graveyard Together" project. This phase involves mapping, documenting, analysing, and assessing the graveyard, alongside a biodiversity study of the site. Kilfenora Cathedral, a national monument with over 830 years of history.

Clare Community Archaeologist

Tenders have been received for the Clare Community Archaeological Scheme and an Ar-chaeologist will be appointed shortly for 2025. Under this scheme Clare County Council in partnership with The Heritage Council seek to promote awareness, knowledge and under-standing of our archaeological heritage amongst groups and individuals in the county.

Heritage Stewardship of the Archaeology in Loop Head

Tenders have been received for the provision of services for the analysis of archaeological data collected by remote sensing at the Loop Head peninsula. This project will contribute essential data for informed conservation planning and long-term heritage stewardship in Loop Head. To date the project has collected 360 ha of Photogrammetry (on land), 253 ha of LiDAR data (on land) and therma (thermal) data of six holy wells.

The Heritage Council, Adopt a Monument Scheme

Adopt a Monument Scheme run by the Heritage Council provides expertise, mentoring, sup-port and networking to help to preserve and protect monuments for future generations.

Inch Tidy Village and Inch National School have been shortlisted in their application for Adopt a Monument Scheme to make the ringfort in Inch, Monument no: CL033 106 accessible, so that it can

become a feature in the community and a learning opportunity for the local school and to conserve the ringfort for future generations.

LOCAL ENTERPRISE OFFICE

- Mentoring: In May, LEO Clare successfully conducted three "One-to-One Mentoring Clinics," accommodating up to 22 businesses. The mentoring sessions covered areas such as Finance and Business Start-Up, Marketing and Sales, Social Media, Website, & Digital. Furthermore, to date, over 150 clients have been assigned expert mentors to assist them in enhancing their businesses, 20 of those assigned during the month of May.
- Training: LEO Clare provided an extensive array of training courses and programmes during the month of May, covering areas such as Starting Your Own Business, Tax & VAT, Email Marketing, Social Media and Artificial Intelligence. Approximately 55 in-dividuals availed of these training supports throughout the month.
- Productivity Supports: With rising prices affecting all

businesses, LEO Clare has var-ious productivity supports to assist businesses offset higher input costs. To date in March, LEO Clare have processed applications for 16 Digital for Business, 13 Green for Business and 3 Lean for Business consultancies, along with 6 Energy Efficiency Grants and 7 Grow Digital Vouchers.

Women in Business Networking event:

Local Enterprise Office Clare hosted a Women in Business networking event at the Inn at Dromoland on 7th May. The keynote speaker was Shirley Walsh, who is the CEO of Shannon Coiled Springs. DERELICT SITES

The Derelict sites team are currently dealing with 282 properties as at 23rd May 2025 that are considered derelict. We continue to have high levels of activity and engagement with owners and their representatives. Initial engagement with owners or their representatives is key to resolution of the issues of dereliction and to gain an understanding of the various reasons why the properties are in a derelict state. Where derelict properties are sold by the owner, we commence engagement with the new owners of those properties to ensure they are aware of their responsibilities under the Derelict Sites Act, 1990.

We are also seeing a consistent number of planning applications for property refurbishment/extensions, and it is clear from driving around the county the level of work ongoing on individual properties. We are advising property owners of the vacant property refurbishment grant if the property is suitable for residential use. With time and effort, working with owners, financial institutions and other departments, there are definite options for positive redevelopment and revitalisation of many such derelict sites.

The table below provides a snapshot of the activity in May 2025 and the year 2025 to date with comparative figures for the full year 2024. There are currently 94 properties included in the Derelict Sites Register as at 23rd May 2025.

Compulsory Acquisition of Derelict Sites (CPO)

The Department of Housing, Heritage and Local Government is promoting a CPO activation programme for local authorities, with targets for the number of CPOs to be done by each local authority. The Table below sets out the status of CPOs commenced by the Derelict Sites Team in Clare County Council since 2022 to the current year. It is important to note that the CPO process can be lengthy and complex.

In addition, the Urban Regeneration and Development Fund will provide funding for CPOs on a rolling basis in the town of Ennis with the objective being that these properties would then be sold on the open market. A particular emphasis will be on properties that have potential for residential use. Two such CPOs are with the PRA for registration. Actions taken on properties in the town of Ennis has resulted in a number of properties coming to market or making plans for site development.

Derelict Site Levy

Determination of valuations on sites which are on the Derelict Sites Register commenced in 2023 and notices of valuation have issued to properties as detailed in the table below. Four owners have appealed the valuation to the Valuation Tribunal and while decisions are awaited on two appeals, one appeal by an owner was rejected. The levy is an annual levy while the property remains on the Derelict Sites Register and amounts to 7% of the value of the property, on an annual basis. Assessment of valuations and billing of the levy will be further progressed during 2025 and it is intended that all properties on the Derelict Sites Register will be valued for the purposes of billing the levy. This levy will go towards the cost of billing and collection of the levy and resourcing of derelict sites function, up to and including CPO of properties.

The Table below shows the levels of activity on the Derelict sites levy as of 23rd May 2025. All other properties on the Derelict sites register are being valued for the purposes of the Derelict sites levy on a regular basis.

VACANT PROPERTY REFURBISHMENT GRANTFOR DERELICT AND VACANT PROPERTIES

To date the value of grants approved under the Vacant Property Refurbishment Grant by Clare County Council has exceeded €23 million as at mid May 2025 (382 grant applications approved or 66% of all applications), with further approvals due to issue. This is a very significant investment in housing in County Clare and the work ongoing around the county on renovations and extensions is very visible. The Vacant Homes Team continues to advise applicants on all elements of the scheme and is available to meet with individuals to take them through the process.

The Grant is making a real difference in boosting the supply of rental properties and properties for permanent residence and will deliver on a key priority of 'Housing for All' National Policy and the Vacant Homes Action Plan, the key objective of which is to reduce vacancy and dereliction in our cities, towns, villages and rural countryside and provide more housing options in the process.

A recent article in the Clare Champion newspaper has stimulated more enquiries into the scheme and we are currently seeing an increase in the number of applications. Any applicant can meet with the Vacant Homes Team in Áras Contae an Chláir by appointment or can discuss their application over the phone with any team member.

We continue to have high levels of enquiries and applications for the Grants and the total applications since the scheme was introduced in July 2022 is now 577, with 80 of them being received this year to date. We are in the top eight local authorities in the Country in relation to application numbers. Our response time for initial assessment of new applications is generally three to four weeks. We have paid out €6.6 million to 113 property owners in County Clare who have completed works — that means that 30% of all grants approved have been paid out to date and many others are in the process of submitting their claims for payment. The final site inspections are organised and the administration of the financial and legal elements of the grant are completed. The level of claims for payment is increasing every day and the Team work closely with owners on this process.

Other Points of Information

- The breakdown of applications between urban and rural areas has remained consistent - 56% of applications are for rural areas of the county and 44% for properties in towns and villages.
- To date, 70% of applications are for properties to be used as principal private residence (376 properties) and the balance of 30% are for rent. This has remained consistent in recent months.
- Approximately 30 property owners have applied to have the period to complete the works extended. Such requests are considered on a case by case basis, depending on the level of work carried out to date and the timeframe needed to complete the works.

ENNIS MUNICIPAL DISTRICT

The Summer Season is very much upon us with a huge amount of work taking place across the month of May in the Town and surrounding areas. In addition, we continue to work closely with our colleagues in the PMO and GDO, in Ennis 2040 and indeed across the Directorates on various works of common interest and benefit.

Some of the main items of works carried out include the following: Unveiling of the 'Mike Mc Tigue' plaque on the renamed bridge on Cusack Road

The renaming of Victoria Bridge on Cusack Road to the Mike McTigue Bridge came about in honour of the former World Champion boxer. In accordance with Section 196 of the Local Government Act 2001, a public consultation process was held from 24th March to 7th April 2023.

The unveiling of the plaque on Tuesday May 13th 2025 was led by Mayor of Ennis MD, Cllr. Clare Colleran Molloy with Mike McTigue's grand-nephews, Nicholas Rynne from Kilnamona and Kevin Rynne from the Cusack Road in attendance along with other relatives of Mike McTigue. The Elected Members of Ennis MD along with Staff and a number of interested public witnessed this historical event.



Kayaking on the River Fergus from Cloughleigh School

Great work has been done by Kayak Le Cheile (setup by Scoil Chríost Rí in association with Clare Sports Partnership at the school in Cloughleigh) and it highligts the huge potential of the River Fergus for recreational tourism. It was decided that the Ennis MD Councillors and the Ennis MD staff would go and experience kayaking on the Fergus.

It was worth the wait as river conditions on the morning of May 20th were very favourable for those novice kayakers among the group. Staff and students at the school, as well as the Burren Outdoor Education and Training Centre facilitated this fantastic experience while briefing Members of the opportunities that exist at the Cloughleigh site. The Principal of the school also thanked Ennis Municipal District Staff for installing the new access steps at

the river wall which has resulted in making the river much more accessible for everyone.

Ennis Local Transport Plan

The Public Consultation Phase of the Ennis Local Transport Plan (LTP) commenced on Friday May 16th and will continue until Friday June 27thwith all Members and interested parties encouraged to participate in the process and feedback their comments and suggestions for consideration. The Ennis Local Transport Plan (LTP) is funded under the National Transport Authority's (NTA) Active Travel Investment Programme. It will guide funding for future transportation projects across Ennis and surrounding areas, including road, cycle, bridges and pedestrian infrastructure. The Ennis LPT is being delivered by the Ennis Municipal District office of Clare County Council and Systra Ltd. The team from Systra includes consultants with significant experience in the delivery of sustainable infrastructure and transport planning.

Public participation in this consultation is important, and we value any feedback you think should be reviewed by the project team to help inform the development of the Ennis LTP.

Ennis Town Bus Service

The Ennis Town Bus Service operation contract proceeded to tender stage in late February 2025, and the National Transport Authority (NTA) Town Bus Team expect that this process should be completed by late October of this year.

Ennis MD Office and Clare County Council Road Design and Active Travel Sections are working with the NTA Town Bus Team and their designers to complete the designs of bus stop locations so that the NTA can proceed to procuring the construction works and proceed to installation of the Bus Stops.

It is expected that work on the bus stops should commence in August. The Ennis Town Bus Service is expected to start by the end of 2025 or very early in 2026. The start date will be dependent on the completion of the bus stop construction and will be a very welcome initiative with many benefits as a result.

Ballybeg Footpaths

In May, Ennis MD roads crews, completed the final phase of the Ballybeg footpath scheme. This final phase of the scheme links the previously completed footpaths with the Kilydsart road junction and provides a safe access over the river at Ballybeg/Kildysart road cross. This will provide a safer and easier pedestrian access to the village of Clarecastle and further into Ennis and is also the final link in a circular walking route which is very popular with the residents of the area.

The complete scheme involved, new footpaths, a yield system for traffic over the bridge, raised uncontrolled crossings, junction tightening and traffic calming works and new signage and street lighting.

The works were designed and constructed by the Ennis MD Staff and the delivery of the completed scheme has been achieved through positive representation and engagement from the public and the Elected Members over the last number of years.









Ballyallia Lake Footpaths

Ennis MD staff have commenced works on resurfacing some of the public footpaths within the amenity area of Ballyallia Lake. It is planned to resurface 350 metres of footpath over the coming weeks which will be a significant enhancement of the wonderful facilities there, which are enjoyed not just in Summertime but throughout the entire year.







Gort Road Business Park Car-Parking project

Ennis MD delivered the construction of 62 new additional car parking spaces to the front section of the Gort Road Business Park. It is envisaged the new car parking scheme will help alleviate the parking issues experienced in recent years by the businesses within the estate. Further work and perhaps additional management measures of the spaces there is planned to ensure fair and equitable use of the areas available. The works were completed by Rathcabin Tarmac Ltd.









Mill Wheel Amenity Area

In the past month, Ennis MD staff in conjunction with Ennis Mens Shed and Ennis Tidy Towns refurbished and installed 3 no. old benches in the Mill Wheel Amenity Area. These are already being much used and enjoyed by all.







Powerwashing of Street Bins & Laneways

Ennis MD crews undertook a deep clean of the existing laneways and litter bins in and around the town of Ennis during the past month. Engagement also took place with the Designer and Contractor of the Public Realm works, who also carried out a deep clean of areas that are substantially complete and in use by the public at this stage. Any additional future measures that need to be included in our Street Cleaning regime will be considered.





Paving Repair Works to 1916 Memorial & Maid of Eireann Fountain

Following complaints of defective paving at both the Maid of Eireann Fountain and the 1916 Memorial adjacent to Club Bridge, Ennis MD crews undertook repair works to both areas which are both widely used by members of the public.





Illegal Dumping & Community Clean-ups

Ennis MD crews assisted with a community cleanup with the newly formed Station Court Residents group this month. Works included overgrowth and litter removal and the cleaning of 38 drainage gullies in the estate. Ennis MD also co-ordinated a cleanup in conjunction with Clarecastle Tidy Towns at Clareabbey in Clarecastle.





Munster GAA Championship Action

While the result was not what we wanted, it did not stop the Ennis MD street cleaning crew in their efforts in cleaning the town after Clare's Munster Championship game against Tipperary in Cusack Park. The crew mobilised at 5:30am following the Saturday evening fixture and had the town back to its pristine state by 9am the same morning.



De Valera Library Footway Works

With a view of improving accessibility and permeability routes in the town centre, in conjunction with Property Management Department, Ennis MD undertook repair works to this area at the Old De Valera Library site on Harmony Row that connects up to Bindon Street, Ennis, hence making the area safer and more accessible for all to use.



Maid of Eireann Planting

Ennis MD Staff in co-ordination with Ennis Men's Shed, Clare County Council Gardening Section and Ennis Tidy Towns installed new planters on the Maid of Eireann Roundabout in recent weeks. Preparatory works are now complete with planters in place and bedding soil now installed. New flowers will be planted in this area in the coming weeks.



TRANSPORTATION

Roadworks Programme and Operations

The 2025 Schedule of Municipal District Works (Annual Roadworks Programme) has been agreed by the Municipal Districts. The Roadworks Programme has now commenced in all 4 Municipal Districts.

Strategic Transportation

Active Travel

The following is a brief overview of the activities within the Active Travel Office:

Tulla Road Active Travel Scheme:

The tender pack will be finalised by the end of May. This will go to tender once approval is granted to proceed by the NTA.

Limerick Road (incl. St. Flannans Drive) Cycle Scheme:

Following a request from the NTA to examine options to reduce costs on the construction of this scheme, a value engineering presentation was made to the NTA on the 8TH May. This presentation outlined potential measures that may reduce the overall construction cost of this scheme. Following this presentation meeting, the preliminary design that had been previously completed will be costed based on the new proposals.

Ardnacrusha to Athlunkard Bridge:

Clare County Council awaits feedback from the NTA on the appropriate preliminary design option to proceed with for this scheme.

Safe Routes To School program:

Gaelscoil Ennis:

Tenders for Consultancy Services for the bridge work element were received and are being assessed.

Holy Family National School Phase 2:

Construction work commenced on the 15th May and is programmed to last 6 weeks. The works will involve footpath widening and a raised controlled Pedestrian Crossing along Station Road.

The Bus Stop Enhancement Programme:

The NTA has established a Bus Stop Enhancement Programme for Local Authorities which will provides an allocation of €500,000 to each Local Authority to facilitate the enhancement / upgrade of existing bus stops to the meet the Transport for Ireland minimum requirements for customer experience. Clare County Council are engaging with the NTA in relation to the upgrading of bus stops throughout the county.

Feedback is awaited on the Grant Application Form & Programme of Works submitted to the NTA for their review at the beginning of May.

Public Lighting

Clare County Council continues to work on the repair and maintenance of the public lighting network in Clare through its public lighting Maintenance Contractor, Electric Skyline. All works undertaken on public lighting networks are required to meet the ESBN's 'Minimum Requirements for Works on Public Lighting'. Where necessary upgrade works are required such as cabling works, additional civils works to bring a light or lights back into service, in order to meet the ESBN's Minimum Requirements this may necessitate the attendance of the ESBN and subsequently shall result in extended repair times. Clare County Council continues to liaise with ESBN and Electric Skyline to expedite all repairs.

For the benefit of Councillors, public lighting faults can be reported via Local Authority Identification (https://www.clarecoco.ie/services/roads-and-transport/road-maintenance-issues/report-a-broken-streetlight).

The retrofitting of lights under the PLEEP Project (Public Lighting Energy Efficiency Project) continues in Clare with works currently ongoing in the Shannon, Killaloe and Ennis MD's. Works under the project are scheduled to commence in West Clare MD in June. 1,662 Luminaires have been retrofitted to date to the 20th May representing 53% of the overall no of units to be retrofitted in Clare as part of the PLEEP Project.

Clare County Council are working with the PLEEP Team and Electric Skyline to maximise output of both work crews.

CAPITAL DELIVERY / PROJECT MANAGEMENT OFFICE

Doolin Pier

PMO are liaising with the department at present to agree next steps, following review of local needs. In this regard, Cross-directorate group are currently reviewing key priorities in the area, so as to inform any future submissions to the department in respect of strategic development of facilities at Doolin pier. The MD are progressing construction of footpaths between Fisher Street and Doolin Pier, the programme of works which is due for completion in coming months. This will ensure that pedestrian connectivity is in place along this well-trafficked route.

Ennis Public Realm Regeneration (Project B)

The works have now moved into Barrack Square, where significant excavation has now been completed throughout the area. Concrete slabs have been laid, followed by laying of granite paving setts. It is expected that the works will be well progressed over coming months, facilitating summer opening, and the launch of this new Café quarter area. The area in front of the Cathedral is now very well progressed, and in combination with works previously completed along O'Connell Street, there is now a continuous stretch of Shared Space Public Realm Streetscape in place. We look forward to the opening up of this section on upper O'Connell Street (in front of the cathedral) in coming weeks, and restoring through-traffic from Station road to Carmody street. This is in itself a milestone for the project, as a large section of shared surface public realm space will be opened to the public for the first time. The O'Connell Square works are ongoing. The street fountain installation is well progressed. The interconnecting mechanical and electrical services have been advanced, and the roof has been backfilled over the reservoir structure. Evening works have commenced in May at the O'Connell Street/Market Street junction. In such areas of narrow street width, activity is been completed Out of Hours to facilitate pedestrian movement through these street sections and minimise impact on traders. Consultation with impacted traders and stakeholders is ongoing, and the contractor has appointed a Public Liaison Officer in this regard, in line with Works Requirements. Focused Stakeholder Consultation events were held on 9th December 2024 and on 19th March 2025 to review upcoming works phases. The contractor is also issuing weekly newsletters to inform of upcoming works. (Subscribe to ennispublicrealmb@shareridge.ie). The contractor, project team, and Clare County Council Resident Engineering staff are available to help traders and the public with any concerns and to mitigate impacts from the works wherever possible. It continues to be necessary to close streets to allow these works to be completed safely, and the project team and contractor, together with Ennis MD are working hard to coordinate activities to keep traffic impacts to a minimum and ensure that Ennis is kept open for business throughout the remaining months of this project.

Ennistymon Inner Relief Road and Bridge Crossing (Blake's Corner)

The Judicial Review process is ongoing.

Killaloe Bridge, Bypass & R494 Upgrade

Substantial Completion Certificate for the New Shannon Bridge Crossing and the R494 Upgrade has been issued.



The New Shannon Bridge Crossing (Brian Boru Bridge) was formally opened by the Minister for Transport Darragh O'Brien T.D. on Thursday 22nd May. The bridge was opened to the public and for vehicular use immediately thereafter.

Project snagging continues.

Training Courses

Clare County Fire & Rescue Service personnel underwent a number of training courses during May including Cardiac First Responder Advanced (CFRA) Initial Training on 12th May and Instructor Refresher Simon Snorkel on 20th & 21st May. Both completed in Shannon Fire Station. 18 recruit firefighters from across the country, including 2 from Clare County Fire & Rescue Service attended a QQI accredited Firefighter Skills Course at Ennis Fire Station Training Centre from 12th to 30th May 2025. The two firefighters from Clare will be based in Shannon Fire Station.

Clare Older People's Volunteer of the Year Award 2025

The Clare Older People's Volunteer of the Year Award 2025 was hosted at Hotel Woodstock, Ennis. Assistant Chief Fire Officers Ger Fallon and Andrew Young represented Clare County Fire & Rescue Service at the event, promoting the current Home Fire Safety Check Initiative. This initiative encourages older people and those living alone to avail of a free, pre-arranged home visit to provide fire safety advise and also the installation of free smoke detectors in the home if required.

Notice of High Fire Risk - Condition Orange

The Department of Agriculture, Food and the Marine issued its 7th Notice of High Fire Risk (Condition Orange) of 2025 on the 15th May. The Notice was for all areas where hazardous fuels such as gorse, heather, dried grasses and other vegetation exist. An interview with Colum Frawley, Acting Senior Assistant Chief Fire Officer was aired on Clare FM. The interview highlighted the need for landowners and members of the public to exercise caution and take all necessary measures to prevent the occurrence of wildfires and not engage in any activities that could cause wildfires. The public were urged to be vigilant and to report any uncontrolled or unattended fires immediately to the fire service. Despite the notices, Clare County Fire & Rescue Service have attended 10 wildland fires since the 1st May 2025.

Interviews for Driver Mechanics

As part of the WRC Agreement for the Retained Fire Service, it was agreed that there would be a minimum crew of 12 personnel in each fire station and that the role of Driver Mechanic would remain. There would be 4 no. Retained Officers (Station, Sub Station, Driver Mechanic) in each Fire Station. In April 2024, it was agreed with SIPTU locally that the complement of officers in each station would include an additional Driver Mechanic position (regrading a firefighter position effectively). Interviews have taken place and the successful applicants have been informed.

Waste Enforcement

Multi-Agency Checkpoints

Multi-Agency checkpoints were carried out on Tuesday 27th May for two locations on the N85. In attendance were members of An Garda Síochána, Waste Enforcement Regional Lead Authority (WERLA), National Transfrontier Shipment Office (NT-FSO), Department of Agriculture, Food and the Marine (DAFM), Revenue, and the Department of Social Protection. (DSP). The Waste Enforcement team check that vehicles transporting waste comply with S.I. No. 821/2007 - Waste Management (Facility Permit and Registration) Regulations 2007.







Inspections of Permitted and Unpermitted Sites

Inspections of 2 Waste Facility Permitted sites and 4 Certificate of Registration sites were carried out by the Waste Enforcement team in May to monitor compliance with their permits, to achieve positive environmental outcomes for the receiving environments. A further 2 sites were inspected because of Plan-

ning referrals, and 2 sites were inspected on foot of complaints received.

Fines issued under the Litter Pollution Act 1997, As Amended

A total of 7 litter fines were issued in May, under the Litter Pollution Act, 1997. Appropriate time will be allowed for payment, thereafter reminder letters are issued.

Enforcement Notices and Warning Letters under the Waste Management Act 1996

In May, 4 warning letters were issued under the Waste Management Act 1996, as amended. These sites are being monitored for compliance.

Abandoned Vehicles

We received 5 abandoned vehicles reports in May and are currently investigating these in line with Clare County Council's policy we continue to be assisted by the Municipal Districts.

Environmental Monitoring (Illegal Dumping/Litter)

The Waste Enforcement Team continued to respond to waste and litter-related complaints in May. A total of 50 complaints relating to litter (7) and waste (43) were received in May. All of these are currently being investigated, followed up and appropriate enforcement action will be taken.

Anti-Dumping Initiative

Clare County Council secured €93,000 under the Anti-Dumping Initiative 2025. This is to be spent on a variety of projects, including Mattress Amnesty days, Clean-ups, and Education and Awareness Campaigns.

Kilkee Green Hub

Call-back visits were made to Kilkee businesses to reinforce the message of best practice in waste management. 11 businesses were visited and encouraged to participate in the initiative. Each participating business must demonstrate their actions taken to reduce waste; and to segregate waste produced. Clare County Council will promote them as "Green Businesses" in return for their buy-in.

CLIMATE ACTION



Projects which are funded under the Community Climate Action Programme are in the implementation phase. Groups have eighteen months to complete their project. Some of the actions undertaken this month include;

- West Coast Surf Club has installed two water refill stations with the help of the West Clare MD. These are located in Spanish Point and Lahinch. This implements action N3.6 of our Climate Action Plan 'Support the Development of smart water stations across the county to reduce plastic bottle waste'. Added value benefit to this project are public
- health and hydration, reducing plastic waste lowering carbon footprint as well as economic benefits for individuals in reducing the need for purchased bottled water.
- **Doonbeg Tidy Towns** have purchased an e-cargo trike for use by tidy towns volunteers.
 - **Inagh Development** They have also carried out native planting in their community. Added value benefit to this project is the sequestering of carbon, cross generational community awareness around biodiversity, increasing ecosystems resilience and enhancing the natural beauty of the village.

Education and Awareness

The over 60's Climate Course continued this month. Cllr Antoinette Baker Bashua (Deputy Mayor of Ennis) welcomed the students on the day and explained the role of Clare County Council to them. Staff from the Climate, Environment, Housing and Integration Team delivered the Energise workshop to the students. Each staff member explained about what their role was within Clare County Council and what their section does. The workshop focussed on energy, well-being and safety.







TY Film Project: The awards for the Rubbish Film Festival took place this month. The Rubbish Film Festival is a digital arts education programme that aims to inspire students' creativity and environmental consciousness. Designed for Transition Year Students, it provided students in County Clare with a chance to share their artistic abilities, raise awareness of environmental issues like climate action, and pick up some new digital storytelling techniques. Colaiste Muire won the award for the best film in the Clare awards and also received second place nation-

ally in the competition. St. Joseph's Secondary School, Spanish point film received the runner-up award in Clare, with Scariff Community College receiving first place for their poster in the Clare Awards. The climate section with support from the Creative Communities fund promoted The Rubbish Film Festival in five secondary schools in Clare this year.







Clare County Council took part in Marchathon in March this year. Marchathon is a fun team Step Challenge that takes place

in March each year. It is open to staff and students of workplaces and third level campuses that are partners of the Smarter Travel programme. Clare County Council came 16th overall nationally and were the second highest - ranked Local Authority to take part. The winning team in Clare County Council 'The Winners' from Ennis MD averaged an impressive 446,160 average steps for their team. Well done to Julie, Lily (Missing from Photo), Marie, Michelle, Niamh and Ryan on their amazing efforts during the month.





Clare County Council is a Sustainable Development Goals Ambassador this year. As an SDG Ambassador we advocate and promote the SDGs and sustainable development. We also integrate the SDGs into our activities. As part of this commitment, we have procured access to the SDG Accelerating Action tool. The Accelerating Action tool enables Clare County Council to apply and report the Sustainable Development Goals effectively. The Climate Team organized a training session on how to use this software, with thirteen members of staff taking part in the training in April.





The Climate Team were invited to attend the fourth Annual Shared Island Forum. This event is part of the Government's Shared Island Initiative to engage with all communities and political traditions on a shared future on the island, underpinned by the Good Friday Agreement. The keynote address was delivered by Taoiseach Micheál Martin TD. One of the panel sessions focussed on Shared Island Investment. Talks by Dr. Derek McLoughlin from the LIFE IP Wild Atlantic Nature project and Prof Mark Emmerson, Co-Director of the Co-Centre for Climate + Biodiversity + Water.
