It was noted there are a number of further requests for Deputations contained in the May Notice of Motions: Organisation of National Ex Service Personnel, Southern Regional Assembly, Irish Red Cross & Clare Leader Forum.

#### 4. Any other business.

The Chief Executive updated the members on the following items:

- Update on Shannon Embankments –report from the geotechnical study which involved all the agencies is due in the coming weeks. A meeting is to be arranged with the Minister to seek funding.
- Correspondence received from the Department confirms that no further funding is available for storm damage for 2013/2014. The members requested that the request be pursued further with the Department as commitments were made by government at the time.
- Outstanding balances on the General Municipal Allocations for three of the Municipal District areas. The members pointed out that the GMA budgets for their respective areas have been allocated and agreed and Councillors have been making every effort to work with the Senior Executive Engineers to complete projects.
- Consultants are being appointed to develop the Ennis Economic Strategy to map out a Plan to 2040, identifying key strategic sites, and with a particular emphasis on employment. It is proposed to fund the costs over two years.

An item was raised relating to the approval of expenditure on a recent France/Guingham twinning event.

This concluded the business of the meeting.
