# Item 12. Briefing by Chief Fire Officer at 3:00 p.m. regarding new Building Control Regulations.

Angela Naughton, Senior Assistant Chief Fire Officer and Adrian Kelly, Chief Fire Officer briefed the members on the new Building Control Regulations which came into effect on 1<sup>st</sup> March, 2014 and the main points were:

- The new requirements shall apply to the design and construction of a new building, the extension to a dwelling involving a total floor area greater than 40 square metres and works which require a Fire Safety Certificate
- 4 certificates will be required

- There are new roles and responsibilities for the Building Control Authority, the owner, the builder and the assigned certifier
- The assigned certifiers have to be either a registered architect, chartered engineer or a registered building surveyor. They must develop a site inspection plan of appropriate frequency and use professional judgement to consider type of building, complexity of construction method, work relating to fire etc. They must also inspect, record their findings and coordinate inspections with other sub certifier (electricians, plumbers etc.).

The Mayor thanked Ms. Naughton for her presentation and opened the debate to the floor. Members raised queries in relation to the meaning of "competent builder", what is meant by training, experience and knowledge, will this impact on planning applications in process, is there any waiver scheme for voluntary organisations etc.?

In response Ms. Naughton stated that there is no one clear definition of the above and that judgement has to be used by the owner as to who is or is not competent and that the builder has to be willing to sign the documents (which are legal in nature) and state they are competent to carry out the works and have the relevant training, experience and knowledge to do so.

She also confirmed that there is no waiver scheme in place for voluntary organisations etc. in relation to these regulations.

The meeting was adjourned for ten minutes at 15:45 p.m. and upon resumption it was agreed to vary the business of the meeting in order to finish item 12.

Discussion continued at this stage and Mr. Kelly and Ms. Naughton responded to further queries raised by the members.

The Mayor stated that a submission on this issue had been sent from the relevant S.P.C. to the Minister and the following resolution signed by Cllrs. T. McNamara, P. Daly, P. McMahon, P. Keane, R. Nagle, M. Hillery, B. Chambers and P.J. Kelly was agreed by all members present.

"That this Council calls on the Minister for Environment, Phil Hogan, T.D., to amend the Building Control Amendment Regulations S.I. No. 9 of 2014 legislation and exempt one off private dwellings and extensions from same."

# Congratulations.

# Item 7. Draft Traveller Accommodation Programme 2014-2018.

Report dated 28<sup>th</sup> January, 2014 from Bernadette Kinsella, Director of Services, Housing, Cultural and Emergency Services was circulated with the agenda. The report states that by Circular Housing 23/2013 dated 2<sup>nd</sup> August, 2013 the Minister for Housing and Planning Ms. Jan O'Sullivan, T.D., directed that relevant housing authorities prepare a Traveller Accommodation Programme for the years 2014-2018, and specified 30<sup>th</sup> April, 2014 as the latest date by which the

Traveller Accommodation Programme must be adopted. The Circular also directs that a review of the adopted Programme should be carried out not later than 31<sup>st</sup> December, 2016.

The report before the meeting outlined that the Draft Traveller Accommodation Programme 2014-2018 will focus on 4 areas as follows;

- Provision of permanent accommodation to replace mobile home accommodation.
- Refurbishment of vacant accommodation where there is an identified demand
- Improvement and extension of accommodation and environs where there is a need and works are feasible
- Provision of occupational, educational and recreational facilities.

The following resolution was proposed by Cllr. J. Flynn and seconded by Cllr. C. Curtin.

"In light of requests made by the L.T.A.C.C., C.D.P. and Clare County Council requesting the Minister to defer the adoption date that pending clarification the Draft Traveller Accommodation Programme 2014-2018 not be adopted until after the Local Elections in May 2014."

The Mayor declared the Plan adopted subject to the wording on page 8 be changed from "managed regional approach" to "managed national approach".

#### **National Diaspora Centre.**

The County Manager announced that Clare County Council intends to submit a bid to develop and operate the National Diaspora Centre which has been proposed by Government. The Council are examining a number of locations in the Bunratty area of Clare and are working in conjunction with Shannon Heritage on an overall bid proposal which was backed by the majority of the members present.

### Item 8. Proposed Draft Clare Co. Renewable Energy Strategy 2014- 2020.

At the outset of this item Cllr. J. Flynn excused himself from the meeting due to a potential conflict of interest.

Report dated 3<sup>rd</sup> March, 2014 from Gordon Daly, Senior Planner was circulated with the agenda. The report states that one of the key objectives of the Clare County Development Plan 2011-2017 is to prepare a Renewable Energy Strategy. This will build on and support the Clare Wind Energy Strategy which already forms part of the County Development Plan. It is also an objective of the County Development Plan to promote County Clare as a low carbon county as a means of attracting inward investment.

The report before the meeting noted that the Renewable Energy Strategy complies with the requirements of the Habitats Directive and Strategic Environmental Assessment.

The report as circulated was noted by the members present. Mr. Daly outlined to the members that the Council will now commence the process of a Variation of the Clare County Development Plan 2011-2017.

#### Item 9. Planning and Development (Planning Enforcement) Policy Directive 2013.

Report dated 3<sup>rd</sup> March, 2014 from Gerard Dollard, Director of Services and Ennis Town Manager was circulated with the agenda. The report states that in May 2013, the Minister for Housing and Planning issued a Policy Directive under Section 29 of the Planning and Development Act 2000, as amended. The provisions of the Directive provide, inter alia, for the presentation of an Annual Report on enforcement activities to the Elected Members of the local authority and subsequently to the Minister. The Council has prepared the first such report to cover the year 2013.

The following was reported in terms of investigating complaints of unauthorised development for the period 1<sup>st</sup> January, 2013 to 31<sup>st</sup> December, 2013.

- The number of new complaints received over this period was 123.
- The number of actual warning letters issued over this period was 323. The total number of files from which these warning letters issued was 240. In some cases these warning letters relate to ongoing complaints received before 2013.
- The number of enforcement notices issued during 2013 was 105. The total number of files from which enforcement notices issued was 76. In some cases these enforcement notices relate to ongoing complaints received before 2013.
- During 2013, 107 cases were closed. These included complaints received during 2013 but the figure is also a reflection of efforts to satisfactorily resolve a backlog of cases.
- Court activity 4 new cases were referred for legal proceedings for non-compliance with enforcement notices in 2013. However, the enforcement unit also continued to progress 7 cases and finalise 3 cases which had been initiated in previous years.
- Quarries the total number of enforcement notices issued under 261A activity was 10.
   A large number of reviews were made to An Bord Pleanála on foot of Section 261A determinations and the enforcement unit are still awaiting the decision of the Bord on some of those files. In addition decisions of the Council/An Bord Pleanála are currently the subject of judicial review proceedings in three cases.

The report as circulated was noted by the members present.

# Item 10. Draft County of Clare (Presentation, Storage and Segregation for the Purpose of and in the Course of the Collection of Household and Commercial Waste) Bye-Laws, 2014.

Report dated 4<sup>th</sup> March, 2014 from Paul Moroney, Senior Engineer, Environmental & Water Services Directorate was circulated with the agenda. The report states that Clare County Council has finalised the process of updating the present bye-laws regulating the presentation and collection of waste within the County, which have been in place since 2007 and are known as the 'County of Clare (Presentation and Collection of Household Waste and Commercial Waste) Bye-laws, 2007. The purpose of the existing bye-laws is to regulate the manner in which households and commercial premises store and present their waste for collection by authorised waste collectors.

The Draft Bye Laws have now passed the Public Consultation Stage and an update to the Draft was presented to the Strategic Policy Committee in November 2013. Clare County Council, having considered the Submissions on the current bye-laws regulating the presentation and collection of waste within the county, made a number of changes, mainly to definitions following this process.

The proposed draft bye-laws will be known as the 'County of Clare (Presentation, Storage and Segregation for the Purpose of and in the Course of the Collection of Household and Commercial Waste) Bye-Laws, 2014 and will apply to all the administrative area of County Clare including the Town Council areas of Ennis, Kilrush, Kilkee and Shannon. Similar bye-laws were introduced by Limerick County Council in January, 2012 and have been in place for a number of years in County Leitrim and appear to be operating quite successfully.

"That the County of Clare (Presentation, Storage and Segregation for the Purpose of and in the Course of the Collection of Household Waste and Commercial Waste) Bye-Laws, 2014 be adopted pursuant to Section 35 of the Waste Management Act, 1996, as amended, and in accordance with Part 19 of the Local Government Act, 2001."

In relation to the proposed "compulsion" clause for Household Waste Collection, queries were raised in relation to exemptions. In response Paul Moroney confirmed that the shared bin option still applies but evidence of same must be produced i.e. signed declaration by both parties and also if using the recycling facilities then receipts should be kept as proof.

#### Item 11. Funding for repairs and associated costs following Severe Weather.

The Mayor took items 11, 16, 17 and 36 in conjunction with each other and this was agreed by all members present.

Correspondence dated 27<sup>th</sup> February, 2014 from the National Directorate for Fire & Emergency Management, Department of Environment, Community & Local Government together with report from Tom Tiernan, Senior Engineer, dated 5<sup>th</sup> March, 2014 was circulated to the meeting.

The report states that the submissions made to the Department of the Environment already are as follows:

• Report which was issued at the special Council Meeting held on January 10<sup>th</sup> and reflected, in outline terms, details of the damage inflicted up to and including January 6<sup>th</sup>.

- Clarifications pertaining to 1 above.
- Report dated February 10<sup>th</sup>, 2014 which is an updated version of the report referred to at No. 1 above and reflects the additional damage caused by the storm of February 1<sup>st</sup>.
- Clarifications pertaining to 3 above.

The report continues to say that the allocation confirmed in the Department of the Environments letter of February 27<sup>th</sup> is based on the information provided under Nos. 1 and 2 above. As is evident in the letter, allocations have been made in relation to our emergency response costs up to January 27<sup>th</sup> (€08,878), roads infrastructure (€2,094,925), piers and harbours (€273,000), tourism infrastructure (€979,200) and coastal protection restoration(€8,276,433). The element pertaining to coastal protection strengthening works (€12,128,860) which relates to coastal protection improvements we had proposed has been passed on to the OPW for further consideration. A sum of €1,582,079 is allocated in respect of Other Facilities.

# Item 16. Weather related damage.

Ar moladh Cllr. P. McMahon Cuidithe ag Cllr. R. Nagle, P.J. Ryan agus P. Daly

"In view of the fact that neither Government nor E.U. Assistance is expected to address the high costs to Clare County Council of recent weather related damage and that those events will recur on a frequent basis, that the Manager be requested to prepare a report on the impact of the Council finances for the next decade from weather related damage."

#### Item 17. Repairs to storm damage.

Ar moladh Cllr. M. Hillery Cuidithe ag Cllr. R. Nagle

"That the Manager would inform Clare County Council of the amount of funding County Clare will receive from the €70 million allocated by the Government nationwide for repairs to storm damage and the locations to benefit from it."

#### Tom Tiernan, Senior Engineer, Transportation replied as follows to both motions:

"Councillors are aware of the letter dated February 27<sup>th</sup> last from the Department of the Environment which confirms the availability of an allocation of €16.206 m. in response to the Council's submission in respect of damage caused by storms in late December, 2013 and early January, 2014. A sum of almost €609,000 was also confirmed to cover the Council's response costs and the costs associated with implementation of immediate necessary works. Further consideration is being given in respect of a further €12.129 m. – a sum sought by the Council to cater for enhancement requirements of coastal protection infrastructure in some areas.

We have not yet received a response on foot of our application for funding to deal with the additional damage caused by the storms which occurred in February."

# Item 36. County Clare's Coastal Defences.

Ar moladh Cllr. G. Keating

Cuidithe ag Cllr. J. Arkins agus B. Slattery agus glacadh leis

"That Clare County Council request the Government to establish a multi annual funding programme for the restoration, upgrade and refurbishment of County Clare's coastal defences, coastal roads, beaches and promenades and that the various departments would be coordinated by one Senior Department Official. This would facilitate prioritisation by the Council of the individual projects and the preparation of design and tender documents in an orderly manner having regard to the seasonality of the works and their impact on the Tourist Industry."

### Tom Tiernan, Senior Engineer, Transportation replied as follows:

"As Councillors are aware, a sum of more than €6.2m. has been made available recently to the Council in response to its application for funding to cover costs of damage inflicted on public infrastructure during the storms of December and early January. The Office of Public Works is presently giving consideration in respect of a further €12.129m. – a further component of the same application. Once clarification is received from Government regarding some queries in relation to the recently announced allocation which is very welcome, a draft programme of works will be prepared – taking account of priority, environmental factors, planning factors, tourism related factors, etc. It is envisaged that a multi-annual programme will evolve – the Council will be kept informed in this regard."

The Mayor thanked Tom Tiernan for his report and opened the debate to the floor. Queries were raised in relation to whether consultation will take place with councillors prior to any decisions being made as to what is priority, will the programme need government approval, who has responsibility for the coastline and its protection, what is the criteria for priority projects, what is meant by "other facilities"?

In response it was stated that councillors will be consulted and kept up to date on an ongoing basis and at present it is at the very early stages of considering any programme and the council are still awaiting response from the department on certain issues. The main emphasis will be on public infrastructure but will support and facilitate others where possible. The council is still awaiting clarity on who is responsible for what in relation to things that are not public infrastructure as several agencies are involved.

As this item was not completed before the finishing time of 18:30 p.m. it was agreed to finish same at the adjourned meeting.

#### Item 21. Tree cutting.

Ar moladh Cllr. C. Crowe Cuidithe ag Cllr. P.J. Kelly agus glacadh leis

"That Clare County Council allocate additional money to be spent on priority tree cutting in each electoral area"

# Tom Tiernan, Senior Engineer, Transportation replied as follows:

"Clare County Council has been and where necessary is continuing to deal with trees in public areas which were blown down or compromised during recent storms – particularly the extreme high wind storm event of February 12<sup>th</sup> last. An application for recoupment of the Council's envisaged costs in this regard is included with our application submitted to the Department of the Environment in respect of storm damage which materialised in February.

If additional money is to be allocated by Clare County Council to facilitate priority tree cutting in public areas, it will mean a further reduction to other important areas of roads maintenance budgets. Details of the proposed 2014 Roadworks Programme will be presented to the Council at the April meeting."

#### Item 29. Broadband.

#### Item 14. Tourism in Clare.

Ar moladh Cllr. J. Flynn Cuidithe ag Cllr. C. Curtin agus glacadh leis

"In light of the importance of employment in tourism in Clare and the launching of the Wild Atlantic Way through the county that Clare County Council commit to pass on resultant cost savings as envisaged in the 2014 Local Government Reform programme to all businesses, including hotels and Accommodation providers, in the form of reduced Commercial Rates."

### Gerard Dollard, Director of Services replied as follows:

"The Council very much welcomes the launch of the Wild Atlantic Way and has worked very closely with Fáilte Ireland to ensure that the project can be maximised for the benefit of the county. The Council is convinced that such a major tourism initiative marketed on an international basis offers a very strong platform to promote economic activity and create enterprise, particularly in the tourism sector.

The Council has adopted its overall Budget for 2014 and, as the Members will be aware, the securing of a balanced Budget was not without difficulty. In the preparation of each Budget, all savings that can be made are taken into account and, in this regard, there has been a very significant reduction, particularly on the payroll side in recent years. These savings have greatly assisted in meeting the shortfall in income resulting from the reduction in grants and other income sources. As such, all cost savings to date have been taken into account in the budgetary process.

It is difficult to envisage where further cost savings can be made while at the same time the Council is taking on new areas of activity arising from the Local Government Reform Programme."

# Item 15. Development contribution.

Ar moladh Cllr. J. Flynn on behalf of Cllr. S. McLoughlin Cuidithe ag Cllr. G. Flynn agus glacadh leis

"I am asking this council to reduce the development contribution by 50% to stimulate investments and developments as this will create jobs in the county."

# Gerard Dollard, Director of Services replied as follows:

"Clare County Council adopted a revised Development Contribution Scheme in September 2013 following an extensive public consultation process.

There is a full exemption from development levies for:

- new aviation related enterprises at Shannon Airport and adjoining lands. Such enterprises
  include Airport operational activity and uses complimentary to the operation of the
  Airport.
- a complete exemption for marine related industry on strategic sites along the Shannon Estuary.

The scheme, as adopted, also contains the following provisions:

- a 33% reduction in the normal rate of development contributions for new businesses grant-aided or supported by I.D.A./Enterprise Ireland with job creation potential.
- a 33% reduction in the normal rate of development contributions to encourage industrial development is applicable to permissions for expansion to existing manufacturing or industrial facilities.

- a 33% reduction in the normal rate of development contributions is applicable to nonresidential and living over the shop residential developments to support town centre development.
- a 33% reduction also applies to renewable energy projects that do not supply electricity to the National Grid.

Any amendments to the Development Contribution Scheme require an extensive public consultation process and consideration by the Elected Members. The Scheme, as adopted by Council in 2013, provides for reduced rates of development levies and at the same time further significant reductions (in some cases a full waiving of any charge). These provisions are designed to stimulate and promote investment and developments that will result in job creation within the county."

### Item 19. Council Plant Depots.

"That the Directors of Services, Infrastructure and Corporate Affairs list the Council Plant Depots among the 23 listed in the County at the January meeting which have E.S.B. and Water Supplies together with permanent storage capacity and the plans to provide similar facilities at the remaining depots to facilitate their enhanced role with the delivery of services in the new Municipal Districts and in this context an up-date be provided on the current planning for the amended structure arising from the implementation of the Local Government Reform Act 2014."

# Tom Tiernan, Senior Engineer, Transportation replied as follows:

"The 23 depots referred to are listed in the table below along with details pertaining to their capacity for storage and indicating whether or not they have power and/or water supplies. Note that while all depots have capacity for storage of materials (outdoor only in some cases) 12 have a power supply installed and 15 have water supply. Notwithstanding the fact that it is likely that the boundaries of the new Roads Areas will correspond with the new Municipal District boundaries, it isn't envisaged that the role of depots will change significantly – for the present at least. They are spread reasonably well around the county and by and large they are adequately serving the purpose they are intended to serve. In the past the practice has been that individual depots are upgraded in whatever manner appropriate as particular needs may arise in the areas where they are located. No decision has been made to change the role of depots arising from the introduction of the MD structure and therefore there is no overall plan to invest in them at present. This situation can be reviewed once Municipal Districts are operating for a period.

# Anne Haugh, Director of Services replied as follows:

"The Service Level Agreement with Irish Water was signed by the County Manager on  $23^{rd}$  December 2013 and became effective from  $1^{st}$  January 2014.

Arrangements will be made to circulate the Service Level Agreement in soft copy to all Members."

<sup>&</sup>quot;That the Service Level Agreement between Irish Water and Clare County Council be made available to the Elected Members of this Council."

#### Item 22. Roadside trees.

Ar moladh Cllr. J. Cooney Cuidithe ag Cllr. C. Crowe agus glacadh leis

"That Clare County Council put a policy in place that all road side trees are checked, limbed and removed if necessary in the interests of road safety."

#### Tom Tiernan, Senior Engineer, Transportation replied as follows:

"The vast majority of roadside trees are located in the roadside boundary structures or inside private properties adjacent to the public road – in both cases the responsibility for checking and managing such trees lies with the relevant property owners – this is clearly set out under Section 70 of the 1993 Roads Act. Therefore, with regard to trees which are located near public roads and are the responsibility of private property owners, there is no need for a policy as the law is clear in this regard and this notice of motion serves as a timely reminder to property owners in this regard.

With regard to trees in public areas which may be compromised, the Council has similar responsibilities and where it is aware of public or road safety issues associated with any such trees, arrangements are put in place to deal with same as a matter of urgency."

#### Item 23. Tenant's Handbook.

Ar moladh Cllr. P. Murphy Cuidithe ag Cllr. P. McCarthy agus glacadh leis

- "With reference to the Clare Local Authorities Tenant's Handbook, and the categorisation of repairs and the appropriate response times I wish to receive the following information:
- a) Are the contractors aware of when these calls are logged and the appropriate response times?
- b) Are the contractors monitored on their performance with regard to responding to a call and completing the works required?
- c) How are these works allocated to a given contractor, ie, is there a lottery system in place?
- d) Do contractors ever lose a job allocation due to not meeting the appropriate response times?"

### Siobhan McNulty, A/Senior Executive Engineer replied as follows:

- "a) The severity and nature of the maintenance call is relayed to the appointed Contractor. The responsibility for ensuring that response times are achieved rests with the Local Authority and not the Contractor. We are not aware of any maintenance call that has not been responded to within the allotted response times as outlined on page 21 of the Tenants Handbook.
- b) Clare Local Authorities have a Framework in place for Building Contractors and are in the process of finalising the Frameworks Agreements for Plumbers and Electricians. These framework agreements provide for performance evaluations, which are undertaken at least annually. At present there is no formal system to monitor and evaluate response to maintenance calls, however, if a Contractor persistently failed to respond to calls, or carried out substandard works, Clare County Council would not re-engage a Contractor who was not delivering the required service.

The present system of allocation of work with a value of less than €1,000 to Building Contractors is by rotation from the established Framework Agreements. At present response maintenance for Plumbers and Electricians is from a panel however the Frameworks Agreements for Plumbers and Electricians is due to be finalised by the 14<sup>th</sup> March 2014 and then participants will be called off in rotation.

d) The Clerk of Works for the area monitors Contractors performance and outcomes. If a Contractor fails to attend a job the Clerk of Works can and will redirect the call. I am not aware of a situation in the recent past when this issue may have arisen."

#### Item 24. Damage to public roads.

Ar moladh Cllr. P.J. Kelly Cuidithe ag Cllr. R. Nagle agus glacadh leis

"That the County Solicitor present a legal opinion detailing the options open to the Council to recover cost of damage done to public roads by third parties or their agents."

#### Item 25. Cumann na mBan.

Ar moladh Cllr. C. Crowe Cuidithe ag Cllr. P. Hayes agus B. Chambers agus glacadh leis

"On this year, the year of the 100th Anniversary of Cumann Na mBan we call on the council to name currently unnamed public buildings, roads or parks after Cumann na mBan or a member of Cumann na mBan from this county. It is fitting and appropriate that the council recognise the role of women in Irish life and those women of Cumann Na mBan who played such a vital role in the struggle for independence."

It was requested that the words "as appropriate" be added to this motion and this was agreed by all members present. Cllr. McCarthy stated she did not support the naming of buildings after people. A query was also raised in relation to a previous motion regarding the Magdalene laundries and whether this has been progressed or not.

### Item 26. Shannon Airport.

Ar moladh Cllr. P. McMahon Cuidithe ag Cllr. P. McCarthy agus glacadh leis

"That Clare County Council examine the implications for Shannon Airport and this county of the new Regional Structures which could cut off either Galway or Limerick from the Airport Region."

Cllr. P. McMahon and other members expressed concern at the proposed composition of the new Regions. The County Manager stated that Limerick-Clare-Galway should be in the same region and act as a counterbalance to Dublin and the east coast.

It was requested that this be an agenda item at the April meeting.

# Item 27. Funding to repair roads.

"That this Council request the Minister for the Environment to provide extra funding to repair roads recently damaged by adverse weather conditions and also funding to remove unstable trees from the road side."

#### Tom Tiernan, Senior Engineer, Transportation replied as follows:

"The submissions made to the Department of the Environment within the past two months regarding the storm damage have included within them a funding application to cover repairs/reconstruction of public roads adjacent to the coast which were damaged by coastal storms. Also included is a provision to deal with a number of non-coastal roads which are submerged and where as a result vehicular access has been or continues to be denied to residents. In addition, the same submissions have within them a request to cover the Council's costs in dealing with trees in public areas which were knocked or compromised during the storms particularly by the high winds of February 12<sup>th</sup>. "

#### Item 28. Irish Water.

Ar moladh Cllr. P. McCarthy Cuidithe ag Cllr. B. Meaney agus glacadh leis

"That Clare County Council, concerned at the implications for a number of projects in the County e.g. Shannon River Walks, seek clarification from Irish Water on its commitment to and obligations on the % for Arts Scheme."

#### Anne Haugh, Director of Services replied as follows:

"The percent for Arts Scheme applied to Capital Projects which were funded by the Department of Environment, Community and Local Government.

Now that Water Services Capital Projects are no longer funded by the Department, a query has been raised at national level with Irish Water to determine whether or not the scheme will continue to operate under the new arrangements."

#### Item 30. Job Creation in the Mid West.

Ar moladh Cllr. T. McNamara

Cuidithe ag Cllr. P. Hayes agus glacadh leis

"I call on Clare County Council to call on the Jobs, Enterprise and Innovation Minister Richard Bruton to review the Governments current policy with regard to Job Creation in the Midwest due to the high levels of unemployment and emigration in the region."

# Item 31. National Flag of Ireland.

Ar moladh Cllr. T. Mulqueen

Cuidithe ag Cllr. G. Flynn agus glacadh leis

"Call on the Department of An Taoiseach to instruct the relevant staff at all Government Buildings, Court Buildings, Local Authority Buildings on the correct guidelines and protocol regarding the use of the National Flag of Ireland."

As the time approached 18:30 p.m. it was proposed by Cllr. C. Curtin to extend the meeting in order to complete the agenda and this was seconded by Cllr. P. Daly and agreed by all members present.

The Mayor took item 34 in conjunction with item 32 as they were similar motions.

#### Item 32. Irish Postmasters Union.

"That this Council condemns the Government parties for their refusal to support the Irish Postmasters Union in their efforts to sustain the Post office network".

There were a number of dissenters in relation to the wording of this motion and after a show of hands the motion was carried with 9 voting for the motion and 6 voting against the motion.

#### Item 34. Irish Postmasters Union.

"That Clare County Council calls on the Minister for Communications, Energy and Natural Resources to adopt and implement the action plan as outlined by the I.P.U. (Irish Postmasters Union)".

#### Item 33. Iarnród Éireann.

"That Clare County Council calls on Iarnród Éireann to provide a proper lift at Ennis Station so that disabled persons can cross independently from one side of the platform to the other without having to suffer the ignominy of being pushed over a slipway on the line, and that pending the installation of a lift, platform 1 should be used for all embarking and disembarking passengers in the interim – and that Bus Éireann make level entry buses available for wheelchair users at the station."

# Item 35. Motorway from Gort to Tuam.

Cuidithe ag Cllr. O. Garry agus glacadh leis

"I request Clare County Council to make contact with the Minister for Transport, Leo Varadkar, T.D., with a view to getting a definite confirmation date for the start of the motorway from Gort to Tuam via Galway City, particularly as its commencement is long overdue."

#### Item 37. Disadvantaged Agricultural Areas.
