Cllr. J. Flynn withdrew from the meeting for this item.

Report dated 6<sup>th</sup> May, 2014 from Tom Coughlan, Clare County Manager was circulated prior to the meeting. The report states that the proposed Variation No. 1 to the Clare County Development Plan 2011-2017, to incorporate the Clare County Renewable Energy Strategy 2014-2020, was placed on public display from 14<sup>th</sup> March to 11<sup>th</sup> April. A total of 20 submissions were received within the statutory period.

Cllr. P.J. Kelly proposed that this item be deferred for further consideration. This was seconded by Cllr. C. Curtin. Gordon Daly, Senior Executive Planner pointed out that the new Council will have an opportunity to review the matter in six months time.

# Item 9: Consideration and noting of the "Draft Clare Biodiversity Action Plan 2014-2017.

Report dated 6<sup>th</sup> May, 2014 from Brian McCarthy, Senior Executive Planner was circulated with the agenda. The report states that the Draft Clare Biodiversity Action Plan 2014-2020 was placed on public display from the 2<sup>nd</sup> April, 2014 to the 22<sup>nd</sup> April, 2014. As part of this public consultation process, three submissions were received.

The Draft Clare Biodiversity Action Plan 2014-2017 proposes measures to conserve the biodiversity of County Clare, through raising awareness of County Clare's biodiversity, coordinating a targeted biodiversity education programme for all ages and abilities, recording the biodiversity of County Clare, the production of best practice guidance for biodiversity management and conservation, and supporting individuals and organisations working towards biodiversity conservation in County Clare.

Cllr. P. McCarthy raised some concern with regard to the omission of the wetlands in Shannon from the plan which was noted by Gordon Daly, Senior Planner who advised this would be incorporated during the completion of the final draft.

Subject to the above the members considered and noted the Draft Plan as presented.

### Item 10: Activities/achievements of Clare County Council from 2009-2014.

Report on the major achievements of the current Council was circulated with the agenda. The report outlined the principal achievements of the Council over the period 2009-2014. The report as circulated was noted by the members present.

### Item 11: Draft National Implementation Plan on homelessness.

Cllr. P. McCarthy advised the meeting that this plan was currently before the Government and that it is expected to be presented to the Council in the coming weeks for amendments or adoption. Homelessness Forum is endorsing the plan and will meet on the subject in a matter of weeks.

### Item 12: Attendance of Clare C.L.D.C. at 3:00 p.m.

Doirin Graham provided a presentation to the Council outlining the functions of Clare Local Development Company, which highlighted the great work achieved in the County over the years. Initiatives spearheaded by C.L.D.C. include the Clare Voluntary Group, Social Inclusion Programme, Local Training Initiatives and the Tus and R.S.S. Schemes.

Stephen Walsh, Chairman of Clare Local Development Company spoke about the proposed changes which would align Local Development Companies with Local Authorities.

Both representatives from Clare Local Development Company responded to queries and concerns from the elected members who supported the retention of the present structures for administering LEADER funding.

The following proposal was submitted by Cllr. B. Chambers, Cllr. J. Flynn and Cllr. P.J. Ryan:

"That the local Community Development Committee in Co. Clare would have a planning, oversight, co-ordination and monitoring role for local development, and would not seek to have an implementation role in the management and delivery of the Leader Programme".

This proposal was supported by the majority of the members present.

### Item 13: Signs.

Ar moladh Cllr. J. Flynn Cuidithe ag Cllr. C. Crowe agus glacadh leis

"Clare County Council commit to introducing more Irish of equal size lettering and status in its signage of new public equipment such as road signs, bin lorries. In addition receipts and other public materials given out of automated machines, etc. should give dual respect to Irish."

#### Michael McNamara, Senior Executive Officer, Corporate Services replied as follows:

"The Council has certain obligations under the Official Languages Act 2003 as have all public bodies. In keeping with these obligations new road signs and vehicles being acquired have signage of equal prominence in both Irish and English displayed.

The Council does not have bin lorries as we have not been involved in refuse collection for a number of years.

Parking tickets are in both Irish and English Languages."

### Item 14: Information signs.

Ar moladh Cllr. P. Murphy Cuidithe ag Cllr. C. Curtin agus O. Garry agus glacadh leis

"With reference to the widespread damage to information signs (directional, speed limits, etc.) across the county's road network as a result of the severe storms experienced this winter we would like to be briefed as to who is responsible for the erecting of and maintenance of these signs. We also believe that guidelines should be introduced to ensure that this kind of damage will not be replicated in the future, i.e. ensuring that poles are sunken to an appropriate depth and that adequate amounts of concrete are used. Finally, we are requesting that all of the damaged signage is re-instated as a matter of urgency."

#### Tom Tiernan, Senior Engineer replied as follows:

"Most of the damage to road signage through the storm period earlier this year occurred along the N67 and, therefore, I am assuming that this notice of motion relates to the N67. In this context, the responsible authority is the N.R.A. who have contracts in place to facilitate maintenance of signage along the National Route network. Given the foregoing, I asked the N.R.A. for observations on the notice of motion and its response is summarised as follows:

- All affected signs have been made safe and remedial works are underway.
- The winds earlier this year were exceptional particularly on the west coast and deficiencies were exposed in sign support systems particularly fingerpost signs. The systems used heretofore by the N.R.A. are C.E. approved but they have engaged with the industry with a view to developing an appropriate means of strengthening sign support systems.

- Where overturning of signs occurred due to poor construction or poor ground conditions the relevant contractor has been required to rectify the problem as soon as possible.
- On foot of the severe storm experience earlier this year, measures are being taken to replace damaged signs with higher quality replacements to minimise the likelihood of recurring problems. Unfortunately this has added to the time taken to carry out the requisite remedial works but should result in a more satisfactory outcome in the longer term."

#### Item 15: Fire and Emergency Operations Plan.

Ar moladh Cllr. J. Flynn Cuidithe ag Cllr. T. Mulqueen agus P. McCarthy agus glacadh leis

"To ask the County Manager (Chief Executive Officer) to provide an Annual Service Development Plan Review of Clare County Council's "Fire and Emergency Operations Plan" to allow for binding changes at National level to be taken into account".

#### Anne Haugh, Director of Services replied as follows:

"The National Directorate for Fire and Emergency Management approved a Project Initiation Document (P.I.D.), issued in May 2013, setting out guidance on the implementation process and projected timescales for the Keeping Communities Safe project.

Following the adoption of the Fire & Emergency Operations Plan, the next steps provided for in the P.I.D. will include the preparation of an Annual Service Development Plan by the Chief Fire Officer to prioritise and address the implementation of changes to current practices identified in the Plan. This will include for both changes at a local and at a regional level.

As the National Directorate for Fire and Emergency Management continue to provide guidance on Fire Service matters, implementation of same will be included in the Annual Service Development Plans. Where there may be policy changes required to the adopted Fire and Emergency Operations Plan, these will be brought to the attention of the Elected Representatives.

As set out in the Project Initiation Document it is intended that a review should be carried out of the Annual Service Development Plan, with a report prepared for the Local Authority Management Team. This review can be made available to the Elected Representatives for their information."

#### Item 16: Household tax, property tax and motor tax.

Ar moladh Cllr. C. Curtin Cuidithe ag Cllr. C. Crowe agus glacadh leis

"That the Head of Finance inform the Council of Household Tax, Property Tax and Motor Tax collected in Clare for the years 2012, 2013 and 2014 (to date)".

#### Niall Barrett, Head of Finance replied as follows:

"The table below sets out the amounts collected in Clare for Household Charge, Local Property Tax and Motor Tax in 2012, 2013 and early 2014.

#### Household Charge, Local Property Tax and Motor Tax.

The table below sets out the amounts collected in Clare for Household Charge, Local Property Tax and Motor Tax in 2012, 2013 and early 2014.

Household Charge was a charge levied on properties in 2012. This was collected by the council in 2012 with arrears of household charge collected up to the 1<sup>st</sup> July 2013. From the 1<sup>st</sup> July 2013 Revenue took over collection responsibility. From 1 July 2013, any outstanding Household Charge liability was included as part of the Local Property Tax liability for the property

Local Property Tax (L.P.T.) was a new tax introduced to replace the Household charge. This tax is collected by the Revenue Commissioners. In 2013 the tax was levied on a half year basis only, with a full year payable in 2014. The table above reflects the amounts published by Revenue as collected in 2013 and 2014 to April.

Motor tax collected includes on line transactions through the central website. 2014 amounts collected are up to 31<sup>st</sup> March 2014."

# Item 17: Water Charges.

Ar moladh Cllr. B. Meaney Cuidithe ag Cllr. J. Flynn agus glacadh leis

"This council requests that house holders and occupiers liable for the water charge but dependent on a septic tank are only charged the water element of the proposed water charge and can this be provided for in the Service level agreement between Irish Water and Clare County Council."

#### Anne Haugh, Director of Services replied as follows:

"The issue of charging house-holders for domestic water services does not form part of the Service Level Agreement and this function will be carried out directly by Irish Water. At present, the Commission for Energy Regulation has a public consultation document issued on the charging for water services for domestic use in respect of which submissions may be made. The consultation and information documents, listed in the Table below, are accessible on <u>www.cer.ie</u>.

#### Item 18: Commercial rates.

Ar moladh Cllr. P. Murphy Cuidithe ag Cllr. O. Garry

"As a means of boosting town centre business across County Clare I am proposing that commercial rates are levied on car parks at out of town retail centres. This would "level off the playing field" and promote smaller traders and businesses."

#### Niall Barrett, Head of Finance replied as follows:

"The amount payable by ratepayers is determined by two factors: the valuation of the property as set by the national Valuation Office and the Annual Rate on Valuation (multiplier) set by the council each year as part of the budget process.

The Valuation Act 2001 determines the basis for the valuation of properties by the national Valuation office. Car Parks where there is no charge levied are not separately valued for valuation purposes. Clare County Council cannot levy Commercial Rates where the property is not included in the valuation list (rate book).

It is a matter for national legislation for there to be a change to the basis of inclusion or exclusion of properties to be valued. I understand that this topic has been raised at a National level in recent months with a Private Members Bill proposed in the Seanad to amend National Legislation for the valuation for commercial rates of Car Parks at out of town retail centres."

A discussion took place surrounding this topic with some members expressing that they were opposed to this motion and following a vote by a show of hands the motion was lost with 9 voting against and 6 in favour of the motion.

#### Item 19: Health & Safety Policies.

Ar moladh Cllr. P.J. Kelly Cuidithe ag Cllr. J. Flynn agus glacadh leis

"That details of the Health & Safety Policy for workers in contact with the following be made available for discussion:

• Asbestos.

- Toxic waste
- Chemicals in both liquid and powder form."

# Anne Haugh, Director of Services replied as follows:

"Clare Local Authorities operates an Occupational Health & Safety Management System in accordance with the internationally recognised OHSAS 18001 Standard. This system comprises Occupational Health & Safety Policies, Procedures and Forms and has been externally validated and registered to the 18001 standard for CCFRS by the National Standards Authority of Ireland.

Please find attached the details of the following documents which outline the relevant policies and controls for Asbestos including disposal requirements and Hazardous Substances including chemicals in both liquid and powder form;

- Clare Local Authorities Occupational Health & Safety Policy.
- Procedure for the Management of Asbestos.
- Risk Assessment for working with Asbestos Cement Pipes.
- Risk Assessment for Hazardous Substances."

With reference to the Clare Local Authorities Occupation Health & Safety Policy, a query was raised with regard to when this policy came into effect and if any policy had been in place prior to the effect date. The County Manager advised that the Council are in compliance with all Health and Safety requirements which are prior agreed with the Health & Safety Authority.

# Item 20: Housing Grants.

Ar moladh Cllr. M. Hillery Cuidithe ag Cllr. P. Hayes agus glacadh leis

"That Clare County Council would provide the number of applications awaiting approval and the grant allocation by the Government in 2014 for the following schemes;-

- Mobility Aids Housing Grant Scheme.
- Housing Aid for Older People Scheme.
- Housing Adaptation Grant for People with Disabilities."

# Niall O'Keeffe, Administrative Officer, Housing Department replied as follows:

"Housing Adaptation Grant for Older People and People with a Disability (H.A.G.)

Housing Aid for Older People (H.O.P.)

Mobility Aids Grants (M.A.G.)

The Department of Environment Community and Local Government notified that the capital allocation €1,614,763, (including €322,953 from own resources) to Clare County Council to fund grants under the abovementioned schemes in 2014. The apportionment of this allocation under the respective headings is a matter for each local authority and is done in accordance with the Grant

Implementation Scheme adopted by the Council. It is expected that in the region of 250 - 300 applications will be funded this year under all headings.

# Item 21: Irish Water.

Ar moladh Cllr. J. Crowe Cuidithe ag Cllr. P.J. Ryan agus glacadh leis

"That Clare County Council request Irish Water to install generators in our Reservoirs in order to prevent disruption to our water supply as a result of E.S.B. power outages during severe weather events."

# Anne Haugh, Director of Services replied as follows:

"The lack of generators at several water and wastewater treatment plants was highlighted by the storm of 12<sup>th</sup> February last. Provision of generators, or of equipment necessary for connection to hired back-up generators, has been raised with Irish Water in discussions about the 2014 Minor Capital Works programme.

Clare's largest water treatment plant in terms of daily production – Drumcliffe, Ennis – already has a generator, provided within the new plant which came into operation in March 2009.

For the plant with the second highest daily production – Castle Lake, Kilmurry – the Council's submissions for the 2014 Minor Capital Works programme included a proposal to install a generator to operate all pumps and the treatment process, as well as smaller generators at reservoirs

in the Castle Lake network to operate chlorine boosting stations. No approval has yet been received from Irish Water for this proposal.

Information is being gathered with a view to making a proposal to Irish Water by Friday 9<sup>th</sup> May for generators, or for equipment to enable quick connection to hired-in generators, at a number of other major water treatment plants."

Cllr. P. Hayes wished to express his support to this notice of motion.

#### Item 22: Housing estates.

Ar moladh Cllr. P.J. Ryan Cuidithe ag Cllr. P. Hayes agus glacadh leis

"That this council would request the Minister for the Environment to release funds to enable Clare County Council take over finished housing estates as a matter of urgency."

It was noted that the Minister has now addressed this issue and the Mayor wished to compliment the Director in charge of the estates.

#### Item 23: Charges imposed on families.

Ar moladh Cllr. P. McMahon Cuidithe ag Cllr. P.J. Ryan agus glacadh leis

"That Clare County Council request the government to carefully examine the impact on families and individuals of massively increased charges imposed in recent years and introduce meaningful waiver systems."

#### Item 24: T.D./Senator and County Councillors.

Ar moladh Cllr. T. Mulqueen Cuidithe ag Cllr. B. Meaney

"Call on the Minister for Environment to amend the relevant legislation in relation to length of service for T.D./Senators and County Councillors to ensure that total service in each category cannot exceed 3 full terms or 15 years duration."

After some discussion with regard to this motion a vote was taken on a show of hands which deemed the motion lost.

### Item 25: Rural Development.

Ar moladh Cllr. P. Hayes Cuidithe ag Cllr. M. Kelly agus glacadh leis

"I propose that this council calls on the Taoiseach and the government to put in place a special department for rural development, with particular emphases on unemployment, and protection of services in the West of Ireland."

### Item 26: Ennis General Hospital.

Cllr. P. Hayes wished to have it noted that he was not happy with the response issued from the N.R.A. with regard to works which had taken place on the N18 in dealing with ongoing issues on this road. The Mayor supported these comments and it was agreed that the matter be followed up.
