# Minutes of the November Monthly Meeting of Clare County Council held in the Council Chamber, Áras Contae an Chláir, New Road, Ennis, Co. Clare on Monday, 10<sup>th</sup> November, 2014 at 3:45 p.m.

The Cathaoirleach, Cllr. John Crowe presided.

Their current lease expired on the 1<sup>st</sup> September last and they wish to renew the lease for a further five year period on the same terms and conditions which applied up to the 1<sup>st</sup> September last.

Item 8: Proposed Variation No. 2 to the Clare County Development Plan 2011-2017, to inter alia, incorporate the 'Strategic Integrated Framework Plan (S.I.F.P.) for the Shannon Estuary'

Consideration of the proposed Variation no. 2 to the Clare County Development Plan 2011-2017 and the "Chief Executive's Report to the Elected Members on Submissions received to the proposed Variation no. 2 to the Clare County Development Plan 2011-2017".

Making of Variation no. 2 to the Clare County Development Plan 2011-2017.

Chief Executive's Report to Elected Members on Submissions received to the Proposed Variation No. 2 to the Clare County Development Plan 2011-2017 was circulated to the elected members on 16<sup>th</sup> October, 2014.

The report states that the proposed Variation no. 2 to the Clare County Development Plan 2011-2017 seeks to incorporate the "Strategic Integrated Framework Plan (S.I.F.P.) for the Shannon Estuary" zone lands at 2 strategic locations – Inishmurry/Cahiracon and Moneypoint and replace the existing Chapter 14 of the Development Plan with a new chapter containing new text, policies and objectives.

The proposed variation was placed on public display from  $22^{nd}$  August to  $22^{nd}$  September. A total of 14 submissions were received within the statutory period. Each submission received has been considered. The next stage is for the elected members to consider the proposed variation to the Clare County Development Plan 2011-2017 and the Chief Executive's report.

1. To include all recommendations in the "Chief Executive's Report to Elected Members on submissions received on the proposed Variation no. 2 to the Clare County Development Plan 2011-2017, dated 16th October 2014;

## Item 9: Agreement pursuant to Section 85 of the Local Government Act 2001 between Clare County Council and Tipperary County Council for the Lough Derg Signage Strategy.

Report from Anne Haugh, Director of Services was circulated with the agenda. The report states that Tipperary County Council has agreed to act as lead authority for the implementation of the Lough Derg Signage Strategy in Counties Clare, Galway and Tipperary. This will involve the necessary procurement and erection of the signage on the Regional and Local routes around the Lough Derg Lakelands area as per the Lough Derg Signage Strategy.

For this purpose, it is necessary for Tipperary County Council to put a Section 85 Agreement in place with Clare County Council. This agreement will allow Tipperary County Council and the appointed Contractors to carry out works in the functional Area of Clare County Council.

The estimated cost for the procurement and erection of signage is €375,000. At the June 2014 meeting of the Lough Derg Marketing Group it was agreed that each of the local authorities would make a contribution towards the final implementation of the signage strategy for the Lough Derg Lakelands region. It has been agreed that Clare County Council will make a contribution of €25,000. The remaining funding has been sought as a Joint Project by the three local authorities through the €2m. Lough Derg Stimulus Fund that was announced in May 2014 by the Department of Public Expenditure and Reform Phase 4 Infrastructure Stimulus: Investing in Recovery and Growth.

Report dated 5<sup>th</sup> November, 2014 from Michael McNamara, Senior Executive Officer, Corporate Services was circulated with the agenda together with report from Gordon Daly, Senior Planner. The report states that it is proposed to develop a Greenway, circa 4.5 km. of a shared pedestrian and cycle facility on a route from Woodquay Car Park, Clonroad Beg, Ennis to Ballymaquiggan, Ennis.

Submissions were invited from the public in the local newspaper on the 5<sup>th</sup> September last. Details of the submissions received are outlined in the report.

The recommendation of the planning department is that the development as proposed would proceed subject to the conditions outlined in the report of the Senior Planner.

#### Item 12: From October Agenda - Curtha faoi bhráid na Comhairle ag Cllr. P.J. Kelly.

"That Clare County Council, mindful of successful challenges to a circular from a Government Department, seeks appropriate legal opinion of the lawfulness of recent circulars which have been financially punitive."

Report of John Shaw, County Solicitor in response to the above motion was brought to the attention of the members. The Chief Executive responded to a number of queries raised and advised that the vast majority of circulars do not impact on reserved functions. In response to Cllr. Kelly, he outlined that many circulars are explanatory and would not require a legal opinion.

#### Item 13: Budget.

#### Niall Barrett, Head of Finance replied as follows:

"I wish to reply as follows:

The unspent amount(s) in each budget programme for the 2013 financial year.

Set out below in the table is a comparison of actual expenditure to budget expenditure in each service division for 2013.

Expenditure was under budget in two areas, Division A Housing & Building and Division G Agriculture, Education, Health and Welfare. In those two cases there was also a reduced income.

#### If any amount was transferred from one programme to another.

Budgeted amounts were not transferred from one Division to another but form part of the overall financial result for the year compared to budget.

#### How the surplus (if any) was expended.

The overall financial result for the year was added to the cumulative opening deficit on the Councils Income and Expenditure Account.

### Details of legislative provisions which deal with un-expended finances at the end of a financial year.

Section 107 (2) of the Local Government Act 2001 states "Every local authority and joint body shall each establish and maintain financial systems, accounts, reporting and record keeping procedures, including the preparation of an annual financial statement, which are consistent with such accounting code of practice, or amendments to it, that the Minister may issue from time to time.

The Accounting Code of Practice for Local Authorities states the following:

"In the following circumstances a local authority may create a specific reserve for inclusion in the Statement of Financial Position (Balance Sheet).

#### **Amounts Specifically Provided in the Budget**

If an amount has been provided for in the budget (i.e. identified as a separate project) and remains unspent at the year-end, the amount unspent may be transferred from the Income and Expenditure Account to a specific reserve in the Statement of Financial Position (Balance Sheet). These transfers should not include amounts included under a general expenditure classification in the estimates and that remain unspent.

#### Amounts Set aside by Resolution of the Council

Amounts may be set aside by specific resolution of the council to be expended on specific projects in future years. These amounts must be transferred to a specific revenue reserve.

#### **Impact on Revenue Account Balance**

Before a transfer is made to reserves the Head of Finance should take account of the impact on the revenue account balance. After making transfers as provided in the adopted budget, a local authority should not make any further transfers that will result in the creation of a deficit for the year."

## Implications of unspent money for 2014 budgetary out-turns and ongoing consequences for income and expenditure proposals as part of the 2015 Budget.

Based on the preparation of the draft budget 2015 the divisions where expenditure is forecasted as being less than the adopted budget 2014 are Division C, Water Services, and Division G, Agriculture, Education, Health and Welfare. In both cases the lower expenditure is offset by a similar reduction in income in relation to the Irish Water Service Level Agreement, and the Recoupment of Higher Education Grants from the Department of Department of Education and Skills respectively, and does not impact on the 2015 budget."

The reply was noted by the members present and the Head of Finance responded to a number of queries raised. It was agreed that the Head of Finance would provide details of the amount of funds in place at 1<sup>st</sup> January 2014 in the revenue reserve.

#### Item 14: Rates.

Ar moladh Cllr. T. McNamara Cuidithe ag Cllr. J. Flynn agus glacadh leis

"As part of rates equalisation I call on Clare County Council to introduce a rates refund grant that would give a 10% reduction up to a maximum of €300 to commercial rate payers throughout County Clare."

#### Niall Barrett, Head of Finance replied as follows:

"2015 will commence the process of harmonisation of the rates between the previous Town Council and County Council areas within the new single rating authority area. The adjustment process, which may take up to a maximum of 10 years to complete, is referred to as the Base Year Adjustment (B.Y.A.) mechanism. The effect of the B.Y.A. in every local authority will be to neutralise any increase or decrease in rates in 2015 that would otherwise occur as a result of the rate struck by the members for the amalgamated authority as a whole. Ratepayers will pay no more or no less rates in 2015 than they did in 2014; with the exception that the town rates for Shannon and Kilkee will not apply.

The Commercial Rates equalisation process will begin in 2016 when the change in the Base Year Adjustment is determined as part of the budget process 2016 and each year thereafter. In the context of the 2016 budget process and later years, the council could consider a grant scheme to be phased in in parallel with, and in proportion to, the progress of the Base Year Adjustment changes. This would be a matter to be dealt with at budget time each year starting with the 2016 budget, and would include such items as the qualification criteria and the limits that would apply to the grant level."

#### Item 15: Collection of household charges in 2014.

Ar moladh Cllr. M. Hillery Cuidithe ag Cllr. B. Slattery agus glacadh leis

"That Clare County Council would state the amount collected including arrears in N.P.P.R. and other house hold charges in County Clare in 2014".

#### Niall Barrett, Head of Finance replied as follows:

"The N.P.P.R. charge was discontinued with effect from 2014. The Local Government Reform Act 2014 provided for a period, from March 2014 to 31st August 2014, during which time no new late payment penalties were applied to existing N.P.P.R. liabilities; with increased penalties applying thereafter During 2014 a significant amount of the N.P.P.R. charge, including late payment penalties, was received from the N.P.P.R. Bureau (which is the central collection point for the N.P.P.R. charge). In the first half of the year 2014, the council received income of €0.49m. as reflected in the result reported to council for the half year. In the third quarter to September 2014, the council received a further €0.75m., and to date in Quarter 4 the council has received €0.38m.

Household Charge was a charge levied on properties in 2012. This was collected by the council in 2012 with arrears of household charge collected up to the 1<sup>st</sup> July 2013. From the 1<sup>st</sup> July 2013

Revenue took over collection responsibility. From 1 July 2013, any outstanding Household Charge liability was included as part of the Local Property Tax liability for the property and is collected by the Revenue Commissioners."

The report as circulated was noted by the members present and the Head of Finance responded to a number of queries raised.

#### Item 16: Staffing arrangements.

The new Municipal District structures as you are aware were established and organisational change came into effect on 1<sup>st</sup> June, 2014.

I previously indicated to the Council that activity levels in the Municipal Districts would be carefully monitored.

Management's objective is to ensure that service delivery objectives are achieved. The level of activity will influence the assignment of staff to the Municipal Districts and indeed throughout the Organisation. The business needs of the Council and compliance with it statutory obligations are factors to be considered in the deployment of staff."

The report as circulated was noted by the members present and both the Chief Executive and Senior Executive Officer, Human Resources responded to a number of queries raised and referred to the embargo still in place and the extra costs associated with additional staff.

#### **Item 17:** Animal Welfare Services.

#### Anne Haugh, Director of Service replied as follows:

(a) Dogs: Seized - 396/Surrendered - 424.

**Horses**: Impounded – 25

1(b) **Dogs**: Re-homed - **411**.

**Horses**: Re-homed – **Nil**.

2(b) **Dogs**: Reclaimed by owner - **181**.

**Horses**: Reclaimed by owner – **Nil**.

(c) **Dogs**: Euthanised -228.

**Horses**: Euthanised – **25**.

Clare County Council only deal with Dogs and Horses. These figures do not include statistics from the animal welfare groups."

The reply as circulated was noted by the members present and Ms. Anne Haugh, Director of Services responded to a number of queries raised.

A Seanad located in the West with wider powers to look at social, rural, environmental, etc. impacts of National and EU draft legislation could become a Seat of Conscience to provide a counter balance to the Dáil, the Seat of political Power in the East. Ireland, Clare and Ennis this year are celebrating the High King of Ireland Brian Boru 1014 and are in the decade of Centenary celebrations including the Rising of 1916, Clare elections of 1917, etc. Clare and its Capital Ennis has demonstrated itself a cradle of democratic independent thinking during the 19th and 20th Centuries with for example 1828 and 1917 elections of O Connell and De Valera".

# Minutes of the Budget 2015 Meeting of Clare County Council held in the Council Chamber, Áras Contae an Chláir, New Road, Ennis, Co. Clare on Wednesday, 12<sup>th</sup> November, 2014 at 3:00 p.m.

The Cathaoirleach, Cllr. J. Crowe presided.

It was proposed by Cllr. C. Curtin and seconded by Cllr. P. Daly and agreed by all other members present that the meeting would be adjourned for 15 minutes until 3:29 p.m. to allow the Shannon Properties Group conclude their presentation to the Council.

The meeting commenced at 3:29 p.m. At the outset, the Cathaoirleach called on the Chief Executive to give a brief overview of the Budget. Mr. Coughlan advised the members that as a result of new legislation, a number of changes to the budget process had taken place this year. He raised a concern with regard to the rate of change and reform within the Local Authority sector and the scale of these changes are significant and challenging, despite this the Council have endeavoured to maintain budgets as much as possible in line with the 2014 Budget.

Mr. Coughlan highlighted the main aspects of Budget 2015 which included the fact that the Local Government Fund would not be available going forward and instead the Local Authority would have to rely on raising finances at a local level via the Local Property Tax. He reported that the Department of Transport had not yet advised of the roads allocation for 2015 but the Budget had been prepared on the basis of the same level of funding as that received in 2014. He reminded members that establishment of the L.E.O., the LCDC and PPN and the development of the Municipal Districts would have an impact on the Budget for 2015 and that although commercial rate levels would remain the same for 2015, the harmonisation process would be commencing in 2016. In relation to Water Services he stated that the Council has a Service Level Agreement with Irish Water.

He advised that a series of meetings to consider the preparation of the Draft Budget had taken place with the Corporate Policy Group and all members had been briefed on new changes to the process and the draft which had been presented for consideration had been the subject of intensive deliberation.

He concluded by thanking the Cathaoirleach, the Corporate Policy Group and all the Elected Members for their advice, assistance and constructive approach in reviewing the issues surrounding the Budget. He also thanked the contribution of all staff in the Council in preparing this Budget especially the staff in the Finance Department.

The Head of Finance addressed the meeting and outlined the main changes in the Budget process this year which included the introduction of new terminology and processes that would be involved in the harmonisation of the rates and calculation of the base year adjustment which will have no impact on the 2015 Budget but will be a consideration in 2016 and thereafter.

Cllr. P.J. Kelly raised a query with regard to the preparation of the Budget for the Municipal Districts and if consultation had taken place with the members of the Municipal Districts to arrive at their allocation. The Chief Executive replied to this query and advised that the General Municipal Allocation for each district has been discussed and agreed with the Corporate Policy Group and had been adopted by the four Municipal Districts.

#### Division A. Housing and Building

#### **Division D** Development Management

Ger Dollard addressed the meeting and provided a brief overview of activities for these areas. He reported that the vacancy level of local authority housing was relatively low at present, however traveller accommodation remained a challenge. The same provision has been made for housing grants for 2015 as that provided in 2014. In the area of Development Management, an increase of planning applications has been noted and this increase is expected to continue for 2015 which should result in an increase in revenue. The Council is obliged to pay for the staffing of the LEO and the creation of the PPN and LCDC will involve a public consultation process the cost of which the Council will have to cover. The area of Taking in Charge is being prioritised at present, however legal costs must be considered.

It has been positive year in terms of tourism development with the Cliffs of Moher reaching one million visitors in September. Work on the commemoration of 1916 will begin during 2015. A number of major projects are being looked at by the Council, all subject to funding including the acquisition and development of Holy Island and the creation of the National Diaspora Centre in Bunratty.

A number of queries were raised by members regarding these divisions which were all responded to by Ger Dollard. Mr. Dollard also drew the members attention to the Capital Reports contained in the Budget book relative to these divisions.

#### **Division E** Recreation and Amenity

#### **Division H** Central Management Charges

Niall Barrett, Head of Finance outlined the main issues covered within these areas, including the Library service, County Museum, Glór and the area of Information Technology. Cllr. C. Crowe asked that consideration be given to acquiring new and important artefacts for the County Museum if budget permits and thanked the Council for their recent acquisition of archive material concerning the late Patrick Brennan T.D.

A number of members also raised the issue of rolling of wifi for the libraries.

The Head of Finance highlighted details of the Capital Programme 2015-2017 contained in the draft Budget, which was noted by the members.

Anne Haugh provided an overview of activities within these areas and highlighted that as the Roads allocation had not yet been received, figures for 2014 had been inserted into the draft Budget until the allocation would be known which is not expected until sometime in the New Year. She reported that the Regional Waste Management Plan was currently at public consultation stage and this process would be continuing during 2015. An area for some concern is that the cost of recycling is increasing while grant allocations for the operation of recycling facilities have been reducing year on year. Income from the collection of wet waste at Council facilities has also been on the decline which is impacting on revenue budgets. Other areas where funding is decreasing includes the Control of Horses and Waste Enforcement Grants.

A number of queries were raised relating to these divisions in particular within the area of Irish Water, which were all responded to by Anne Haugh.

Anne Haugh also drew the members attention to the Capital Reports contained in the Budget book relative to these divisions.

The Cathaoirleach thanked the Chief Executive, Directors of Services and Head of Finance for their overviews and presentations and then opened the debate to the floor for observations/queries.

Dissatisfaction from many members was noted with regard to the fact that Road allocations are not available until after the Council is obliged to adopt a Budget and many felt that it was impossible to adopt a Budget while being in the position of not knowing revenue for the year ahead. The Chief Executive replied and advised that this has been the position for the past number of years and that despite this the Council were being asked to adopt the Budget or risk being dissolved as per legislation.

Cllr. J. Flynn and Cllr. I. Lynch queried where savings were generated by the abolition of the Town Councils. The Chief Executive replied that savings were not made directly as all staff are still employed by the Council and offices are still operating etc. but that efficiencies would be achieved going forward.

After some discussion on the matters raised, the Cathaoirleach asked that members needed to make a decision to either adopt or reject the Budget as presented or adjourn the discussion to a later date.

It was proposed by Cllr. R. Nagle and seconded by Cllr. B. Chamber and agreed by all members present that the meeting would be adjourned for a period of 10 minutes to allow discussion among the groups.

The meeting resumed after a 10 minute adjournment.

It was proposed by Cllr. J. Cooney and seconded by Cllr. G. Flynn that the Budget as proposed be adopted but subject to the Capital Funding allocation for 2015 of €50k being reduced to €50k to allow a further allocation of €50,000 to each of the Municipal Districts. The Head of Finance replied that this could be dealt with by way of the Annual Financial Statement and recommended that this proposal should not detract from the proposed Budget as presented being adopted at this point.

The following resolution was proposed by Cllr. J. Cooney and seconded by Cllr. G. Flynn:

"That pursuant to Section 103(7) of the Local Government Act 2001 the Draft Budget 2015 as presented by the Chief Executive is hereby adopted".

A number of members indicated their opposition to this proposal. The Cathaoirleach called a vote on this proposal which resulted as follows:
