# Minutes of the February Monthly Meeting of Clare County Council held in the Council Chamber, Áras Contae an Chláir, New Road, Ennis, Co. Clare on Monday, 9<sup>th</sup> February, 2015 at 3:45 p.m.

The Cathaoirleach, Cllr. John Crowe presided.

- At the outset the Cathaoirleach congratulated Adrian Kelly and the Council's Fire and Building Control Section on successfully maintaining their 18001 Safety Management Accreditation recently. The Council's Health and Safety Officer's role was also acknowledged in this achievement.
- The Cathaoirleach reminded members that the Mayor's Charity Banquet is taking place on 28<sup>th</sup> February and that tickets are still available and urged everyone to support this worthy event which will benefit 3 Clare based charities.

### **Item 3:** Minutes of the Corporate Policy Group Meetings.

The members noted the minutes of the meetings held on 5<sup>th</sup> January, 2015 as presented.

#### Item 4: Nominations to S.P.C.'s.

The Meetings Administrator reported that there was no update available on this and that the Council is still awaiting nominations from a small number of bodies.

#### **Item 5:** Monthly Management Report.

The monthly management report attached to the agenda included key activities in the principal service areas and was noted by the members.

#### Item 6: Draft Corporate Plan 2015 - 2019.

Report dated 4<sup>th</sup> February, 2015 from Michael McNamara, Senior Executive Officer, Corporate Services was circulated with the agenda. The report states that the Council are required to prepare a Corporate Plan pursuant to the provisions of the Local Government Act, 2001.

Revised guidelines in relation to the Corporate Plan were issued by the Department last November and the Council agreed at meeting held on 8<sup>th</sup> December last to extend the period for the preparation and adoption of the Corporate Plan 2015 – 2019 to the end of September 2015.

Work has since commenced on the preparation of the Plan and the attached Draft has been prepared by the Management Team and considered by the C.P.G. at their meeting last week and is now before the Council for adoption.

The Draft sets out the objectives for the Council over the next 5 years and also outlines supporting strategies to achieve the objectives listed.

Once the Draft is adopted, there will be a consultation process during which feedback and observations will be invited from elected members, staff, through S.P.C.'s, the P.P.N. and stakeholders with an interest or involvement in Local Government.

The final Plan will come back before the members in 3-4 months time once the consultation process has been completed.

"That pursuant to Section 134 (9) of the Local Government Act, 2001, the Clare County Council Draft Corporate Plan 2015-2019 be adopted as circulated."

#### Item 7: Briefing on storm remedial works at 3:00 p.m.

Steve Lahiffe, Senior Executive Engineer provided an overview of work which has taken place to date and work which is due to take place in the coming months with respect to sites in the county affected by the storms of 2014. The meeting was advised that works will commence on the Kilkee Strand Line on Monday, 16<sup>th</sup> February. The presentation outlined the total estimated cost of the works required arising from the storms to be €36.8m. The total funding allocated to date is €17.6m. Details of the amounts expended to date and the locations in question were also provided.

In relation to the remaining sites, the strategy proposed was outlined. Mr. Lahiffe also referred to the fact that most of the areas in question were in Special Areas of Protection.

Any queries raised with regard to the presentation were dealt with by both Steve Lahiffe and Tom Tiernan, Senior Engineer.

The Cathoirleach proposed that the Councillors should visit the sites affected throughout the county by storm damage, this proposal was seconded by Cllr. G. Keating and agreed.

#### Item 8: Accounting.

Ar moladh Cllr. P.J. Kelly

Cuidithe ag Cllr. G. Flynn agus glacadh leis

"That the C.E.O. inform the members of the Council if he has engaged the services of a national accountancy firm to seek financial assistance for the Council from a non-traditional source of income and if so, state

- (a) The circumstances which led to this initiative
- (b) The expected financial return from exercise
- (c) Amount of professional fees associated with effort."

#### Tom Coughlan, Chief Executive replied as follows;

"The council has not engaged an accountancy firm to seek financial assistance for the council".

Cllr. P.J. Kelly also asked if the Council had been in contact with the Revenue Commissioners and the Chief Executive replied that the Council is in ongoing contact with the Revenue Commissioners on a myriad of issues. The Chief Executive also requested Cllr. Kelly to clarify his reference to a possible financial mis-adventure as he was not happy to leave such a suggestion hanging over the Council. Cllr. Kelly responded that he had asked a question and received a reply.

#### Item 9: Cedra Report.

Ar moladh Cllr. J. Flynn

Cuidithe ag Cllrs. C. Curtin agus J. Breen agus glacadh leis

"Cedra Working Group. With reference to the adoption in October 2014 of the notice of motion to establish a Working Group to review the Cedra Report and the subsequent nomination of elected members from each Municipal District to same;

That this Council would now set timelines for meetings, etc. to enable the review and its findings to input, as appropriate, into both

- a) The proposed Clare County Development Plan (2017-2023), and
- b) The proposed Clare Local Economic and Community Plans (2015-2021)."

#### Gerard Dollard, Director of Service replied as follows:

"The following Members have now been nominated to the Working Group on CEDRA Report:

Ennis Municipal District: Cllrs. Johnny Flynn and Clare Colleran Molloy.

Killaloe Municipal District: Cllrs. Tony O'Brien and Joe Cooney.

Shannon Municipal District: Cllrs. Gerry Flynn and P.J. Ryan.

West Clare Municipal District: Cllrs. Christy Curtin and Gabriel Keating.

The Members will be aware that the Council has commenced a statutory process for the review of the Clare County Development Plan and this process will conclude in 2017. The Council has also received formal guidelines in relation to the preparation of the Local Economic Community Plan (L.E.C.P.) and these have been circulated to the Elected Members. The guidelines indicate that:

"As the framework for the economic development and local/community development of the local authority area, the L.E.C.P. will also be the primary mechanism at local level to bring forward relevant action arising from measures under the Action Plan for Jobs and other statements of Government policy including the report of the Commission for the Economic Development of Rural Areas (CEDRA)."

There is an extensive process involved in the preparation of the Local Economic and Community Plan with key roles being assigned to the Local Community Development Committee and the Strategic Policy Committee for Economic Development and Enterprise.

Given the commencement of the preparation of the L.E.C.P., the review process currently underway for the Clare County Development Plan, the establishing of the S.P.C. for Economic Development and Enterprise and the Local Community Development Committee, the Members may wish to give further consideration to this Working Group as it is clear that the CEDRA report will be a key component to be considered in the preparation of both the County Development Plan and the L.E.C.P."

After some discussion on the setting up on the Cedra Working Group, it was proposed by Cllr. J. Cooney and seconded by Cllr. T. O'Brien that elected members who are part of the working group would meet on Monday, 16<sup>th</sup> February at 3:00 p.m. in order to discuss the matter further.

#### Item 10: Taking in charge estates.

Due to absence of Cllr. M. Hillery who originally submitted this notice of motion, Cllr. T. McNamara agreed to move this motion.

Ar moladh Cllr. T. McNamara Cuidithe ag Cllr. B. Chambers agus glacadh leis

"That the director of services would present a progress report on the taking in charge of the 180 housing estates within County Clare to include the number already processed and the planned number of estates to be finalised in 2015."

#### Gerard Dollard, Director of Service replied as follows:

"Significant resources have been applied to the area of Estates/Taking in charge since 2012 to deal with a range of complexities and legacy issues that exist on such developments. In 2012 the Planning Authority compiled a Register of over 180 estates which were all at various levels of completion, inadequately completed/unfinished or not taken in charge and have continued to work on the resolution of these developments through engagement with Developers (where developers exist), Receivers/ Liquidators/Bondholders/Agents on behalf of bondholders and residents.

In 2012 the Planning Authority successfully progressed the Taking in charge of 7 developments. In 2013, 14 developments were taken in charge with a further 16 developments reaching a satisfactory conclusion in 2014.

It is anticipated that circa 20 estates will be taken in charge in 2015 with significant progress being made in the resolution of many others. The availability of some funding from 2014 Annual Financial Statement will assist in making further progress in 2015.

A major issue being dealt with in 2014 and 2015 to date has been the threat of disconnection of public lighting supply on some 70 different developments throughout the county. The Council has engaged extensively with Electric Ireland and has successfully managed the situation to date. The Council recently received a commitment from Electric Ireland that disconnections of public lighting will be deferred pending further discussions with the Council.

The Planning Authority will continue to engage with all interested parties to continue to make progress in this area in the interests of the residents on developments affected."

#### Item 11: Legal Fees.

Ar moladh Cllr. C. Curtin

Cuidithe ag Cllr. G. Flynn agus glacadh leis

"That the Chief Executive Officer provide a Tabular Statement of Legal Fees paid by Clare County Council in 2013 and 2014 and in that context inform the Council of the Progress and Procedure to-date in the Procurement Process for Legal Services for the County now that the Contract with the County Solicitor is nearing the end."

#### Michael McNamara, Senior Executive Officer, Corporate Services replied as follows:

The Council invited tenders on 1<sup>st</sup> December 2014 for the provision of legal services for a 6 year period. The tender submissions received have been examined and the short-listing exercise has now been concluded. Those firms that were successful at Stage 1 will be requested in the coming weeks to submit detailed tender proposals to the Council. A final decision will be made on the basis of these detailed tender proposals received. It is hoped to have the matter finalised before 31<sup>st</sup> March 2015."

The Chief Executive responded to a number of queries raised and advised that the fees outlined for specific years may not directly relate to that year in question as it is common for cases to take a number of years to resolve and fees are not paid until cases are finalised. The Chief Executive advised the members that he would be happy to distribute to them a copy of the tender document which had been advertised but that he would be unable to report on any tenders received to date as the tender process has not been completed. He also confirmed that there is no charge for attendance by the County Solicitor at Council Meetings.

#### **Item 12:** Public Consultation.

Ar moladh Cllr. R. Nagle

Cuidithe ag Cllr. B. Slattery agus glacadh leis

"That Clare County Council would immediately put in place a protocol that would outline clearly how individuals and communities are to be consulted concerning any proposals that directly affect them."

In moving this motion Cllr. R. Nagle referred to Blakes Corner, Ennistymon and expressed his serious concern about the process used by the Council in notifying the affected parties in the town. He also referred to the press release issued immediately after the meeting without the knowledge of the Municipal District Chair or members. He said it was absolutely essential that a protocol be put in place outlining how individuals and communities are consulted concerning proposals that directly

affect them. The Chief Executive in response said he respected the role of the elected members and referred to the various scenarios the Council have to deal with from time to time such as Part VIII applications, Development Plans, major Roadwork or Infrastructural Projects. He also said that he would always ensure that members were briefed first in all such occasions. In relation to the specific project referred to by Cllr. Nagle at Blakes Corner, the Chief Executive said that he was not happy with the way the matter was dealt with and apologised to the members in this regard. He stated that Council staff should have met with the affected parties after the members had been told. He also stated that he was not happy with aspects of the press release issued.

#### Item 13: Gritting programme.

Ar moladh Cllr. J. Cooney Cuidithe ag Cllr. P. Burke agus glacadh leis

"That Clare County Council include all regional roads on their gritting programme in inclement weather conditions in the interest of road safety.

#### Tom Tiernan, Senior Engineer replied as follows:

"When excluding the motorway network which is directly the responsibility of the National Roads Authority the total length of road incorporated in Clare County Council's salting programme is 654 km – which includes all of the national secondary route network (185 km.) 437 km. of regional roads and 32 km. of local roads. These routes represent a total of 15.3% of the entire County network which is consistent with the national average target of 15%.

There are a total of 635 km. of regional roads in County Clare which means that almost 200 km. will have to be added to the current schedule to facilitate the requirement of this Notice of Motion. As things stand at present the winter maintenance scheduled routes are distributed as equitably as possible across the County taking account of traffic demands facilitation of access to towns and villages and provision of coverage for at least one strategic route between centres where more than one option is available. Available resources are stretched to facilitate the current schedule which in general terms is working very well and the capacity isn't available at present to facilitate extending the service in the manner suggested. If the service were to be extended more resources would be required and the nature of such an extension should be based on an overall review of the current service and the assessment of potential individual route extensions rather than an overall extension to incorporate all regional roads."

In further reply to queries raised Mr. Tiernan stated that a review could be done to look at areas of concern to members but stated that resources were not available to include all regional routes.

#### Item 14: Septic Tanks.

Ar moladh Cllr. P. Hayes Cuidithe ag Cllr. C. Crowe agus glacadh leis

"I am asking for a report into the recent regulations governing septic tanks,

(a) How many inspections were carried out since the introduction of these new laws,

- (b) What grant aid has been paid to date.
- (c) Are the public aware of these grants and the costs associated with improvement works."

#### Anne Haugh, Director of Service replied as follows:

#### "(a) How many inspections were carried out since the introduction of these new laws

88 inspections have been carried out by Clare County Council since the introduction of these laws.

#### (b) What grant aid has been paid to date

As of 31<sup>st</sup> January, 2015 grant-aid of €18,976.69 has been paid out to 6 applicants.

#### (c) Are the public aware of these grants and the costs associated with improvement works."

If a member of public fails an inspection, details of the grant available and the grant application form are sent out with the Advisory Notice. Details of grants are also available on Clare County Council's website."

Cllr. P. Hayes thanked Ann Haugh, Director of Service for her reply.

#### Item 15: Wild Atlantic Way.

Ar moladh Cllr. P. Murphy Cuidithe ag Cllr. M. Howard

"Wild Atlantic Way, I am proposing that Clare County Council actively pursue a meeting with Deputy Michael Ring in order to lobby for an alternative route to the current leg by ferry from Killimer to Tarbert. The proposed alternative route to follow the coastline of counties Clare and Limerick."

Discussion continued on this motion which had already been moved at the January meeting.

#### Gerard Dollard, Director of Service replied as follows:

"The concept behind the Wild Atlantic Way was towards achieving tourism product that could be marketed on an international basis. A detailed study, research and preparation for the launch of the Wild Atlantic Way was designed to bring together existing tourism product and package it in a very attractive way for the international market. In Clare, there was significant consultation at local level and at community meetings in the overall development of the concept. It is clear that the branding has been successful and, while it is at the very early stages, there is no doubt that the potential for the Wild Atlantic Way to be marketed as a major tourist attraction has huge potential.

It is important that the overall integrity of the concept would not be diluted to such an extent that the idea no longer has international marketing appeal and consequently does not deliver the visitor numbers that would be expected. I am aware that there is considerable representation from many parts of the country seeking to have additional routes added to the Wild Atlantic Way. In some cases, the rationale for adding the route does not support the concept of the Wild Atlantic Way and would have an adverse effect in terms of undermining the potential of the Wild Atlantic Way.

The original programme launched by Fáilte Ireland involved the launch of the Wild Atlantic Way as Phase 1 of the project with further "loops" being added to allow the visitor an opportunity to veer off the Wild Atlantic Way and take in other locations in the vicinity of the route. This is currently a work in progress with Fáilte Ireland and the development of the loops are awaited.

The Council will be meeting with Fáilte Ireland shortly to discuss ongoing progress in relation to the Wild Atlantic Way initiative. The ideas suggested in the motion will be raised as part of those discussions."

After some discussion on this matter, a number of members reported that they were not in favour of the proposal as submitted. Cllr. P. Murphy then submitted the following revised proposal to the meeting:

"I am proposing that Clare County Council, when engaging with Fáilte Ireland in relation to the Wild Atlantic Way initiative, suggest the development of the two following "loops",

- i. a Shannon/Fergus Estuary route to incorporate the natural coastlines of Counties Clare and Limerick and
- ii. a "Circle of Clare" to include towns, villages and attractions of mid and east Clare similar to the Ring of Kerry."

This was seconded by Cllr. M. Howard and agreed by the members present.

#### Item 16: Clare's Atlantic Way.

Ar moladh Cllr. J. Flynn Cuidithe ag Cllr. A. O'Callaghan agus glacadh leis

"Maximise Clare's Atlantic Way Tourist Potential.

In light of successful existing inland Tourist attractions such as;

Air Venture Shannon; Bunratty Folk Park; Cragganowen heritage, etc. That Clare County Council in conjunction with others, such as Shannon Heritage, should urgently plan, develop, and market at least 6 new inland tourist attractions to ensure maximum economic benefit & tourist bed nights retention in Clare from the tourism expected to be generated by the Wild Atlantic Way along our Counties Coastline.

These proposals could consider for example; Clare Food and Crafts at proposed Ennis Covered Market; West Clare Railway Greenway; Ballyalia Lake to Clarecastle Harbour Water, Cycling and outdoor pursuits Hub; Ennis Abbey and Medieval Gaelic Town, Ennis Trad, Clare Library genealogical services; etc."

#### Item 17: Cumann Na mBan.

Ar moladh Cllr. C. Colleran Molloy

Cuidithe ag Cllr. C. Crowe agus glacadh leis

"On the 100th Anniversary of the founding of Cumann Na mBan, and in recognition of those women who served and who played a vital role in securing the independence of the State that a building, park or piece of infrastructure in County Clare be named Cumann na mBan in recognition."

Cllr. C. Crowe in seconding the motion referred to a motion on similar terms which he moved in 2014 and which was also approved by the Council.

#### Item 18: Trees.

Ar moladh Cllr. G. Flynn Cuidithe ag Cllr. A. O'Callaghan agus glacadh leis

"That Clare County Council put in place a program to eradicate ivy from trees throughout the county due to health and safety concerns and in view of recent tragic accidents caused by fallen trees and the possibility of ivy on trees being a factor as outlined recently by a family that lost a loved one."

#### Tom Tiernan, Senior Engineer replied as follows:

"Notwithstanding the fact that ivy growing around the trunks of trees can add to their bulk and mass it is my understanding that there is generally no adverse impact to the health of a tree by virtue of the fact that there is ivy growing on it. I am not aware that the concept of ivy growing on trees has ever been identified as a health and safety issue of any significance. While a connection may have been made with the fact that ivy was growing on the tree in question in relation to the sad case referred to in the Notice of Motion there doesn't seem to be a general problem in this context. In my view the concept of developing a program to eradicate ivy from all trees throughout the County would be elaborate and expensive and would be disproportionate in terms of what would be achieved by the exercise. Notwithstanding the fact that Clare County Council would have no funding to take on such an endeavour I would equally feel that it is unlikely that funding would be available from any other source."

In light of issues raised by Cllr. G. Flynn, Mr. Tiernan agreed to seek advices from Teagasc in relation to the matters raised.

At this point it was proposed by Cllr. C. Crowe, seconded by Cllr. A. O'Callaghan that the meeting would be extended by 10 minutes. This was agreed by the members present.

#### **Item 19:** Sheltered accommodation.

Ar moladh Cllr. G. Flynn Cuidithe ag Cllrs. P. Murphy, M. Begley agus J. Cooney agus glacadh leis

"That Clare County Council request an update from Minister Paudie Coffey in housing concerning funding for a much needed scheme of sheltered accommodation at the county Daycare Centre, Clarecastle."

#### Gerard Dollard, Director of Service replied as follows:

"In January 2014 the Department of Environment, Community and Local Government issued a Call for Proposals to Housing Authorities for the Capital Assistance Scheme for Approved Housing Bodies, 2014-2016. Authorities were asked to submit a short list of prioritised proposals (no more than 5) to the Department for consideration for funding. The criteria to be used in assessing the proposals to include:

- 1) The extent to which the proposals address the housing need as identified in the Housing Needs Assessment 2013.
- 2) Value for Money Proposals should be cost effective and fit-for-purpose and be in compliance with Public Spending Code and Capital Works Management Framework.
- 3) Prioritised projects should be in a position to progress without delay following funding approval, with some recoupable expenditure to be incurred in 2014.

A proposal to develop sheltered accommodation was received from the Clarecastle Daycare Centre Company Ltd., which was included in the prioritised proposals submitted to the Department by Clare County Council. That funding application was not successful, however it is expected that a Call for Proposals will issue from the Department shortly and a renewed application can be considered under that Call."

The following resolution was then proposed by Cllr. P. Murphy, seconded by Cllrs. G. Flynn, J. Cooney and M. Begley and agreed by those present.

"That the expected application for sheltered accommodation by Clarecastle Daycare Centre Company Ltd. is given priority one status by Clare County Council when the call for proposals for the Capital Assistance Scheme is issued by the Department of Environment, Heritage and Local Government."

#### Standing Orders.

Cllr. J. Breen proposed that Standing Orders be examined with a view to having correspondence listed earlier on the agenda than heretofore. It was agreed that the Standing Orders Sub-Committee would consider this proposal.

## A.I.L.G. Annual Conference taking place in the Nuremore Hotel, Carrickmacross on 12<sup>th</sup>/13<sup>th</sup> March, 2015.

The Meetings Administrator informed the Members that the estimated average cost per Councillor attending this Conference was €128.56.
