The Cathaoirleach, Cllr. Bill Chambers presided.

At the outset Cllr. J. Breen raised the issue of the progression of the Limerick Northern Distributor Road Phase 2. He stated that he had asked that this be addressed by the Chief Executive in order to progress this project which straddles two local authority areas. In response the Chief Executive advised that the Senior Engineer for Roads will give an update to members at the April meeting.

Cllr. Breen also questioned when he would receive a response to a planning matter he had raised previously with the Chief Executive. The Chief Executive advised that as it was a planning matter, the planning department would revert to Cllr. Breen in due course.

Item 1: Minutes of Council Meetings.

"It was proposed by Cllr. J. Breen and seconded by Cllr. A. O'Callaghan to suspend standing orders in order to discuss the recent publication of a HIQA Report into Superbugs at our hospitals and the Whistleblower Report in relation to University Hospital Limerick. It was agreed by the Cathaoirleach to suspend Standing Orders for a period of 15 minutes to discuss this matter."

Suspension of Standing Orders

Two motions were given to the Meetings Administrator and in accordance with Standing Order Number 24 the Cathaoirleach agreed to suspend Standing Orders for 30 minutes to discuss these matters.

1. HSE Forum

The following motion was proposed by Cllr. T. McNamara and seconded by Cllr. A. Norton on behalf of the nominated Councillors on the HSE West Forum and agreed by all present:-

"We the undersigned call for the suspension of standing orders to allow us the four nominated councilors of Clare County Council who sit on the HSE West Forum to refute the false allegations that were levelled against us at the February meeting of Clare County Council by Councillor James Breen".

Cllr. T. McNamara spoke on behalf of the four members. He was insistent that he totally rejects Cllr. Breen's suggestion made at meeting on 13th February, 2017 that the serious issue in relation to deaths at Limerick Regional Hospital as a result of contracting a superbug had not been raised at the HSE West Forum by the Councillors. He directed the members to correspondence in the Agenda where there was a copy of Minutes of meeting held on 22nd November 2016 of the HSE Forum. Under Any Other Business it clearly notes that Cllr. T. McNamara had raised this issue at that meeting. Cllrs. A. Norton, P. Burke and P.J. Ryan also spoke on this matter. They all voiced their disappointment that Cllr. J. Breen felt that they in some way were not doing their job as representatives on this forum. They also felt that if Cllr. Breen had any concerns then he should have approached them directly in order to afford them the opportunity to raise these concerns directly with the HSE West Forum.

2. An Post

The following motion was proposed by Cllr. P. J. Kelly and seconded by Cllr. P.J. Ryan and agreed by all present:-

"That Clare County Council calls on the Government to intervene with An Post in order to avoid closure of post offices which are an essential lifeline of rural Ireland".

Cllr. P. J. Kelly strongly urged the members to support this request. He was emphatic in his view of the need to preserve, protect and sustain our post offices as they are a central part of the life blood of rural Ireland. Cllr. P. J. Ryan was also insistent that the Government give power back to the post offices in order to make them viable.

Cllr. P. McMahon suggested that the Government should introduce community banking to the post offices and it was suggested that New Zealand had a perfect system of the concept of community banking. The members fully supported this request as rural towns will decline with the closure of post offices. They are an integral part of rural Ireland and everything should be done to preserve them. The issue of rural transport was also raised.

The monthly management report attached to the agenda included key activities in the principal service areas and was noted by the members.

Cllr. C. Curtin complimented and thanked the Chief Executive for the detailed information provided on the new format management report. He asked that an update be provided at the next meeting on the Hydrological survey for Miltown Malbay, Ballyvaughan and Corofin. He also requested in his role as Chairman of the Rural Water Committee that a formal request be sent to the Department to ensure that the notifications of the grant allocations be advised to local authorities in a timely manner for 2017 in order to avoid the scenario that occurred in 2016 whereby the spend target was completely unrealistic. Cllr. J. Flynn praised the Rural Development Directorate for the roll-out of free public Wi-Fi to Ennis Town. He also stressed the importance of local businesses availing of L.E.O. training programmes in order to establish themselves as on-line traders.

Item 6: Proposed disposal by lease of Courthouse, Ennistymon pursuant to Section 183 of the Local Government Act, 2001 and Section 211 of the Planning & Development Act, 2000.

Report dated 20th March, 2017 from Carmel Greene, Senior Executive Officer, Corporate Services Department was circulated with the agenda. The report states that in 2002, Clare County Council entered into a 22 year lease with Old Ennistymon Heritage Ltd in relation to the Courthouse in Ennistymon. The Courthouse is an excellent community facility which is used as an art studio and gallery and also used for the holding of many arts events.

The Company, which is a registered Charity, is now making an application for LEADER funding in order to widen the social inclusion aspect of the facility. In order to apply for this funding a lease of at least 21 years is required.

In light of this, it is proposed to enter into a new lease of the Courthouse to Old Ennistymon Heritage Ltd. The proposed term of the lease is 22 years.

Kelly queried whether the Chief Executive had requested legal advice from a Barrister prior to presenting this report to the members as he was not happy to support these changes. The Chief Executive in response advised Cllr. P.J. Kelly that he did not request legal advice because it was solely the role of the elected members on whether to adopt these changes or not. Cllr. C. Curtin did however, acknowledge Cllr. P.J. Kelly's frustration but insisted that these changes were for a trial period only and can be reviewed at the end of 2017.

Item 29. MABS.

"That Clare County Council call on the Minister for Social Protection, Mr. Leo Varadkar, T.D., to issue a directive under Section 9 of the Citizens Information Act 2007 to the Citizens Information Board directing it to abandon proposals to abolish the local MABS and Citizens Information Service Companies delivering very important services to the most vulnerable in our society and to replace them with Regional Companies far removed from, and unfamiliar with, local issues. I further propose that this motion be circulated to each local authority for consideration."

The members were in unanimous support for this motion and asked that this motion be copied to all local authorities.

Item 17. Procurement.

Ar moladh Cllr. J. Breen

"In view of the fact that approximately 350 outside companies supply services to this council, how often are these tenders advertised and when and where was last time?"

Niall Barrett, Director of Finance and Support Services replied as follows:

"Procurement in all public bodies, including Clare County Council, is governed by National and EU legislation. The value of the contract determines the procurement procedure to be followed and the frequency in which the contract is tendered. There are other factors that also effect the frequency including the nature of the goods or services required, with many service contracts being of longer duration.

Most tenders are advertised on the **eTenders** website. This is a public sector procurement portal where all public sector bodies advertise public tenders and where any service provider/contractor can register free of charge and express interest and view details of any tender competition being ran by any public body.

In addition, contracts for many common goods and services (such as utilities, professional services and stationery) are put in place nationally by the **Office of Government Procurement (OGP)** for use by other public bodies, and these competitions are also advertised publically on eTenders and, if required on the Official Journal of the EU (OJEU). Within these tender competitions, framework competitions are often run for specific areas. Companies that are successful in the competition are placed on a panel of entities to supply under that framework. Then as individual contract supply opportunities arise, mini-competitions are run between all framework members to establish who will be the supplier for that particular contract. Mini-competitions are limited to existing framework participants.

In situations where goods or services are required which fall below the thresholds for the above processes then a Request for Quotations (RFQ's) process is used. These RFQs are also commonly advertised on the **Supplygov** website. The Supplygov site is another public procurement portal used by public bodies.

Quotations and tenders are sought by the Council on a daily basis and in many cases, quotations are sought directly from known suppliers, in full compliance with our procurement procedures, as the value of the goods is low.

The monthly Management Report now includes details of all publically advertised tenders during the previous month.

For ease of reference the tenders advertised (on eTenders) in the last month (February) are set out below:

The tender to establish a new framework for general building services is currently advertised on eTenders and the council will be holding an information session for building contractors in the coming weeks. This competition and the information sessions will be advertised on local print media and social media in the coming weeks."

Cllr. Breen asked if financial information on what was paid to selected contractors could be provided on request and asked that consideration be given to doing some of these works in-house.

Item 18. Customer Satisfaction Survey.

Ar moladh Cllr. C. Curtin

Cuidithe ag Cllr. G. Flynn agus glacadh leis

"That the Council carry out a Customer Satisfaction Survey."

Niall Barrett, Director of Finance and Support Services replied as follows:

"Clare County Council carried out a "Quality of Service Survey" in July 2010. This was a detailed questionnaire which was aimed at helping the Council to monitor the level of service provided. Comments and suggestions for service improvement were invited from the people surveyed. This was a substantial undertaking and took several months to set up, collect responses and collate the responses received.

It is an opportune time for Clare County Council to carry out further survey work in order to consider customer feedback with a view to assessing service delivery. This may provide information on areas that could be improved and also provide an opportunity to assess the changing nature of the service delivery due to factors such as advances in technology in recent years.

Consideration will be given the format of the surveys, including carrying out individual surveys in particular service areas so that the survey responses may be more targeted. The options and timeframe for conducting such a survey will be assessed to determine what format the survey may take and what population groupings to survey. It may also be used as an opportunity to advise customers of enhancements to the council's services, such as electronic payment options which are available. It is intended that those surveyed would also be given an option to provide comments, suggestions or recommendations in relation to the services provided by the Council."

The members agreed that the last survey carried out by Clare County Council was very successful and it is their opinion that it would be a very worthwhile project. The Chief Executive in response advised that a key customer of Clare County Council is the elected member. He added that as part of this survey he is also looking into service cataloging. He informed the members that he will revert back to them once the details of how to conduct the proposed survey have been finalised.

Item 19. Tourist Attractions in County Clare.

"In light of Irelands current 2023 Rugby World Cup bid, that Clare County Council develop a series of tourism promotional videos to promote tourist attractions outside of the main tourist attractions within the county, to establish County Clare as a clear leader in Irelands tourist product and to capitalise on the possible influx of visitors presented by a successful bid as well as the current increased media attention."

Due to the absence of Cllr. I. Lynch this motion was not moved or discussed.

Item 20. Shannon Airport.

Ar moladh Cllr. P. McMahon Cuidithe ag Cllr. P. J. Ryan agus glacadh leis

"In view of the substantial threats posed by Brexit and the uncertainty surrounding immigration and pre-clearance facility at Shannon Airport, that this Council reaffirms its support for American military for transiting the airport."

The majority of the members supported this motion. However, Cllr. M. McKee felt that he could not support this motion as Ireland is a neutral country. He therefore, expressed his dissent in relation to this matter and asked that it be recorded.

Item 21. Planning Contributions.

Ar moladh Cllr. P.J. Kelly

"That the following information be made available in written format:

- (a) Amount of planning contributions spent in each of the years ending 2012, 2013, 2014, 2015 and 2016
- (b) The amount proposed to be spent in 2017
- (c) (1) The amount and location of each item of expenditure referred to in (a) above
 - (2) the statutory and/or regulatory references applied in determining location and cost in each separate project.
- (d) The cost of proposed cycle lane from Ennis to Ennistymon and the administrative exercise which is referred to in (c) (2) (above) which was applied."

Gerard Dollard, Director of Economic Development replied as follows:

The proposed cycle lane from Ennis to Ennistymon has been included in the list of capital projects under the new draft Development Contribution Scheme for 2017-2023. It is estimated that this project will cost in the region of €4m with funding sources being central government Smarter Travel programme funding and local sources."

Item 22. Irish Cement Plant planning application to Limerick City and County Council

Ar moladh Cllr. C. Crowe

Cuidithe ag Cllr. C. Colleran Molloy agus glacadh leis

"That Clare County Council lodge an appeal to An Bord Pleanala against planning file 16-345 (Limerick City & County Council).

This granted application provides for a tyre burning facility at Irish Cement's plant at Castlemungret, Limerick. The people of Clare and we, their local government, should have very legitimate health, safety and environmental concerns for this development. The site bounds on the River Shannon and is only a few hundred metres from County Clare."

Gerard Dollard, Director of Economic Development replied as follows:

"Having contacted Limerick City and County Council I am advised that the application by Irish Cement Limited comprised of "a 10 year permission for development to allow for the replacement of fossil fuels through the introduction of lower carbon alternative fuels and to allow for the use of alternative raw materials in their Limerick Cement Factory. To facilitate the on-site handling, storage, and introduction of the alternative fuels and alternative raw materials it is proposed to construct: a tyre storage area with tyre handling/separation area, and associated conveyor kiln 6 with fire water retention tank; a proposed pumpable fluids storage tank which is located within a concrete bund area with associated uploading station all within a 2.4m high security fencing; a proposed fine solids handling building with 2 no. associated truck unloading areas & associated feed conveyors; associated switch room building & associated conveyor from screening building to dosing building at front end of kiln 6, as well as a fine solids transfer building, associated conveyor connecting to a proposed fine solids dosing building to back end of kiln 6 and associated fore-water retention tank; a proposed alternative raw materials storage building with concrete path surround; 3 no. proposed silos for the introduction of free-flowing solids; a proposed by-pass filter comprising a bag filter and a cooling tower with concrete path surround and 1 no. fire-water retention tank. The works include for the demolition of 4 no. steel and metal clad covered car park bay structures. The works also include for associated mechanical equipment and ancillary works, including provision of short sections of internal roadway, pavement,

fencing and landscape works. In reducing the quantity of fossil fuel use, the proposed development seeks to introduce a range of alternative fuels up to a maximum of 90,000 tonnes per annum. The use of alternative raw materials is contained within this proposed overall quantity. The application area extends to 10.52 hectares within Limerick Cement Factory (this application relates to an activity for which an Industrial Emissions Licence applies under the Environmental Protected Act 1992, as amended (Industrial Emission Licence Register Number P0029-03. An Environmental Impact Statement accompanies this planning application)".

I am advised that a decision to grant permission, subject to 16 conditions, was made by Limerick City and County Council on 8th March, 2017 with the period for an appeal to An Bord Pleanala, expiring on Monday 4th April. It is noted that there were over forty 3rd Party objectors to the application who all have an entitlement to appeal to An Bord Pleanala.

I am advised that the application comprised an EIS and two further submissions in response to further information and clarification requests. All of this information, together with all submissions on the application, was assessed for almost a year by Limerick City and County Council."

The members discussed this matter in great detail. Cllr. C. Crowe asked the members to support this motion. He felt that it was a grossly offensive planning application. He appreciated that the time was short within which to lodge the appeal but he requested the assistance of the Clare County Council's planning and environment departments in order to achieve the deadline of 4th April.

Some, however, voiced their concerns on this course of action as they felt it wasn't appropriate for Clare County Council to question by way of an appeal the decision of Limerick City and County Council. It was also felt that it wasn't possible for Clare County Council to come up with a substantial grounds for objection on a planning application it hadn't seen.

The following amendment to the resolution was then proposed by Cllrs. J. Flynn and seconded by J. Cooney

"That Clare County Council deal with the Environmental Assessment of the proposed Mungret Development at the E.P.A. Licence stage, rather than the current Planning Stage".

The Cathaoirleach called a vote on the amendment, which resulted as follows:

In favour: Cllrs. J. Flynn, M. Howard, J. Cooney, G. Flynn, C. Curtin, B. Slattery, B. Chambers and G. Keating (8).

Against: Cllrs T. McNamara, C. Colleran Molloy, T. O'Brien, C. Crowe, P. McMahon and M. McKee (6).

Abstentions: Cllrs. A. Norton, P. Burke and P.J. Ryan (3)

This amendment was deemed to have been carried by 8 votes to 6.

Item 23. Overtaking distance.

Ar moladh Cllr. M. Howard Cuidithe ag Cllr. C. Colleran Molloy agus glacadh leis

"Considering that the Government will introduce before the summer, a bill where motorists are to face penalty points and a fine for driving too close to a cyclist, the minimum passing distance will now be set at 1.5 meters on roads with speed limits of more than 50 kmh.

I request Clare County Council to reconsider my motion of June 2015 - "That Clare County Council imitate the initiative of other local authorities (Wexford, Mayo, Donegal) by placing signs on Council vehicles to indicate that the appropriate space to give a cyclist when overtaking to a minimum of 1.5m clearance". I believe we need to do our bit in creating awareness and instilling this basic tenet in the public consciousness."

Tom Tiernan, A/Director of Physical Development replied as follows:

"Notwithstanding the fact that the points made in response to the previous notice of motion in relation to this matter in June, 2015 continue to pertain, I would agree that the fact that the issue is now being addressed in a legislative context strengthens the argument in favour of the local authority being assertive in relation to same. The fact that a significantly enhanced network of cycleways has been developed around Ennis recently adds additional rationale to the suggestion.

Given that the legislative process referred to in the notice of motion is to evolve over the coming months, I would suggest that no action be taken until such time as the process is completed. Then we will design appropriate signage to be placed on the back of Council vehicles to reflect the key details of the forthcoming legislation – and in particular the requirement to give cyclist the space they need to use the public road safely."

Item 24. Mother and Baby Home in Kilrush.

Ar moladh Cllr. I. Lynch Cuidithe ag Cllrs. M. Howard agus A. Norton agus glacadh leis

"In light of the recent revelations on the sad history of Mother and Baby Homes throughout Ireland, I propose that a plaque be erected on the site of the County Clare Mother and Baby Home in Kilrush. Clare County Council set up the Home in 1922 and whilst it was in operation, unmarried, pregnant women from all over the county were sent there to have their babies. Clare County Council made the decision to close the home in 1932 and from then on, send women to Sean Ross Abbey in Roscrea."

The Chief Executive in response advised that the sentiments of this motion would be referred to the Memorial Committee for further discussion with a strong recommendation from the members.

Item 25. Legal services.

Ar moladh Cllr. C. Curtin Cuidithe ag Cllrs. P.J. Kelly agus G. Flynn agus glacadh leis

"That a breakdown with costings of the legal services provided to the Council under the sub-heading 'other' (figures of €83,503 in 2015 and €119,223 in 2016) be made available and arising from same that a new reporting mechanism to the Council on legal transactions and accruing costs be implemented."

Niall Barrett, Director of Finance and Support Services replied as follows:

"I have set out hereunder the breakdown of the figures for "other" legal costs of €83,503 in 2015 and €119,223 in 2016.

With regard to the request for a reporting mechanism on legal transactions, it is intended to include a report on payments made for legal costs as an item every six months on the management report to Council."

Cllr. C. Colleran Molloy queried whether the Chief Executive had considered and examined the possibility of internalising some of the more regular conveyancing work further to her motion in January. In response the Chief Executive advised the members that Senior Staff were tasked with reviewing this matter and he will revert back to the members once this had been completed.

Item 26. Spending of public funding.

Ar moladh Cllr. G. Flynn Cuidithe ag Cllr. P. J. Ryan agus glacadh leis

"That the Chief Executive in the interest of accountability and transparency change the practice of Senior Engineers having the absolute power and decision making on the spending of public funding throughout the county of Clare and that the elected public representatives are consulted on how best practice can be applied. Councillors at local level have only the opportunity to request various improvements through motions but in reality have little or no influence on the delivery."

Pat Dowling, Chief Executive replied as follows:

"There are 3 designated Senior Engineer positions in Clare County Council whose responsibilities are broadly as follows:

- Senior Engineer, Water Services implementation of an evolving multifaceted transformation programme as set out by Irish Water, direction of implementation of ongoing operational and capital programmes as determined by Irish Water and implementation of the countywide Rural Water Programme based on allocations made available by the Department of the Environment.
- Senior Engineer, Environment direction of a wide-ranging and detailed environmental inspection programme, overseeing implementation of a range of environmentally orientated management plans, development of county strategies in relation to issues such as climate change adaptation, energy management and so on and implementation of capital programmes such as in relation to beaches, recycling facilities etc.
- Senior Engineer, Transportation development and implementation of Roadworks Programmes, similarly in relation to flood relief and coastal defence strategies and pursuit of implementation of strategic capital programmes facilitating significant transportation, coastal and flood relief needs.

We note the concerns outlined in the notice of motion, but it is important to make a number of points to reflect the reality and context within which Senior Engineers are required to deliver the services expected of them by the local authority. In this regard, the following should be noted:

- Water Services (with the exception of Rural Water) is now the responsibility
 of Irish Water with all budgets facilitating service delivery, operations,
 improvements, scheme development and so on being provided by Irish Water.
 As a result, Clare County Council Water Services Staff are very much
 required to accommodate the Irish Water agenda as part of National and
 Regionally based strategy going forward.
- A very large proportion of programmes to be implemented across technical areas are regulation based which, in effect, means that much of the leverage available to Engineers in the past to make judgement calls based on local circumstances etc. is no longer available.
- A much more scientific approach than heretofore is insisted upon in situations where heretofore subjective judgement calls could be made based on a variety of criteria such as Engineering need and various local circumstances. The

recent evolution of the Pavement Management System (PMS) has radically changed the approach which is taken in relation to the development of Roadworks Programmes, calculation of outputs in association with key performance indicators, programming generally and accountability in relation to the management of transportation infrastructure.

Therefore, it would appear that the environment within which Senior Engineers work which is centred around more intensive regulation, a demand for implementation of best practice technically, the strategic agenda of third parties and greater accountability is being mis-interpreted by some as "Senior Engineers having the absolute power and decision making on the spending of public money throughout the county of Clare". The fact that funding levels have been as depleted as they have over the past number of years has added further restriction to the capacity of Engineers to incorporate flexibility in their decision-making to the degree they would wish. There is no practice in place of the type depicted by this notice of motion. To the contrary, Senior Engineers and their staff at Senior Executive and Executive Engineer level throughout the Council are more than happy to liaise and work with Council Members and to develop a detailed understanding of the issues which are of greatest concern to Councillors. We fully appreciate that a very large proportion of issues which confront Council Members on a daily basis are related to the areas which are managed by Senior Engineers. Our challenge is to be able to provide as much flexibility as possible in responding to Councillor led issues while at the same time working within the aforementioned constraints. We are very much conscious of the fact that both the Executive and Elected components of the Council structure are working towards achievement of the same objectives in terms of service to the general public and that it is in neither party's interest to divert from that principle."

Cllr. G. Flynn felt that it was time to have a policy that would be respectful to all four municipal districts. He also queried if a Senior Engineer from Water Services could be made available at district meetings. In response to the queries raised the Chief Executive reassured the members that improvements in engagement and consultation will happen over time to ensure a collaborative working relationship.

Item 27. Telephone allowance for the elderly.

Ar moladh Cllr. P.J. Ryan Cuidithe ag Cllr. T. O'Brien agus glacadh leis

"That this Council would request Minister for Social Protection, Leo Varadkar to reinstate the telephone allowance for the elderly."

It was agreed to circulate this to all local authorities.

Item 28. Convention on the rights of persons with Disabilities.

Ar moladh Cllr. A. Norton Cuidithe ag Cllr. G. Flynn agus glacadh leis

"I am requesting that Clare County Council write to our Oireachtas members asking why they are delaying in ratifying the Convention on the rights of persons with Disabilities."

It was agreed by the members that the Standing Orders would be suspended in order to extend the meeting to 6:00 p.m. As there was one half of the members of the whole Council present, this was proposed by Cllr. G. Flynn and seconded by Cllr. C. Curtin.

Item 30. GoSafe Contract with An Garda Síochana.

Ar moladh Cllr. C. Colleran Molloy Cuidithe ag Cllr. P.J. Ryan agus glacadh leis

- "Where on the 14th March, 2017, District Judge Patrick Durkin, had no option but to dismiss a total of 9 prosecutions brought by GoSafe, and further based upon his observation that "the entire system is being brought into disrespect in the busiest district in the country," that Clare County Council call on:
- (1) the Public Accounts Committee to examine the costs of the administration of justice attributable to the GoSafe contract: and that
- (2) the Garda Commissioner undertake such prosecutions directly as it is unfair to the Garda Siochána and abusing scarce state resources."

The members noted that the comments by Judge Durkin were a cause of concern and need to be addressed. Cllr. P.J. Ryan suggested that there should be more of an emphasis on educating young people with the money being spend on Go Safe.

Item 31. An Post.

Ar moladh Cllr. M. Hillery

"That Clare County Council call on the Government to support the retention of AN POST present network because of the importance of the post office in local communities."

Due to the absence of Cllr. M. Hillery this motion was not moved or discussed. Cllr. T. McNamara on behalf of Cllr. M. Hillery requested that this motion be listed again for the April meeting.

Item 32. Undergraduate nursing places in Universities.

Ar moladh Cllr. G. Keating Cuidithe ag Cllr. Mary Howard agus glacadh leis

"That this Council calls on the government to immediately review the number of undergraduate nursing places available in our universities and other educational institutions. The constraints on places is resulting in significant increases in the points requirement and sending many of our students overseas."

Cllr. G. Keating spoke of the changes in recent years which prohibit nursing students from gaining access to nursing colleges in Ireland. Cllr. M. Howard advised that some nursing schools are not able to operate to full capacity. There was unanimous support for this motion. The members requested that this motion be circulated to all Universities and Institutes of Technology.

Item 33. River Maintenance budget.

Ar moladh Cllr. J. Cooney Cuidithe ag Cllr. G. Keating agus glacadh leis

"That Clare County Council provides details on the funding allocated for the cleaning and dredging of rivers in Clare for 2016; outline the level of funding available for 2017 and report on the river maintenance work plans for both years."

Tom Tiernan, Director of Physical Development replied as follows:

"The funding allocated for works which would include cleaning and dredging of rivers is shown in the Annual Works Programme under the "Arterial Drainage" heading. In 2016 the sum allocated was €54,000 and for 2017 a similar sum is provided. The sum allocated for works of this nature over the past no. of years is significantly less than it should be and these very depleted resources have dictated that only the bare minimum in terms of requirements could be facilitated. In the circumstances, it has been our practice to endeavour to incorporate drainage works into the programme over and above what the allocation would facilitate where such works could be justified in association with other budgets. Therefore, the value of works achieved tends to be greater than the aforementioned adopted budgets would suggest.

In 2016 works to the value of $\le 115,000$ were carried out – exclusive of a schedule of road drainage works which were carried out throughout the county on foot of the flood damage remediation funding of ≤ 3.6 m which was allocated to Clare following the severe weather events of the winter of 2015/16.

The following is an overview of the works carried out in 2016 for the aforementioned €115,000:

Ennis MD – significant remediation and upgrade works were carried out to a no. of non-return valve structures in the Lower Fergus Catchment as well as replacement of one of the large tidal barrage sluice doors near Clarecastle.

Killaloe MD – Channel clearance and bridge cleaning works were carried out at Ardclooney River and Bridge and also on the Black River near O'Briensbridge. In addition, some vegetation clearance work was carried out on the Blackwater River

near Mountcatherine in association with the Minor Flood Defence works which were carried out on foot of OPW grant funding towards the end of 2016.

Shannon MD – Drain cleaning and dredging works were undertaken at a no. of locations in Shannon and along the R462 Cratloe to Sixmilebridge Road.

West Clare MD – Dredging works were carried out on the Kildimo River in the northern part of the MD.

The poor levels of funding available to facilitate arterial drainage works don't facilitate the concept of elaborate programming and while some targets are set in relation to priority works, a significant proportion of allocated funds is used to deal with situations which emerge as priorities through the course of the year. Notwithstanding same, the following are current objectives for 2017:

- Drain cleaning works in a no. of streams in the Shannon MD including at the Shannon Free Zone East and at the Westbury Housing Estate.
- Channel maintenance/remediation works on the Owenogarney River in East Clare.
- Drain cleaning works in the Manus Drainage District, vegetation clearance in the Fergus Drainage District (Fergus Minor) and also some vegetation clearance in Quin."
